## INDEPENDENT AUDITOR'S REPORT

To the 401(k) Plan Investment Committee and Plan Fiduciaries of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of CC Metals and Alloys, LLC 401(k) Plan ("Plan"), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**NOTES TO FINANCIAL STATEMENTS**

**Note 1 – Description of Plan**

The following description of CC Metals and Alloys, LLC 401(k) Plan (“Plan”) is provided for general information purposes only. Participants should refer to the Plan Document for more complete information.

**A. General**

The Plan is a defined contribution savings plan adopted on January 1, 2011 to provide eligible employees an opportunity to save for retirement on a tax-advantaged basis. The plan sponsor is CC Metals and Alloys, LLC, and Reliance Trust Company serves as the plan trustee. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (“ERISA”). A 401(k) committee controls and manages the operations and administration of the Plan.

**B. Contributions**

Each year, participants may contribute up to 50% of their annual compensation, as defined in the Plan, not to exceed the maximum amount allowed under the provisions of the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts distributed from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. CC Metals and Alloys, LLC contributes 50% of the salary reduction amount contributed during the Plan year up to 10% of compensation received during the Plan year. Each year, the companies may make a discretionary contribution to the Plan. Contributions are subject to certain limitations.

**C. Participant Accounts**

Each participant’s account is credited with the participant’s contributions and the employer’s matching contribution (if applicable) as well as allocations of Plan earnings and charged an allocated administrative fee. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**D. Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in employer contributions is based on years of continuous service. A participant is 100% vested after one year of credited service.

**E. Payment of Benefits**

Upon termination, a participant may take a lump sum distribution of the account or can choose installments over a period of not more than their life expectancy. Upon the death of a participant, the beneficiary is entitled to distribution of the total value of the participant’s account to be paid in cash. If the participant is over the age of 72, the participant must take annual required minimum distributions of their account. If the participant terminates employment or becomes totally disabled, the participant is entitled to a distribution of the total vested value of that participant’s account. If the participant’s vested account balance is greater than \$5,000, the participant may choose to leave their account in the Plan. Under certain circumstances, hardship withdrawals are permitted by a participant who is under age 59 ½. After age 59 ½, a participant may make a withdrawal without a need to prove serious financial hardship.

**F. Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$65,959 and \$21, respectively. These accounts will be used to reduce future employer contributions or pay reasonable plan expenses. In 2024 and 2023, employer contributions were reduced by \$29,587 and \$0, respectively, from forfeited nonvested balances.

**G. Plan Amendments**

Effective May 20, 2022, the Plan was amended and restated (“2022 Restatement”). The 2022 Restatement changed the Plan to add a Roth contribution feature. Prior to the 2022 Restatement, only pre-tax contributions were allowed by the Plan.

**Note 2 – Summary of Significant Accounting Policies**

**A. Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting.

**B. Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

**C. Investment Valuation and Income Recognition**

The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchase and sale of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

**D. Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan had no excess contributions payable at December 31, 2024 and 2023.

**E. Payment of Benefits**

Benefits are recorded when paid. There were no participants who elected to withdraw from the Plan that had not been paid as of December 31, 2024 and 2023.

**F. Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of participant accounts and distributions to participants are charged directly to the participants account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

**G. Date of Management’s Review of Subsequent Events**

The Plan has evaluated subsequent events through October 15, 2025, the date which the financial statements were available to be issued.

**Note 3 – Information Certified by Trustee**

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Plan management instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information certified by Reliance Trust Company, except of comparing such information certified by the trustee with information included in the plan’s financial statements and supplemental Schedule H, line 4i – Schedule of Assets (Held at End of Year):

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Trust Funds:* Investments are represented by a “unit of account” and per unit values whose value is the result of underlying investments. These underlying investments are valued using the Net Asset Value (NAV) provided by the administrator of the mutual fund investments. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding.

**Note 5 – Related Party Transactions and Party In Interest Transactions**

Certain plan investments are shares of mutual funds managed by Reliance Trust. Reliance Trust is the trustee and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Plan sponsor pays directly any other fees related to the Plan’s operations.

**Note 6 – Plan Termination**

Although they have not expressed any intention to do so, the Companies have the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

**Note 7 – Income Tax Status**

The Internal Revenue Service has determined and informed the Plan by a letter dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

**Note 8 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 9 – Subsequent Events**
