The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the General Produce Distribution Company, LLC Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan was established on January 1, 1986, to provide retirement benefits for employees and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan is a defined contribution plan under which employer contributions are discretionary based on a fixed formula. The Plan covers employees of General Produce Distribution Co, LLC (prior to April 14, 2023, known as General Produce Distribution Company, LLC, General Produce Mount Shasta and Genpro, Inc.) and referred to as the "Employer." Effective March 30, 2023, General Produce Mount Shasta merged with General Produce Distribution Company, LLC. The trustees of the Plan are the members of senior management of Genpro, Inc. (President, Chief Executive Officer and Chief Financial Officer) and the custodian is John Hancock Life Insurance Company (U.S.A.) as of December 31, 2023 and for the period from January 1, 2024 to November 8, 2024, and Fidelity Management Trust Company, is the custodian and trustee of the Plan, as of December 31, 2024 and for the period from November 9, 2024 to December 31, 2024.

Eligibility and Vesting: All employees who have completed a minimum of one year of service (1,000 hours of service during an Eligibility Computation Period) and are at least 21 years old are eligible to participate in the Plan. Effective November 11, 2024, the service requirement is updated to three months. Upon eligibility, employees may enter the Plan on January 1 or July 1. Effective November 11, 2024, plan entry dates were updated to quarterly. Employees are immediately vested in their contributions, plus earnings thereon, while vesting of employer contributions is based on years of service as follows:

Less than 2 years' service	0%
2 years but less than 3 years	20%
3 years but less than 4 years	40%
4 years but less than 5 years	60%
5 years but less than 6 years	80%
6 years' service or more	100%

Effective November 11, 2024, the vesting of employer contributions is based on years of service as follows:

Less than 1 year service	0%
1 year but less than 2 years	25%
2 years but less than 3 years	50%
3 years but less than 4 years	75%
4 years' service or more	100%

Contributions: The Employer makes annual contributions for eligible participants equal to 12% of the employee's eligible annual compensation, not to exceed \$2,350 annually for each participant. In order to qualify for a current year contribution, the employee must be employed on the last day of the current year or meet one of the exception criteria specified in the Plan Document. Effective November 11, 2024, the employer contribution is made each pay period in a discretionary amount, that was equal to 3% of the employee's eligible weekly earnings for 2024.

Participants may contribute up to 100% of their pretax annual compensation, as defined in the Plan, subject to certain IRS limitations. Effective November 11, 2024, participants may contribute up to 75% of their pretax annual compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from

other qualified defined benefit or contribution plans. Additional amounts may be contributed by the Employer at the option of the Employer's members. Contributions are subject to certain limitations.

Effective November 11, 2024, the Plan implemented an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant.

Participant Accounts: Each participant's account is credited with the participant's contribution and allocations of the Employer's contributions, Plan earnings, and is charged with his or her withdrawals and an allocation of administrative expenses paid by the Plan. Allocations may be charged based on a pro-rata, percentage basis based on the ratio of the participant's balance to total participant balances, or per participant, on a uniform dollar basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of participant and employer contributions into various investment options offered by the Plan.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Payment of Benefits: On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum or partial withdrawal amounts equal to the value of the participant's vested interest in his or her account, or installments as defined in the Plan. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or leave it in the Plan. In-service distributions are allowed by the Plan if the participant meets certain criteria, as defined.

Forfeitures: Forfeited non-vested accounts may be used to pay Plan expenses or reduce future Employer contributions, or they may be reallocated as additional contributions. During the years ended December 31, 2024, forfeitures of \$14,178 were used to reduce Employer contributions. At December 31, 2024 and 2023, there were \$30,165 and \$14,178, respectively, in forfeited non-vested accounts available.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with market rates for similar loans. All loans are covered by demand notes and are repayable through payroll deductions.

Plan Termination: Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts and disclosures and actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Cash and Cash Equivalents: The Plan considers all cash and money market accounts with an original maturity of three months or less to be cash equivalents. The Plan invests excess cash in uninsured money market accounts with a national brokerage firm.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through October 14, 2025, which is the date the financial statements were available to be issued.

NOTE 3 – CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (U.S.A.), the custodian of the Plan, as of December 31, 2023 and for the period from January 1, 2024 to November 8, 2024, and by Fidelity Management Trust Company, the trustee of the Plan, as of December 31, 2024 and for the period from November 9, 2024 to December 31, 2024.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Pooled Separate Accounts: The fair values of participation units held in pooled separate accounts are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. Each pooled separate account provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund's net asset value per unit. Investments measured at fair value on a recurring basis are summarized below:

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Employer. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Employer. As of December 31, 2024, the Plan held party-in-interest investments consisting of mutual funds issued by Fidelity Investments. Fidelity Management Trust Company (“Fidelity”) is the trustee of the Plan and Fidelity Investments is an affiliate of Fidelity; therefore those transactions qualify as exempt party-in-interest transactions. As of December 31, 2023, the Plan held units of pooled separate accounts managed by John Hancock Life Insurance Company (U.S.A.) (“John Hancock”). John Hancock is a service provider to the Plan and, therefore, these transactions and the Plan’s payment of fees to John Hancock qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 6 – TAX STATUS

The Internal Revenue Service issued an opinion letter dated June 30, 2020, indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the General Produce Distribution Company, LLC Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan was established on January 1, 1986, to provide retirement benefits for employees and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan is a defined contribution plan under which employer contributions are discretionary based on a fixed formula. The Plan covers employees of General Produce Distribution Co, LLC (prior to April 14, 2023, known as General Produce Distribution Company, LLC, General Produce Mount Shasta and Genpro, Inc.) and referred to as the "Employer." Effective March 30, 2023, General Produce Mount Shasta merged with General Produce Distribution Company, LLC. The trustees of the Plan are the members of senior management of Genpro, Inc. (President, Chief Executive Officer and Chief Financial Officer) and the custodian is John Hancock Life Insurance Company (U.S.A.) as of December 31, 2023 and for the period from January 1, 2024 to November 8, 2024, and Fidelity Management Trust Company, is the custodian and trustee of the Plan, as of December 31, 2024 and for the period from November 9, 2024 to December 31, 2024.

Eligibility and Vesting: All employees who have completed a minimum of one year of service (1,000 hours of service during an Eligibility Computation Period) and are at least 21 years old are eligible to participate in the Plan. Effective November 11, 2024, the service requirement is updated to three months. Upon eligibility, employees may enter the Plan on January 1 or July 1. Effective November 11, 2024, plan entry dates were updated to quarterly. Employees are immediately vested in their contributions, plus earnings thereon, while vesting of employer contributions is based on years of service as follows:

Less than 2 years' service	0%
2 years but less than 3 years	20%
3 years but less than 4 years	40%
4 years but less than 5 years	60%
5 years but less than 6 years	80%
6 years' service or more	100%

Effective November 11, 2024, the vesting of employer contributions is based on years of service as follows:

Less than 1 year service	0%
1 year but less than 2 years	25%
2 years but less than 3 years	50%
3 years but less than 4 years	75%
4 years' service or more	100%

Contributions: The Employer makes annual contributions for eligible participants equal to 12% of the employee's eligible annual compensation, not to exceed \$2,350 annually for each participant. In order to qualify for a current year contribution, the employee must be employed on the last day of the current year or meet one of the exception criteria specified in the Plan Document. Effective November 11, 2024, the employer contribution is made each pay period in a discretionary amount, that was equal to 3% of the employee's eligible weekly earnings for 2024.

Participants may contribute up to 100% of their pretax annual compensation, as defined in the Plan, subject to certain IRS limitations. Effective November 11, 2024, participants may contribute up to 75% of their pretax annual compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from

other qualified defined benefit or contribution plans. Additional amounts may be contributed by the Employer at the option of the Employer's members. Contributions are subject to certain limitations.

Effective November 11, 2024, the Plan implemented an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant.

Participant Accounts: Each participant's account is credited with the participant's contribution and allocations of the Employer's contributions, Plan earnings, and is charged with his or her withdrawals and an allocation of administrative expenses paid by the Plan. Allocations may be charged based on a pro-rata, percentage basis based on the ratio of the participant's balance to total participant balances, or per participant, on a uniform dollar basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of participant and employer contributions into various investment options offered by the Plan.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Payment of Benefits: On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum or partial withdrawal amounts equal to the value of the participant's vested interest in his or her account, or installments as defined in the Plan. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or leave it in the Plan. In-service distributions are allowed by the Plan if the participant meets certain criteria, as defined.

Forfeitures: Forfeited non-vested accounts may be used to pay Plan expenses or reduce future Employer contributions, or they may be reallocated as additional contributions. During the years ended December 31, 2024, forfeitures of \$14,178 were used to reduce Employer contributions. At December 31, 2024 and 2023, there were \$30,165 and \$14,178, respectively, in forfeited non-vested accounts available.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with market rates for similar loans. All loans are covered by demand notes and are repayable through payroll deductions.

Plan Termination: Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts and disclosures and actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Cash and Cash Equivalents: The Plan considers all cash and money market accounts with an original maturity of three months or less to be cash equivalents. The Plan invests excess cash in uninsured money market accounts with a national brokerage firm.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through October 14, 2025, which is the date the financial statements were available to be issued.

NOTE 3 – CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (U.S.A.), the custodian of the Plan, as of December 31, 2023 and for the period from January 1, 2024 to November 8, 2024, and by Fidelity Management Trust Company, the trustee of the Plan, as of December 31, 2024 and for the period from November 9, 2024 to December 31, 2024.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Pooled Separate Accounts: The fair values of participation units held in pooled separate accounts are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. Each pooled separate account provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund's net asset value per unit. NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Employer. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Employer. As of December 31, 2024, the Plan held party-in-interest investments consisting of mutual funds issued by Fidelity Investments. Fidelity Management Trust Company (“Fidelity”) is the trustee of the Plan and Fidelity Investments is an affiliate of Fidelity; therefore those transactions qualify as exempt party-in-interest transactions. As of December 31, 2023, the Plan held units of pooled separate accounts managed by John Hancock Life Insurance Company (U.S.A.) (“John Hancock”). John Hancock is a service provider to the Plan and, therefore, these transactions and the Plan’s payment of fees to John Hancock qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 6 – TAX STATUS

The Internal Revenue Service issued an opinion letter dated June 30, 2020, indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
