## INDEPENDENT AUDITOR'S REPORT

To the Downriver Community Services, Inc. 403(b) Thrift Plan Participants

### **Scope and Nature of the ERISA Section 103(a)(3)(C)**

A. DESCRIPTION OF PLAN:

The following description of Downriver Community Services, Inc., (organization) 403(b) Thrift Plan (Plan) provides only general information. Participants should refer to the Downriver Community Services, Inc. 403(B) Thrift Plan, plan document, adoption agreement and plan summary for a more complete description of the Plan's provisions.

**1. General**

The Plan is a defined contribution plan covering employees who normally work more than 20 hours per week and nonstudent employees of the organization. This 403(b) plan is a Custodial Account Plan (Code section 403 (b) (7)) invested in mutual funds. An employee becomes a Participant in the Elective Deferral portion of the Plan on his/her first day of employment with the Employer. To become a participant in the nonelective contributions portion of the plan, an employee must be 21 years old and satisfy a one year of service eligibility condition. An employee must complete 1,000 hours of service during the relevant eligibility computation period to receive credit for one year of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**2. Contributions - Elective deferrals**

A participant may make an election to defer his/her compensation and have it contributed to the plan under a salary reduction agreement. The salary reduction agreement has specific maximum and minimum deferral limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up deferral contributions.

**3. Contributions - Nonelective**

The employer contributes a nonelective contribution based upon a percentage of employee compensation ranging from 2% to 7% based upon years of service. For nonelective contributions only, compensation in excess of \$94,353 is excluded beginning in 2007 and increased annually according to the Federal Government COLA rate. For 2024 and 2023, the maximum wage amount used to calculate the nonelective deferral was \$142,810 and \$138,382 respectively. The employer will not match any age 50 catch up deferral. Entry into the nonelective portion of the plan is the first day of the month, once the year of service eligibility is met. Employees are not required to contribute any money in order to participate in the plan. After the initial eligibility period the plan measures subsequent eligibility periods based upon the employee anniversary date.

Following is the nonelective contribution schedule:

Years of Service	Contribution Percentage
1 year of service but less than 3 years of service	2% of compensation
3 years of service but less than 4 years of service	3% of compensation
4 years of service but less than 5 years of service	4% of compensation
5 years of service but less than 6 years of service	5% of compensation
6 years of service but less than 7 years of service	6% of compensation
7 years of service or more	7% of compensation

**4. Participant Accounts**

Each participant's account is credited with the participant's contribution and (a) the Organization's nonelective contribution and, (b) Plan earnings (losses). The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The plan does not apply any allocation conditions to all employer contributions, elective deferrals, and forfeitures. Participants direct the investment of their elective deferrals and nonelective contributions into various investment options offered by the Plan. The Plan currently offers numerous mutual fund investment options for participants.

**5. Vesting**

Participants are immediately vested in their elective deferral contributions plus actual earnings thereon. Vesting in the Organization's nonelective contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service and 0% vested for less than three years of service. A participant who incurs a separation from service as a result of death or disability becomes 100% vested.

**6. Participant Loans**

The plan allows participants to borrow from their 403 (B) account balances. The minimum loan available to a participant for a loan is \$1,000. All loans will be limited to 50% of a participant's vested account balance, provided such loans do not exceed \$50,000. The \$50,000 maximum loan amount is reduced by the participant's highest outstanding loan balance in the previous 12 months over the existing loan balance, if any, on the date a new loan is made. The interest rate charged on loan is determined as follows: For loans originating in any given month, the interest for a loan will be based on the prime rate published in The Wall Street Journal on the first business day of each month. An \$85 loan origination fee is charged for each loan and is deducted from the approved loan amount. An annual loan maintenance fee of \$50 will be charged on each loan and will be deducted from participant account. Principal and interest payments shall be made by means of bi-weekly payroll deductions.

**7. Payment of Benefits**

The plan provides for a mandatory distribution of a participant's vested account balance, including rollover contributions, if the maximum is less than or equal to \$5,000. An employee who has incurred a severance from employment and who elects to receive a distribution will receive a lump sum distribution.

**8. Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$81 and \$80 respectively. The employer may elect to use these funds to pay plan administrative expenses, or to reduce future nonelective contributions. Forfeitures of \$17,069 and \$7,293 were used in 2024 and 2023, respectively.

B. SUMMARY OF ACCOUNTING POLICIES:

**1. Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles required the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**2. Basis of Accounting**

The financial statements of the plan are prepared on the accrual basis of accounting.

**3. Notes Receivable from Participants**

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

**4. Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

**5. Payment of Benefits**

Benefits are recorded when paid

**6. Operating Expenses**

All expenses of maintaining the Plan are paid by the employer, Downriver Community Services, Inc.

D. FAIR VALUE MEASUREMENTS:

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use Level 2 or 3 inputs for the period presented.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Level 1**

Mutual fund shares held in mutual funds are valued at quoted market prices that represent the net asset value “NAV” of shares held by the Plan at year end. NAV is based on the value of underlying assets owned by the fund, less liabilities, and then divided by the number of shares outstanding. Mutual funds held by the Plan are registered with the SEC and are required to publish daily NAV and to transact at that price, and therefore, are considered actively traded.

E. RELATED PARTY TRANSACTIONS:

American Funds acts as the Investment manager and education consultant for the plan. Fees paid by the Plan for the recordkeeping services amounted to \$1,712 and \$626 for the years ended December 31, 2024 and 2023.

F. PLAN TERMINATION:

Although it has not expressed any intent to do so, the organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

G. TAX STATUS:

The Internal Revenue Service does not have an approval program for 403(b) documents. The Plan administrator and the Plan's third-party administrator believe that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC. Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more than likely than not would not be sustained upon examination by the IRS. Management has evaluated any uncertain tax position and does not believe that there is any required disclosure or adjustments required to the financial statements.

H. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.
