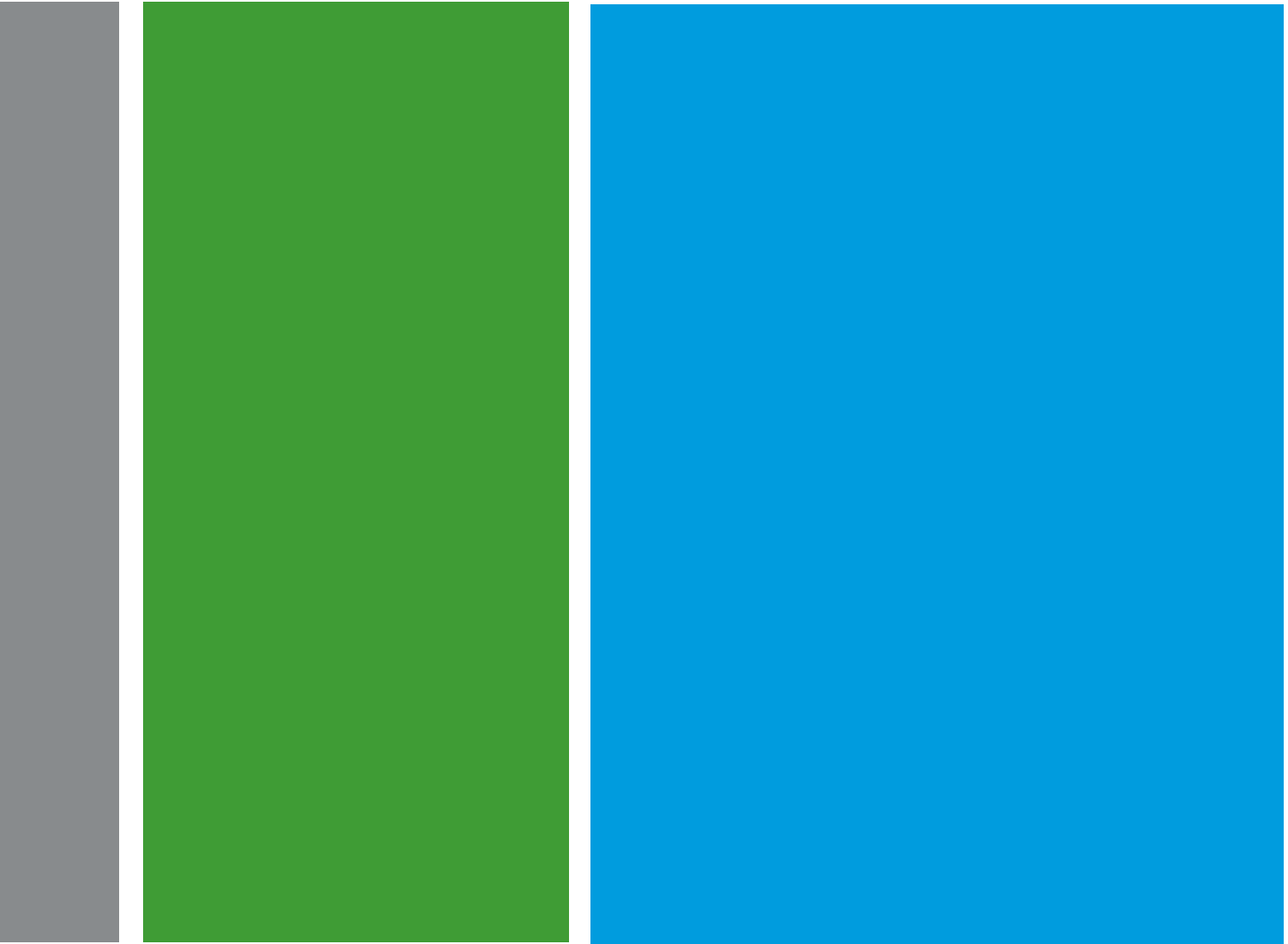

### 1) Plan Description:

The following brief description of Atlantis Healthcare 1165(e)/401(k) Savings Plan for Non-Union Employees (the Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement for a complete description of the Plan's provisions.

- A) General – On July 1, 2006, Atlantis Health Care Group (Puerto Rico), Inc. (the Employer) adopted a defined contribution retirement plan to eligible employees. Employees become eligible to participate in the Plan after meeting the following requirements: minimum age of twenty-one (21), or twenty-one (21) with three months of service.

The Plan qualifies under Section 1081.01 of the Puerto Rico Internal Revenue Code (the Code) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Banco Popular de Puerto Rico is the Trustee of the Plan.

Plan year	:	December 31
Normal retirement	:	The later of participant attaining age 65 or the fifth anniversary after becoming a participant
Plan entry date	:	Quarterly entry dates. The first day of each of the first, fourth, seventh and tenth months of the Plan Year is an entry date.

- B) Contributions – The Plan provides for contributions to be made by the Employer and by participants as follows:

- Employee pre-tax contributions – Pre-tax contributions were limited to \$15,000 for the year ended December 31, 2024, as established by Section 1081.01 (d)(7)(A)(i) of the Puerto Rico Internal Revenue Code (the Code).
- Employee after-tax contributions – May not exceed 10% of the aggregate compensation paid to the employee as provided by Section 1081.01 (a)(45) of the Code. After tax contributions may be subject to other restrictions and rules established by the Plan Administrator.
- Employee rollover contributions – Participants may also contribute amounts transferred from other Puerto Rico qualified retirement Plans.
- Employer contributions – The Employer contributes to the Plan on behalf of each Plan participant 50 cents for each dollar of the participant's pre-tax contribution. The employer will not make matching contributions above 10% of the participant's compensation.
- Profit sharing contributions – For each Plan year in which this Plan is in effect, the Employer may make contributions to the Trust in one or more installments out of its net profits for the Plan year, in such amounts as the Employer may determine. The Plan year for which each contribution is made shall be designated at the time of the contribution. Profit sharing contributions shall be allocated as of the last day of the Plan year among employees who have completed 1,560 hours of service during the Plan year.

For the year ended December 31, 2024, total annual contributions made by the Employer and participants were limited to the lesser of \$69,000 or the total compensation paid by the Employer to the participant during the Plan year, as provided by Section 1081.01 (a)(11)(B)(i) of the Code.

- C) Participant accounts – Individual accounts are maintained for each of the Plan’s participants to reflect the participants and employer’s contributions as well as the participants’ share of the Plan’s income and any related expenses. Allocations are based on the proportion that each participant’s account balance bears to the total of all participants’ account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participants vested accounts.
- D) Participant elections – Participants may decide how the contributions allocated to them are invested among the investment options offered by the Plan. The Plan currently offers mutual funds as investment options for participants. Any investment election may be changed with respect to future contributions.
- E) Vesting – Contributions made by participants, rollover contributions and qualified non-elective contributions, plus or minus any earnings or losses, are 100% vested at all times. Participants are 100% vested in the Profit-Sharing contributions after completing three (3) years of services. Regarding vesting in the matching employer’s contribution portion to their accounts is determined as follows:

2	20%

4	60%

6	100%

- F) Payments of benefits – Normal retirement date is the date on which the participant attains the later of reaching age 65 or the fifth anniversary of the first day of the Plan year in which the participant entered the Plan. On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest or annual installments over a fixed period of time, not to exceed ten (10) years.
- G) Financial hardship – Financial hardship represents participant withdrawal necessary to meet immediate financial needs to cover only the following expenses: medical expenses, purchase of principal residence, tuition payments for post-secondary education, rent or mortgage payments to prevent eviction, and funeral expenses. Plan Administrator may determine any other cause that has produced an immediate and heavy financial need to the extent deemed necessary to satisfy the requirements of Article 1165-8(d)(2) of the Code or such other event or circumstances as the Puerto Rico Secretary of the Treasury through regulation may permit.
- H) Forfeitures – Forfeitures represent non-vested portions of Employer’s contributions on the day of the participants’ termination. Forfeitures are used to reduce any Employer’s contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts amounted approximately to \$30,400 and \$6,400, respectively.

### 2) Summary of Significant Accounting Policies:

The most significant accounting policies followed by the Plan are summarized below:

- A) Basis of accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.
- B) Use of estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- C) Interest in Master Trust – Investment assets of the Plan are maintained in the Master Trust administered by Banco Popular de Puerto Rico, as Trustee.
- D) Investment valuation and income recognition – Plan’s investments are stated at fair value. See Note 5 for discussion of fair value measurements.

The net appreciation (depreciation) in fair value of investments, including realized gains or losses and net change in unrealized gains or losses, is reflected in the statement of changes in net assets available for benefits. Realized gains or losses on the disposal of investments are determined by specific identification and recognized on a trade date basis. Purchases and sales are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date.

- E) Contributions – Employer and participant’s contributions are recorded in the Plan year in which the Employer makes the payroll deductions.
- F) Payment of benefits – Benefits payment to participants are recorded when paid.
- G) Expenses – Expenses are paid by the Employer, therefore excluded from these financial statements. Investment related expenses are reported in net appreciation (depreciation) of investments.

### 3) Information Certified by Banco Popular de Puerto Rico (Trustee):

Plan’s asset information as of December 31, 2024 and 2023 and for the years then ended, included throughout the Plan’s financial statements and supplemental schedule, was prepared by or derived from information provided by the Trustee and furnished to the Plan Administrator.

The Plan Administrator has obtained certifications from the Trustee that information provided to the Plan Administrator by the Trustee related to the Plan’s assets is complete and accurate. Accordingly, as permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information, which appears throughout the financial statements and supplemental schedule related to the following assets:

Information of the Master Trust's investments by level was not readily available.

Investments held by the Plan within the Master Trust are considered Level 1 type investments within the fair value hierarchy, except for the investment in obligations of U.S. governmental agencies that are considered Level 2.

### 5) Fair Value Measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The valuation techniques are based upon observable or unobservable inputs. Observable inputs reflect market data obtained from independent sources, while unobservable inputs reflect the Master Trust's market assumptions.

These two types of inputs create the following fair value hierarchy:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

### 6) Party-In-Interest Transactions:

Atlantis Health Care Group (Puerto Rico), Inc. is a party-in-interest as defined by ERISA. The Plan includes a cash account from Banco Popular of Puerto Rico, who is the Trustee of the Plan, therefore, these transactions also qualify as party-in-interest transactions as defined by ERISA. There were no prohibited transactions for the year ended December 31, 2024.

### 7) Tax Status:

The Plan is intended to be a tax-qualified arrangement that complies with the provisions of ERISA, and the Code. A Determination Letter was issued by the Puerto Rico Treasury Department on June 26, 2012. Although the Plan has been amended since receiving the latest Determination Letter, the Plan Administrator and the Plan's legal counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code.

Accounting principles generally accepted in the United States of America require Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination of taxing authorities. The Plan Administrator evaluated the tax positions taken by the Plan and concluded that the Plan as of December 31, 2024 and 2023, had maintained its tax-exempt status and had taken no uncertain tax positions that would require adjustments or disclosures to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

### **8) Risks and Uncertainties:**

The Plan's investments are exposed to various risks, such as interest rate fluctuations, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the Plan's account balances and the amounts reported in the accompanying statements of net assets available for benefits.

### **9) Plan Termination:**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time or to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become 100% vested in their accounts.

### **10) Subsequent Events:**

The Plan Administrator is not aware of any subsequent events which would require recognition and/or disclosure in the financial statements. The Plan Administrator has evaluated subsequent events through October 7, 2025, the date on which the financial statements were available to be issued.
