Report of Independent Auditors

To the Administrator of the Narda-MITEQ 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the Narda-MITEQ 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, including the related notes (collectively referred to as the “financial statements”).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Basis for Opinion

The following brief description of the Narda MITEQ 401(k) Plan (the “Plan”) is provided for general information purposes only. Narda Holdings, Inc. (the “Company”) is the Plan’s sponsor. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan that was established on December 1, 2021 to allow the Company’s eligible employees an opportunity to save for retirement on a tax-advantaged basis. Plan contributions are made at specified rates and are credited to an individual account for the benefit of each participant. Investment income of the Plan is allocated daily to individual participant accounts based on participant account balances, as provided in the Plan. The benefit to which a participant is entitled is the amount provided by the participant’s vested account balance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Eligibility

All employees of the Company’s New York location, excluding union employees and non-US citizens, are eligible to participate in the Plan on their hire date for employee contribution amounts.

Vesting

Participants are immediately vested in employee contributions and allocated share of earnings. Participants vest over a 3 year period for all employer contributions and the earnings thereon. The vesting percentages after years 1-3 are as follows: After 1 year of service – 25% vesting, after 2 years of service - 50% vesting and after 3 years of service - 100% vesting. Also, an employee fully vests in the employer contributions upon reaching the age of 55 years if not fully vested based on their years of service upon their 55th birthday, or death, or disability. Service for the predecessor employer to the Company is included in the vesting period.

Contributions

Eligible participants may elect to have made on their behalf, through salary reductions, a contribution at each payroll period. Participants may contribute up to the maximum allowable amount as prescribed in the Internal Revenue Code (\$23,500 per annum for 2024). Contributions for highly compensated employees are reduced if certain nondiscrimination tests are not complied with. Contributions made to the Plan are recorded during the Plan year in which they are withheld. In addition, participants aged 50 and over may contribute a “catch-up” contribution up to \$7,500 in 2024. Participants are permitted to make rollover contributions from certain other qualified plans.

The Company matches 100% of each employee participant’s contributions up to 6% of eligible compensation after 90 days of service. The Plan was modified effective January 1, 2024 to exclude bonuses from eligible compensation. The matching contribution is based upon the employee contributions on a weekly basis throughout the calendar year and stops when the employee stops contributing to the plan or when the employee and/or the employer hits the Internal Revenue Service (“IRS”) statutory 401(k) limits.

Profit Sharing

The Company has, at its sole discretion, the capability to provide a profit sharing distribution to plan participants after year end based on the Company performance. The contribution is done on a non-elective basis as a ratio of a participant's total eligible compensation compared to total eligible annual compensation. The distribution will be made to all eligible employees regardless of whether they are enrolled as a plan participant. The Company did not provide a profit sharing contribution in 2024.

Forfeitures

Participants who terminate employment, but have not become fully vested in Company contributions, forfeit their vested balances. In accordance with the Plan, the amount of forfeitures will be applied to reduce Company contributions or pay plan expenses. Forfeitures for the year ended December 31, 2024 was \$8,988. This amount was used to reduce the Company's contributions for the year ended December 31, 2024.

Administrative Expenses

For the year ended December 31, 2024, expenses related to the administration of the Plan were paid by the Company and the Plan.

Payments of Benefits

A participant's vested interest in Plan assets is distributable generally upon termination, disability, retirement or death. Active participants may receive distributions from the vested amounts in their accounts at any time after attaining the age of 59-1/2 or due to hardships as defined in the Plan. Participants may elect to receive their account balance as a single lump-sum payment (which payment would generally be eligible to be rolled-over to an individual retirement account of the participant's choosing), or as a direct transfer to an individual retirement account.

Notes Receivable From Participants

Under certain conditions, participants may borrow up to 100% of the participant's vested account balance, subject to the provisions of the Plan. However, the amount the Plan may loan is limited to the lesser of \$50,000 reduced as defined in the Plan or one half of the vested interest in the Plan. The repayment term of the loans may vary from one to five years (with the exception of a loan used to purchase a primary residence, in which case the term of the loan may exceed five years) with interest payable at a fixed rate equal to the prime rate (as of the first day of the month following receipt of the loan application), plus 1%.

The loans are evidenced by promissory notes and require repayments of principal and interest to be deducted from the participants' salaries. The loans to a participant are collateralized by the participants' interests in the Plan's assets. If a participant terminates service with the Company prior to repayment of the loan, the outstanding balance of the loan becomes due immediately and the amount of the participant's distribution from the Plan is reduced accordingly.

Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the participant loan is deemed to be in default, at the time when the participant becomes eligible for a distribution under the terms of the Plan, the participant's account is reduced by the unpaid loan amount, plus any applicable interest, and the reduction is treated as a distribution.

Amendment and Termination of the Plan

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan and to discontinue contributions at any time, subject to the provisions of ERISA. Upon termination or complete discontinuance of contributions to the Plan, all earned benefits credited to each participant's account shall be distributed at the time and in the manner provided for in the Plan. However, neither through amendment, nor by termination, may any part of the Plan's assets be used for purposes other than the exclusive benefit of the participants.

2. Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements have been prepared on an accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investments and Investment Income

The Plan's investments consist of (1) mutual funds (both registered investment companies and institutional), valued at net asset value ("NAV") of shares held by the Plan at year end, as quoted by such funds at year end and (2) money market funds, stated at NAV.

The Plan presents the net appreciation or depreciation in the fair value of its investments, which consists of realized gains or losses and unrealized appreciation or depreciation of those investments, in the Statement of Changes in Net Assets Available for Benefits.

Purchases and sales of investments are recorded as of the trade date. Interest income is accrued when earned, and dividend income is recorded as of the ex-dividend date. Capital gain distributions are included in dividend income. Investment earnings are automatically reinvested into the fund from which they were derived.

Contributions Receivable

Employer and participant contributions receivables are recorded for amounts due to the Plan related to the current fiscal year at year-end and received by the Plan within the following fiscal year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Risks and Uncertainties

The Plan provides for investments in various investment securities that are, in general, exposed to various risks, such as interest rate, credit and overall market volatility risks. Given the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur and that such changes could materially affect participants' account balances and amounts reported in the financial statements.

4. Fair Value of Financial Instruments

Accounting principles generally accepted in the United States provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The valuation techniques used by the Plan to measure fair value as of December 31, 2024 and 2023 were as follows:

Mutual Funds and Money Market Funds

Valued at the NAV of shares held by the Plan at year end. The NAV of the mutual funds and money markets is based on prices in active markets. Participants can redeem shares from the mutual funds on a daily basis.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurement at the reporting date.

5. Related Parties and Parties-In-Interest

The Plan Administrators are the employee members of the 401(k) Plan Committee of the Company. The 401(k) Plan Committee acts as fiduciaries having responsibility to exercise discretionary control over the Plan's management and administration. Recordkeeping fees, investment advisory fees and financial statement audit fees are paid by the Company. Reliance Trust Company is the Trustee of the 401(k) plan for the company and holds the assets of the plan. In addition, certain participants borrowed from the Plan. Such participants are parties-in-interest to the Plan.

6. Income Tax Status

The Plan has adopted a plan document template provided by the record keeper (ADP) that was pre-approved by the Internal Revenue Service, who issued an opinion letter dated October 6, 2020 indicating that the plan document template met the applicable sections of the Internal Revenue Code. This plan document template was used to create the Plan document adopted by the Plan. The Plan is required to operate in conformity with the Code to maintain its qualification. The Plan

Administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

7. Subsequent Events

The Plan's Administrator has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued. No subsequent events that would require disclosure in these financial statements have been noted as of this date.
