INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the accompanying financial statements of the Magic City Motor Corporation Employees' Profit Sharing and Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN:

The following description of the Magic City Motor Corporation Employees' Profit Sharing and Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Magic City Motor Corporation and subsidiaries (the "Company"). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan Committee oversees governance of the Plan. The Plan Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Each year, participants may contribute up to 100% of pretax annual eligible compensation, not to exceed the allowable amount under Section 402(g) of the Internal Revenue Code ("IRC"). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (i.e., rollover contributions). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan at a 2% deferral rate with an automatic escalation of 1% at the beginning of each calendar year up to a maximum rate of 10% unless they choose to opt out.

Each year the Company, subject to the discretion of the Company's Board of Directors, may make discretionary profit-sharing contributions to the Plan. There were no profit-sharing contributions for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution, investment earnings, eligible forfeitures, and administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their participant contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portions plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the participant's vested account balance in the Plan and bear interest at the prime rate plus one percent. Principal and interest are paid ratably through monthly payroll deductions. Loans may only be distributed for approved hardship reasons. Loan terms can range from one to five years for general purpose hardships and five to fifteen years for purchases of principal residences.

1. DESCRIPTION OF PLAN – (Continued):

Investment Options

Upon enrollment in the Plan, a participant may direct contributions to a variety of investment funds.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,963 and \$28,312, respectively. Under the Plan, forfeitures are reallocated to existing participants. In 2024, \$42,067 was reallocated to existing participants.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

The following accounting policies, which conform to U.S. generally accepted accounting principles ("GAAP"), have been used consistently in the preparation of the Plan's financial statements.

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with GAAP, the Department of Labor's ("DOL") rules and regulations, and disclosure under ERISA.

Estimates

The preparation of financial statements in accordance with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Significant estimates used in preparing these financial statements include the fair value of investments. It is at least reasonably possible that significant estimates will change within the next year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the Plan administrator considers the note receivable to be in default, the note receivable balance is maintained until a distributable event has occurred at which point the note receivable balance will be reduced and the delinquent note receivable is recorded as a benefit payment based on the terms of the Plan document.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – (Continued):

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Withdrawal and loan fees are charged to the participants' accounts that incurred the fees. All remaining administrative expenses paid by the Plan are allocated to the participants' accounts based on their ownership percentage of the funds generating the expense. The Company pays for some administrative expenses of the Plan, which are not reflected in these financial statements.

Investment Valuation and Income Recognition

Investments are reported at fair value. See the note titled "Fair Value Measurements" for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

3. FAIR VALUE MEASUREMENTS:

The Plan's investments in pooled separate accounts are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs are other than quoted market prices in active markets which are either directly or indirectly observable, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 3 inputs were necessary for the Plan.

The following is a description of the valuation methodologies used for assets measured at fair value:

Pooled Separate Accounts – Investments in pooled separate accounts are valued at the net asset value ("NAV") of shares held by the Plan at year end as reported by the fund managers.

4. RELATED PARTY TRANSACTIONS:

John Hancock (the "Trustee") serves as the trustee and manages the Plan investments. These investment transactions qualify as party-in-interest since all pooled separate accounts are sponsored by the Trustee. Fees paid to the Trustee for investment management services and administration costs amounted to \$59,128 and were allocated to the participants' accounts based on their percentage ownership of that fund unless they were incurred by a participant's request for a loan or withdrawal. Loan and withdrawal fees are charged directly to the participant's account that initiated the transaction.

Certain administrative functions are performed by officers or employees of the Company. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

5. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

6. INCOME TAX STATUS:

The Plan has adopted a prototype plan sponsored by the Trustee. The Internal Revenue Service (“IRS”) has determined and informed the Plan sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain tax position that more likely than not would not be sustained upon examination by the IRS. There are no uncertain tax positions. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to tax examinations for years prior to 2021.

7. INFORMATION PREPARED AND CERTIFIED BY TRUSTEE:

All assets are held and invested by the Trustee as of December 31, 2024 and 2023 and for the year ended December 31, 2024. The Trustee receives and holds all income from the investments. The Trustee has certified the completeness and accuracy of all investments reflected in the accompanying statements of net assets available for benefits and the related investment activity reflected in the statement of changes in net assets available for benefits.

The following information included in the accompanying financial statements as of December 31, 2024 and 2023 and for the year ended December 31, 2024 was obtained from data that has been prepared and certified as complete and accurate by the Trustee.

8. RISKS AND UNCERTAINTIES:

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

9. SELF CORRECTION PROGRAM:

The Plan Sponsor intends to enter the Self Correction Program to correct insignificant Plan operational failures as allowed by the IRS. The Plan Sponsor has consulted with outside advisors and is in the process of evaluating corrective actions.

10. SUBSEQUENT EVENTS:

Management has evaluated all subsequent events through October 14, 2025, the date the financial statements were available to be issued.
