To the Plan Administrator and Participants of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Ross Mould, LLC Bargaining Employees' Defined Benefit Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits and of accumulated plan benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in accumulated plan benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

December 31, 2024 and 2023

1. Description of Plan

The following description of the Ross Mould, LLC Bargaining Employees' Defined Benefit Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a noncontributory defined benefit plan established effective August 1, 1983, as restated January 1, 2024. Effective September 30, 2014, the Plan was amended to freeze entry into the Plan. After that date, no employee shall become an active participant. Effective March 31, 2018, the Plan was amended to freeze accrued benefits under the Plan. Prior to the plan freeze, the Plan covered substantially all employees of Ross Mould, LLC, Penn Mould, Inc., Brockway Mould, Inc. and OMCO Mould, Inc. (collectively, the Company) who are represented for collective bargaining purposes by United Steel, Paper and Forestry, Rubber, Manufacturing, Energy, Allied Industrial and Service Workers International Union AFL-CIO, CLC, Flint Glass Industry Conference or Glass, Moulders, Pottery, Plastic and Allied Workers International Union AFL-CIO, CLC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Plan management is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Board of Directors (trustees) of the Company.

Funding Policy

The Plan's funding policy is for the Company to contribute an amount which will meet or exceed the annual ERISA minimum funding requirement. The minimum funding requirements of ERISA were met in 2024 and 2023.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Pension Benefits

Participants are entitled to a monthly annuity beginning before the sixtieth day following the close of the plan year in which the latest date below occurs:

- The date at which the participant attains age 65;
- The tenth anniversary of the participant's entry date;
- The date the participant ceased to be an employee.

Monthly benefits are payable based upon a formula, which multiplies an agreed upon amount as documented in the collective bargaining agreement times the number of years of credited service. The agreed upon amount varies and is based upon the year in which the participant is entitled to receive benefits and the participant's labor grade immediately preceding retirement.

The Plan permits early retirement for participants who have attained age 55 and who also have 10 years of vesting service. Accrued benefits on the early retirement date are reduced by $\frac{1}{2}$ of 1% for each month that the early retirement date precedes the date in which the participant turns age 60. Active participants who have attained age 55 and who have a minimum of 30 years of service may elect early retirement with no reduction in benefits.

Effective October 15, 2024, the Plan was amended to allow a voluntary lump sum retirement window for eligible participants through November 30, 2024. Lump sum benefit payments to participants as a result of this amendment were approximately \$0.5 million in 2024.

Death Benefit - Qualified Preretirement Survivor Annuity

A qualified preretirement survivor annuity shall be payable to a participant's spouse provided the following requirements are met:

- The participant and spouse were married for a minimum of one year ending on the date of death;
- The participant was vested in the Plan.

Death Benefit - Survivor's Pension

A survivor's pension shall be payable to a participant's spouse provided the following requirements are met:

- The participant attained age 40 prior to death;
- The participant completed 10 or more years of vesting service prior to death.

The benefit payable is equal to 50% of the accrued benefit at the date of death.

Disability Benefit

Active participants with a minimum of 10 years of service are eligible to receive disability benefits.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein; disclosure of contingent assets and liabilities; and the actuarial present value of accumulated plan benefits at the date of the financial statements, and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits payments to participants are recorded upon distribution.

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation in fair value of investments in the Statement of Changes in Net Assets Available for Benefits.

Subsequent Events

Subsequent events were evaluated through October 13, 2025, the date the financial statements were available to be issued.

On April 2, 2025, the Plan purchased group annuity contracts for approximately \$35.8 million from third-party carriers to pay and administer future annuity payments.

3. Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments, including lump-sum distributions, that are attributable under the Plan's provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. Benefits under the Plan are based on employees' compensation during each year of credited service. The accumulated plan benefits for active employees will equal the accumulation, with interest, of the annual benefit accruals as of the benefit information date. Benefits payable under all circumstances, such as retirement, death, disability, and termination of employment, are included, to the extent they are attributable to employee service rendered to the valuation date. Benefits to be provided via annuity contracts excluded from plan assets are excluded from accumulated plan benefits.

The actuarial present value of accumulated plan benefits is determined by the Plan's independent actuary and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

The actuarial present value of accumulated plan benefits includes total flexible pension investment contracts (see Note 11) of approximately \$11.4 million and \$ 11.9 million as of December 31, 2024 and 2023, respectively. The computations of the actuarial present value of accumulated plan benefits were made as of January 1, 2025 and 2024. Had the valuations been performed as of December 31, there would be no material differences. The significant actuarial assumptions used in the valuations were:

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated plan benefits.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued based upon the unit values of such pooled accounts held by the Plan at year end. Unit values are based on the fair value of the underlying assets of the fund derived from inputs principally from or corroborated by observable market data by correlation or other means, although are not based upon quoted market prices in an active market. The underlying investments of the pooled separate accounts consist of mutual funds, each of which follows a separate investment strategy. Due to the nature of these pooled accounts, there are no unfunded commitments or redemption restrictions.

5. Concentrations

As of December 31, 2024 and 2023, the Plan had investments of \$18,924,907 and \$16,832,760, respectively, that were concentrated in three funds.

6. Information Certified by Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Principal Life Insurance Company, the Custodian of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024 and the information reported in the supplemental Schedule H, Line 4(j) - Schedule of Reportable Transactions for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

7. Related-Party and Party in Interest Transactions

The plan's investments are administered under a contract with the Custodian of the Plan. Contributions are held and managed by the Custodian, who invests cash received, interest and dividend income and makes distributions to participants. These transactions are party in interest transactions under ERISA.

As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to various service providers. Additionally, certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. These transactions are party in interest transactions under ERISA.

Fees incurred by the Plan for the investment management services are included in net appreciation in the fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Custodian receives revenue from investment fund service providers for services the Custodian provides to the funds. This revenue is used to offset certain amounts owed to the Custodian for its administrative services to the Plan. If the revenue received by the Custodian from such investment fund service providers exceeds the amount owed for its services, the Custodian remits the excess to the Plan's trust on a quarterly basis. The Plan or Plan Sponsor may make a payment to the Custodian for administrative expenses not covered by revenue sharing.

8. Plan Termination

In the event the Plan terminates, the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

1. Annuity benefits that former employees or their beneficiaries have been receiving for at least three years, or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under Plan provisions in effect at any time during the five years preceding Plan termination.
2. Other vested benefits insured by the Pension Benefit Guaranty Corporation (PBGC) (a U.S. government agency) up to the applicable limitations.
3. All other vested benefits (that is, vested benefits not insured by the PBGC).
4. All nonvested benefits.

Certain benefits under the Plan are insured by the PBGC if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination.

Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations and may also depend on the financial condition of the plan sponsor and the level of benefits guaranteed by the PBGC.

9. Tax Status

The Plan adopted a pre-approved plan offered by Principal Life Insurance Company. The pre-approved plan received an Internal Revenue Service (IRS) Advisory Letter dated July 12, 2021, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

11. Flexible Pension Investment Contract

The Plan document includes a benefit payment option with Principal, under which Principal guarantees to pay all future benefits to which retired participants that have elected this payment option are entitled, in the event that the Plan is unable to do so. Retired participants that elect this payment option receive a certificate from Principal that is an irrevocable commitment to pay all future benefits to which the individual is entitled. This certificate is a legally enforceable guarantee by Principal to pay a specific dollar benefit at a future date, with no fluctuations in market value.

In order to maintain the funds necessary to pay these guaranteed benefits, Principal reserves a portion of the Plan's assets to which it is contractually entitled. The amount reserved is equal to the present value amount required to purchase an annuity contract for each retired participant. These contracts meet the allocated contracts criteria under 29 CFR 2520.104-44, and are therefore excluded from the Plan's investments in the accompanying financial statements. At December 31, 2024 and 2023, the amounts of these allocated contracts totaled approximately \$11.4 million and \$11.9 million respectively.

The values of these allocated contracts fluctuate regularly a result of investment gains or losses, transfers in for new retirees, transfers out when payments to retirees cease, and changes in the price to purchase annuity contracts with equivalent retirement benefits. Changes in the present value of these allocated contracts result in opposite equivalent changes in the Plan's unallocated contracts and are accounted for as other additions or deductions on the accompanying Statement of Changes in Net Assets Available for Benefits.

Models Used in Preparing Results: Acrisure uses valuation and projection software to model benefit cash flows, present values, and attribution to various periods based on deterministic or stochastic assumption sets and benefit parameters provided by the user. The software model also supports comparisons between periods to measure gains and losses and compile plan experience data to support or modify demographic and certain economic assumptions.

In the absence of adequate review, the model's complexity and flexibility could lead to unintentional results. However, the model contains robust tools to test and verify the reasonableness of results. Our internal technical review utilizes these tools.

We have reviewed the model's documentation and have relied on the expertise of the software vendor for underlying structure, methodology, and extensive supporting calculations. We have not performed a substantial audit of the model or its structure beyond typical use in preparing results as this is typically not done by plan actuaries. However, we expect that the very deep market of qualified users for this same model ensures that no materially significant issues can or will persist.

Plan Provisions

The following is a summary of the major provisions of the plan as of January 1, 2024. Please refer to the plan document for a more complete description of the most recent plan provisions.

Effective Date

- Originally effective August 1, 1983 as last amended effective May 2019.

Eligibility

- Represented for collective bargaining purposes by American Flint Glass Workers of NA Local 112, 71, 143, and 146 or Glass Molders, Pottery, Plastic & Allied Workers International Union Local 110 and 272.
- Entry into the plan is frozen effective September 30, 2014.

Accrual Freeze

- Benefit accruals under the plan are frozen effective March 31, 2018.

Normal Retirement

- Normal retirement occurs at age 65.
- The Accrual Service on such date multiplied by the dollar level, based on Labor Grade, according to the following table:

- The benefit shall be reduced for Brockway Mould employees by the benefit they receive from the prior Owens-Illinois Plan.
- The monthly benefit for an active participant employed by Brockway Mould will also include increases in accordance with the bargaining agreement in effect at the time of his retirement. The primary employer is required to provide a portion of the increases based on all years of accrual service. The Owens-Illinois portion shall be limited to the lesser of (i) 4% per annum from the time of the sale, or (ii) the benefit level for the appropriate time period according to the current bargaining agreement.
- The monthly Accrued Benefit for a participant employed by Penn Mould shall be reduced by his accrued benefit provided by Kraft.
- If a participant dies before receiving 72 monthly benefit payments, his beneficiary shall receive the same monthly benefit until a total of 72 monthly payments have been made.

Plan Provisions (continued)

Early Retirement

- A participant may retire under the early retirement provisions of the Plan on the first day of any month providing they have attained age 55 and have completed 10 Years of Service.
- Accrued benefit on early retirement date reduced by $\frac{1}{2}$ of 1% for each month that the early retirement date precedes age 60. Exceptions are active participants who have attained age 55 with 30 years of vesting service. Their benefits will not be reduced. For inactive participants, accrued benefit on early retirement date reduced by 6% for each year that the early retirement date precedes age 65.

Late Retirement

- Late retirement occurs on the first day of the month coincident with or immediately following the date the participant terminates employment for any reason other than death, which is subsequent to the participant's Normal Retirement Date.
- The late retirement benefit is equal to the greater of the accrued benefit increased to recognize that the annuity commences subsequent to the normal retirement date or the accrued benefit on late retirement date.

Vested Termination

- A participant is fully vested in his accrued benefit after five (5) Years of Service. Shall be 100% vested upon becoming eligible for early or normal retirement, or if totally and permanently disabled.
- The accrued benefit is equal to the benefit developed under the normal retirement formula multiplied by the vesting percentage.

Disability Retirement

- An active participant will be eligible for disability retirement after ten (10) Years of Service.
- If the participant is eligible for Social Security, he shall receive a monthly income payable immediately as if he retired on the date of disability. If the participant is not eligible for Social Security, he shall continue to accrue service. If the disability was non-occupational, he can continue to accrue up to 2 years of additional service.

Pre-Retirement Survivor Annuity (PSA)

- Qualified married participants fully or partially vested in an accrued benefit are eligible.
- Paid in the form of a monthly annuity payable to spouse, deferred to participant's earliest retirement date if later than date of death.
- If death occurs, the amount paid to the surviving spouse equals the amount that would have been paid had the participant terminated employment on the date of death and survived to his/her earliest retirement age, retired with a qualified joint and 50% survivor annuity in effect, and died the next day.

Death Benefit – Survivor's Pension

- Eligible at age 40 with 10 years of vesting service
- Paid in the form of a monthly annuity payable to spouse
- If a participant dies, his spouse shall receive 50% of his accrued benefit on date of death.
- The Plan's Death Benefit is the greater of the PSA or the Survivor's Pension

Payment Forms

- Normal: Life Annuity with 10 years guaranteed.
- Optional: Optional forms of payment available to plan participants which are the actuarial equivalent of the Normal Form are as follows:
 - Life Annuity payable monthly, or 15 years certain and life.
 - 50%, 66 2/3%, 75%, or 100% Joint and Survivor.
 - Monthly annuity with Social Security adjustment option payable for life.
