Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Optim Orthopedics, LLC 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). 1. DESCRIPTION OF THE PLAN:

The following description of the Optim Orthopedics, LLC 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan, established November 1, 1979, amended and restated August 1, 2022, is a defined contribution plan covering all employees of Optim Orthopedics, LLC (the Employer, Company, or Plan Sponsor) who have completed eligible service, defined in the Plan document as 12 consecutive months of service from the employment commencement date, or other eligible service, and who are age 21 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to contribute to the Plan by deferring a portion of their compensation, up to the annual limits permitted by federal law, including catch up amounts available to employees 50 years of age and over. Participants are also allowed to make rollover contributions of amounts received from other tax-qualified retirement plans. Eligible employees are automatically enrolled to defer 6% of their eligible compensation unless they elect otherwise. The Employer may make a discretionary contribution at the option of the Employer's management on a uniform basis to all participants, a safe harbor contribution, a profit sharing contribution, or a matching contribution. For the year ended December 31, 2024, the Employer elected to contribute a safe harbor contribution equal to 3% of each participant's compensation, and a profit sharing contribution, together totaling \$1,514,794.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching and/or safe harbor contributions, as well as allocations of the Company's profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their voluntary contributions and Employer safe harbor contribution plus actual earnings thereon. Vesting in the Employer's discretionary contribution and profit sharing contribution portion of their accounts, plus activity thereon, is based on a graduated schedule of years of continuous service. A participant is 20% vested per year of credited service and is 100% vested after five years of credited service.

1. DESCRIPTION OF THE PLAN (CONTINUED):

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$500, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may have only one loan outstanding at any time, and the loans are made for terms not to exceed five years, unless for the purchase of a principal residence. The loans are secured by the balance in the participant's account and bear interest at a rate equal to 1% over prime. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value, or the portion thereof, of the participant's vested interest in his or her account, or installments over a period not to exceed the participant's life expectancy. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan also permits withdrawals in circumstances of financial hardship, in accordance with provisions specified in the Plan document. Participants are allowed to make in-service withdrawals from their fully vested account balances upon reaching the age of 59 ½.

Forfeited Accounts

Forfeited accounts may be used to pay Plan expenses and to reduce future Employer contributions. As of December 31, 2024 and 2023, the Plan had forfeited non-vested account balances of \$24,644 and \$20,826, respectively. For the year ended December 31, 2024, the Plan used \$144,755 of forfeitures.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED):

Investment Valuation and Income Recognition

Investments are reported at fair value. See Note 3 for discussion of fair value measurements. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by investment advisors and the recordkeeper.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which employee deferrals are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan payments and the loan is deemed to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payments of Benefits

Benefits are recorded when paid.

Expenses of the Plan

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Other expenses for various service providers, including the plan auditor, recordkeeper, and trustee, are paid directly by the Plan and are included in administrative expenses. Fees related to participant distributions and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Automatic Data Processing, Inc. (ADP) has revenue sharing arrangements which are used to offset certain amounts owed to ADP for its administrative services provided to the Plan. If the revenue received by ADP exceeds the amount owed under its agreement with the Plan, ADP remits the excess to the Plan's trust on a quarterly basis. During 2024, there was no excess revenue received by the Plan.

Subsequent Events

The Plan's management has evaluated subsequent events for adjustment or disclosure in the Plan's financial statements through October 14, 2025, the date the financial statements were available to be issued. No recordable or disclosable events occurred through this date.

3. FAIR VALUE MEASUREMENTS:

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date. The fair value framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; or
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

3. FAIR VALUE MEASUREMENTS (CONTINUED):

Common collective trust accounts – valued at the NAV provided by the administrator of the fund as a practical expedient. The NAV is determined by each fund’s trustee based upon the fair value of the underlying assets held in the fund, less liabilities, divided by the number of outstanding units. The common collective funds have no restrictions on participant redemptions. The notice period applicable to the Plan is five days written notice unless time is needed to attain cash for liquidation. The Plan had no unfunded commitments relating to the common collective funds at December 31, 2024.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. CERTIFIED INFORMATION:

For the year ended December 31, 2024, the plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. 5. TRANSACTIONS WITH PARTIES-IN-INTEREST:

ADP is the recordkeeper for the Plan and therefore is a party-in-interest. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are considered parties-in-interest transactions under ERISA.

The Plan issues notes receivable to participants which are secured by the balances in the participants' accounts. These transactions qualify as party-in-interest.

6. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

7. INCOME TAX STATUS:

The Internal Revenue Service (IRS) has provided an opinion letter, dated October 6, 2020, for the Prototype Non-Standardized Profit Sharing Plan with CODA, that the Employer has adopted, which states that the Plan and related trust are acceptable under applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. RISK AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. CONCENTRATIONS:

Three investments comprised 48% of net assets available for benefits as of December 31, 2024. Four investments comprised 62% of net assets available for benefits as of December 31, 2023.
