Report on the Audit of the Financial Statements

NOTE 1 DESCRIPTION OF PLAN

The following description of Service Complete Electric, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a participant directed defined contribution 401(k) plan generally covering all eligible, full-time employees of Service Complete Electric, Inc. (the "Company", "Plan Sponsor" or "Plan Administrator") The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Empower Trust Company, LLC ("Empower" or "Trustee") is the trustee of the Plan and holds all of the Plan's investment assets. The Plan Sponsor is responsible for oversight of the Plan, which includes determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

Effective April 2021, certain provisions under the CARES Act relating to participant distributions and participant loans were enacted. The CARES act allows for utilization of these provisions immediately, but requires formal adoption of the amendment no later than the last day of the Plan year beginning on or after January 1, 2022.

Eligibility

All full-time employees (excluding non-resident aliens and those covered under a collective bargaining agreement) of the Company who are age twenty-one or older and have completed two months of service are eligible to become a participant in the Plan immediately ("Participants").

Contributions

Each year, participants may contribute up to 100% of pre-tax or post-tax ("Roth") annual compensation, as defined in the Plan and limited to the maximum allowable under the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans ("Rollovers"). Upon completion of eligibility requirements, the Plan provides for an automatic enrollment starting with a participant deferral of 3% of compensation, as defined, unless the participant makes a contrary election. A participant's automatic deferral percentage will increase on January 1 of each successive plan year of participation by 1% until a maximum deferral of 6% is reached.

The Plan Sponsor may make a discretionary matching contributions to the Plan each year. For the year ended December 31, 2024, the Plan Sponsor elected to not make a discretionary matching contribution to the Plan. The participant must be employed as of the last day of the Plan year in order to be eligible to share in the Company's discretionary matching contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions (including Rollovers), Plan earnings (losses), and an allocation of any discretionary Plan Sponsor contributions if active in the Plan at year end. Participant accounts are charged for any withdrawals, distributions, and an allocation of administrative expenses that are paid by the Plan. Allocations are based on formulas as defined in the Plan document. The benefit to which is a participant is entitled, is the benefit that can be provided from the participant's vested account.

Upon distribution of the account to a participant who separates from service before vesting, the portion of the account attributable to the non-vested portion of the Company's discretionary matching contribution is forfeited.

Investment Options

Participants may direct the investment of their account balances into various investment options offered by the Plan. The Plan offers a variety of mutual funds, a stable value fund and common collective trusts as investment options for participants. These funds include a variety of investments options with various objectives and degrees of financial risk.

Vesting

Participants are immediately vested in their elective deferral contributions and rollover contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contributions accrue at a rate of 25% per year beginning with the first year of vesting service, with full vesting accrued after four years. Participants must work a minimum of 1,000 hours during each plan year to earn a year of vesting service. The plan provides for 100% vesting of Company discretionary matching contributions and earnings thereon upon attainment of normal retirement age of 65, disability or death.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of (i) 50 percent of the participant's account balance or (ii) \$50,000 (reduced by any loan repayments during the prior year). Loan terms shall not to exceed five years unless the loans proceeds are used to acquire a principal residence for which the term cannot exceed 15 years. The loans are secured by the balance in the participant's account and bear interest at a rate of 6.5 to 9.5 percent, which is commensurate with local, prevailing rates as determined by the Plan Administrator. Participants may only have two loans outstanding at any given time. Principal and interest is paid ratably through monthly payroll deductions.

Benefit Payments

Upon retirement, disability, death or termination of employment, the participant shall become entitled to the total value of his or her vested account. Distributions will be paid in a lump sum or installments over a number of years, based upon election of the participant or the Plan, as defined in the Plan. If a participant terminated employment for any reason and his or her vested account balance does not exceed \$5,000, the Plan Administrator may distribute such amount in a lump sum payment to the participant without consent of participant.

The Plan also allows a participant to withdraw all or a portion of his or her account as an in-service distribution as long as the participant has attained age 59 ½, is still employed by the Plan Sponsor, and has completed six years of service, as defined.

The Plan permits distributions in the event of a hardship, as defined in the Plan document. Hardship withdrawals are limited to the vested portion of the discretionary matching contributions made by the Plan Sponsor and 100% of the participant's elective deferral account.

Forfeited Accounts

Any nonvested amounts remaining after the distribution of a terminated participant's account balance are forfeited. Forfeitures are used to reduce Company discretionary matching contributions or pay Plan expenses. During the year ended December 31, 2024, \$6,828 in forfeitures were used to reduce the discretionary matching contributions paid by the Company relating to the December 31, 2023 contributions. There were \$937 and \$7,104 in unallocated forfeiture accounts at December 31, 2024 and 2023, respectively.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Sponsor determines the plans valuation policies utilizing information provided by investment advisors and custodians. See Note 4 for additional discussion of fair value measurements.

Investment Valuation and Income Recognition

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants are recorded as distributions based on terms of the Plan document.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses incurred in relation to the maintenance of the Plan are paid by the Plan Sponsor and the Plan. For the year ended December 31, 2024, expenses incurred by the Plan totaled approximately \$23,000. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. In addition, certain investment related expenses are included in net appreciation in fair value of investments presented in the accompanying Statement of Changes in Net Assets Available for Benefits.

Subsequent Events

The Plan has evaluated subsequent events for potential recognition and disclosure through October 13, 2025, the date the financial statements were available to be issued. There are no events that have been identified that should be recorded or disclosed.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

Empower Trust Company, LLC, the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open ended mutual funds and are registered with the SEC. The funds are required to publish their daily net asset value ("NAV") and do not transact at that price.

Stable Value Fund: Valued as the NAV as determined by the Trustee, which reflects the fair value of the investments comprising the stable value fund. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is determined to be probably that the fund will sell the investment for an amount different than reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the stable value fund, the Trustee reserves the right to ensure that securities liquidations will be carried out in an orderly business manner.

Common Collective Trusts: Valued at the net asset value (NAV) of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

NOTE 6 RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The Plan's assets are managed by Empower, which is the trustee of the Plan. Therefore, administrative expenses paid to the trustee of the Plan qualify as party-in-interest transactions. Party-in-interest transactions also include transactions with any person who provides services to the Plan, and an employer whose employees are covered by the Plan.

All notes receivable of the Plan are between the Plan and Plan participants. Therefore, these notes qualify as party-in-interest transactions.

NOTE 7 PLAN TAX STATUS

The Plan uses a prototype non-standardized plan which received an opinion letter from the Internal Revenue Service ("IRS") dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore believes that the Plan is qualified and tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 RISKS AND UNCERTAINTIES

The Plan provides for various investment options in investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying Statements of Net Assets Available for Benefits.

The Plan Administrator, through its investment advisor, monitors the Plan's investments and the risks associated therewith on a regular basis, which the Plan Administrator believes minimizes these risks.
