### 1. DESCRIPTION OF THE PLAN:

The following description of The Inspirational Network 401(k) Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

#### GENERAL

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan covers substantially all full-time employees of The Inspirational Network (the Company or the Plan Sponsor) who are age 21 or older and have been employed with the Company for a period of one month. Employees are automatically eligible for the employer match, if any, upon enrollment in the Plan. The Inspirational Network investment committee is responsible for the oversight of the Plan. The investment committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan Sponsor's board of directors.

#### CONTRIBUTIONS

Participants may contribute between 1% and 100% of their annual compensation, up to a maximum of \$23,500 in 2024 and \$22,500 in 2023, respectively. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Plan also includes an auto-escalation provision whereby all participants automatically enrolled in the Plan increase employee deferrals by 1% annually, up to a maximum of 16%.

The Company matches employee contributions on a discretionary basis, as determined by the Company's board of directors. For the period from January 1, 2023, to June 28, 2024, the Company matched 100% of the first 3% and 50% of the next 4% of compensation contributed. Effective June 29, 2024, the employer match was temporarily suspended.

#### INVESTMENT OPTIONS

Upon enrollment in the Plan, a participant directs the investment of all contributions into various investment options offered by the Plan. In addition, participants also have the option to invest in self-managed brokerage accounts.

### 1. DESCRIPTION OF THE PLAN, continued:

#### NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

#### PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution, and allocations of (a) the Organization's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All amounts in participant accounts are participant-directed.

#### VESTING

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in employer matching contributions is based on years of service. A participant is 100% vested when he or she attains normal retirement age, which is defined in the plan document as age 65. Prior to normal retirement age, a participant's interest in the employer contributions vests 20% after two years of service, increasing 20% each succeeding year until fully vested after six years of service.

#### PAYMENT OF BENEFITS

Upon retirement, severance from employment, or death, a participant with an account balance of \$1,000 or more may elect to receive an amount equal to the value of the participant's vested interest in his or her account. Any terminated employee with less than \$5,000 vested will receive a distribution representing his or her vested account balance less applicable income tax withholding, unless instructed to rollover such amount to either an IRA or another qualified retirement plan. Upon disability, reaching age 59 1/2 or incurring a hardship, a participant may make withdrawals from employee contributions and related earnings only.

#### FORFEITURES

Benefit payments to terminated employees partially vested in the Plan include their vested portion of employer contributions. At December 31, 2024 and 2023, non-vested accounts totaled \$66,148 and \$3,796, respectively. For the Plan year ended December 31, 2024, \$61,238 was applied to reduce employer contributions. Forfeitures may be used to reduce administrative expenses or reduce employer contributions according to the plan document.

#### 2. SIGNIFICANT ACCOUNTING POLICIES:

##### BASIS OF ACCOUNTING

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### USE OF ESTIMATES

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### INVESTMENT VALUATION AND INCOME RECOGNITION

The Plan's investments are stated at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an ordinary transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements and Note 5 for a discussion on full benefit-responsive investment contracts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis of accounting. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

##### PAYMENT OF BENEFITS

Benefits are recorded when paid.

##### ADMINISTRATIVE EXPENSES

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to certain transactions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

3. INFORMATION CERTIFIED BY THE QUALIFIED INSTITUTION:

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, one was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company (the trustee and recordkeeper).

4. FAIR VALUE MEASUREMENTS:

The *Fair Value Measurements and Disclosure* topic of the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available.

Mutual funds and self-directed brokerage accounts (invested in mutual funds) are valued at the net asset value (NAV) of shares held by the Plan at year-end. NAV is a readily determinable fair value which is published daily and is the basis for current transactions. Because these funds are traded daily on an active exchange and are valued primarily on the basis of market quotations, official closing prices, or on the basis of information furnished by a pricing service, they are classified as Level 1. The common/collective investment funds are presented at fair value as provided by the trustee based on NAV. NAV is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. There are no unfunded commitments with respect to these investments; however, they may be subject to redemption restrictions, at the trustee's discretion to the extent that it is determined such actions would disrupt management of the funds.

5. GUARANTEED INVESTMENT CONTRACTS WITH INSURANCE COMPANY:

The Plan has fully benefit-responsive guaranteed investment contracts with Principal. Principal maintains the contributions in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The Plan has fully benefit-responsive guaranteed investment contracts with Principal. Principal maintains the contributions in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

5. GUARANTEED INVESTMENT CONTRACTS WITH INSURANCE COMPANY, continued:

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of benefit-responsive guaranteed investment contracts at December 31, 2024 and 2023, was \$21,116 and \$0, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, which was 4.25% as of December 31, 2024. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring. The guaranteed investment contracts do not permit the insurance company to terminate the agreements prior to the scheduled maturity date.

6. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

7. TAX STATUS:

The Plan has adopted a prototype plan document sponsored by Principal. The prototype plan document has obtained an opinion letter from the Internal Revenue Service dated June 30, 2020, in which it states that the prototype plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is operating in compliance with the applicable requirements of the Internal Revenue Code.

8. PARTIES-IN-INTEREST TRANSACTIONS:

Certain Plan investments are managed by Principal Trust Company, a trustee of the Plan, and therefore these transactions qualify as party in interest transactions.

For the year ended December 31, 2024, direct fees of \$84,797 were paid to Principal for recordkeeping and investment management services. In addition, \$13,098 of direct fees were paid to other parties-in-interest for advisor services, professional services, and plan servicing. Direct fees are reflected as administrative fees in the statement of changes in net assets available for benefits. Indirect fees are recorded as a reduction of investment income in the statement of changes in net assets available for benefits.

9. RISKS AND UNCERTAINTIES:

The Plan's investments include funds that invest in various types of investment securities and in various companies within various markets. Investment securities are exposed to several risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Plan's financial statements and schedules.
