**NOTE 1 - DESCRIPTION OF PLAN**

EducationDynamics 401(k) Profit Sharing Plan (the Plan) is a defined contribution plan that became effective January 1, 2007. The Plan is designed to provide retirement, disability, and death benefits to employees of EducationDynamics, LLC (the Plan Sponsor or Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Effective January 1, 2020, the Plan changed its name from the Halyard Education Partner, LLC 401(k) Profit Sharing Plan to EducationDynamics 401(k) Profit Sharing Plan.

Effective May 3, 2021, the Plan adopted an amendment to reflect statutory changes pursuant to the Bipartisan Budget Act of 2018 (BBA), and Internal Revenue Code Sections 401(k) and (m) 2019 Final Hardship Regulations, and any related guidance.

Eligibility: All full-time and part-time salaried and hourly employees who have attained the age of 21 and have completed two months of eligibility service requirements, and all temporary employees who have attained the age of 21 and have completed at least 1,000 hours of service, are eligible to participate in the Plan, provided they are not subject to a collective-bargaining agreement where retirement benefits were a subject of good-faith bargaining and where the inclusion of such employees was not a result of such bargaining, and are not nonresident aliens who do not receive any earned income from the Employer, which constitutes U.S. source income.

Contributions: Each year, participants may elect to defer between 1% and 80% of their annual compensation, as defined, provided their contributions do not exceed maximum allowable amounts under the Internal Revenue Code (the Code). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also allows for Roth 401(k) contributions. Effective January 2, 2013, eligible employees are automatically enrolled in the Plan and 5% of compensation is deferred, subject to increases of 1% annually up to 10%, unless the employee has elected not to participate or elects to change their contribution percentage.

Effective January 1, 2020, in accordance with Plan provisions, the Employer makes safe harbor matching contributions. The Employer contributes 100% of the first 3% of the eligible participant's compensation contributed to the Plan and 50% of the next 2% of the eligible participant's compensation contributed to the Plan. Effective January 1, 2024, the employer matching contribution has changed from the 401(k) safe harbor matching to a discretionary matching employer contribution at 100% of the first 2% of the eligible compensation.

The Employer may also make an additional matching employer contribution on behalf of each eligible participant in an amount equal to a percentage of the eligible contributions made by each eligible participant during the Plan year. The Employer may also make a discretionary nonelective employer contribution in the ratio that each eligible participant's compensation bears, to the total compensation paid to all eligible participants for the contribution period.

Total contributions on a participant's behalf may not exceed amounts in accordance with Internal Revenue Service (IRS) guidelines. The Plan Sponsor elected not to make an additional employer matching employer contribution or a discretionary nonelective contribution during the year ended December 31, 2024.

Rollovers: Rollovers represent transfers of account balances of certain participants into certain investments of the Plan from other qualified plans or from individual retirement accounts. During the year ended December 31, 2024, there were rollover contributions of \$62,582

Participant Accounts and Participants' Investment Options: Individual accounts are established for each participant. Each participant's account is credited with the participant's contributions, the employer contributions, if any, and the proportionate share of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

The Plan offers a stable value fund and a variety of registered investment companies with varying investment objectives as investment options. Upon enrollment in the Plan, participants direct their contributions and employer contributions to any of the investment options offered by the Plan. Participants may change their investment elections among these various investment options at any time.

Vesting: Participants are 100% vested in their deferral contributions, rollover contributions, and the safe harbor matching employer contributions.

See below table for vesting provisions for discretionary nonelective and matching contributions:

Payment of Benefits: In the event of termination of employment, retirement, death, or disability, all of the participant's vested contributions and earnings thereon will be paid at the participant's option (subject to spousal consent) in a lump-sum distribution. Participants with vested balances less than \$1,000 will receive an automatic lump-sum payment of benefits. Participants with vested accumulated benefits in excess of \$1,000, and who terminate employment prior to age 62, may elect to leave their investment in the Plan.

Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan. Participants may also withdraw an amount at age 59½ if certain criteria are met. There were no significant requests by participants to withdraw their funds that were not paid by year-end at December 31, 2024 and 2023.

Notes Receivable from Participants: Participants may borrow from their account balance a minimum of \$1,000, up to a maximum equal to the lesser of 50% of the participant's vested balance or \$50,000 reduced by the excess, if any, of the participant's highest outstanding balance of loans from the Plan during the one-year period. The loan is secured by the balance in the participant's account. The loan interest rate, determined monthly, is set at 1% above prime rate, as defined. A participant may have a maximum of one loan outstanding at any time. The loans are repaid semi-monthly through payroll deductions. The term of the loan is five years or less, unless the funds are utilized to acquire a principal residence, in which case the administrator may permit a longer repayment term.

Forfeited Accounts: Forfeitures are retained in the Plan and can be used to pay administrative expenses and reduce future employer contributions at the option of the Plan Sponsor. As of December 31, 2024 and 2023, forfeited non-vested accounts were \$48,493 and \$34,854, respectively. In 2024, no forfeitures were used to fund employer contributions.

**NOTE 2 - SUMMARY OF ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investment Valuation and Income Recognition: The investments of the Plan are reported at fair value and are held by Fidelity Management Trust Company (Trustee), the trustee of the Plan. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for a discussion of fair value measurements.

Purchases and sales of the investments within the Plan are reflected on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

The Plan presents, in the statement of changes in net assets available for benefits, the net appreciation in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments.

Payment of Benefits: Benefit payments to participants and beneficiaries are recorded upon distribution.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income from notes receivable is recorded on the accrual basis. No allowance for losses is deemed necessary by Plan management, as principal and interest are repaid through payroll deductions, and the notes are collateralized by the participants' account balances. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. A note receivable is considered to be in default after any scheduled payment remains unpaid beyond the last day of the calendar quarter following the calendar quarter in which the participant missed the scheduled payment.

Use of Estimates: The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Administrative Expenses: All costs and expenses of administering the Plan are borne by the Plan, except that they may be paid by the Plan Sponsor at its discretion. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments. The Plan paid administrative expenses of \$91,914 to the Trustee for the year ended December 31, 2024.

**NOTE 3 - TAX STATUS**

The IRS issued an opinion letter dated June 30, 2020, indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (“IRC”). Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 4 - PLAN TERMINATION**

While the Plan Sponsor has not expressed any intention to terminate or partially terminate the Plan, the Plan Sponsor reserves the right to amend or discontinue the Plan or its contributions at any time, subject to the provisions set forth under ERISA. Upon termination of the Plan, the Plan Sponsor, at its discretion, may elect to terminate the trust agreement. In such event, each affected participant’s individual account balance will become 100% vested and be paid to such participant as soon as practicable, after a determination is made of the value of the participant’s individual account.

**NOTE 5 - PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS**

The Plan, the Plan Sponsor, and the Trustee (Fidelity Management Trust Company or FMTC), are parties-in-interest with respect to the Plan under the provisions of ERISA. Notes receivable from participants also qualify as party-in-interest transactions. Plan investments include shares of registered investment companies and a collective trust fund managed by the Trustee; therefore, these transactions qualify as party-in-interest transactions. Investment-related fees are reflected as an offset of net investment income and are not readily determinable. These transactions, as well as trustee fees, record keeping fees and certain professional fees for the administration of the Plan that were paid either directly or indirectly by the Plan to FMTC or its affiliates represent party-in-interest transactions.

**NOTE 6 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Trustee.

**NOTE 7 - FAIR VALUE MEASUREMENTS**

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs.

The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual Funds: The fair values of mutual funds are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs). The fair values of these investments are based upon the closing net asset value per share of the fund on the day of the valuation as reflected on a national securities exchange.

Collective Trust: The collective trust is valued based on the net asset values per unit as reported by the fund manager. The underlying assets, owned by the collective trust, consist primarily of readily marketable fixed-income securities. The collective trust is valued using the NAV of units of a bank collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. There is no notice period, no redemption fees, and no unfunded commitments.

**NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

**NOTE 10 - LATE REMITTANCES**

As the plan year ended December 31, 2024, prior year, employee withholdings totaling \$2,476,322 including \$209,947 of 2023 were not remitted within the required time frame. These transactions constitute prohibited transactions as defined under ERISA. Of this amount, \$1,595,746 delinquent contributions, along with related lost earnings, were deposited to participant accounts by the Plan Sponsor and are pending submission under the Department of Labor's Voluntary Fiduciary Correction Program (VFCP). The remaining \$880,576 of delinquent employee deferrals, along with the corresponding lost earnings, are in the process of being corrected by the Plan Sponsor. The Plan Sponsor has implemented procedures to ensure that all future participant contributions are remitted within the prescribed time period.
