### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Sunrise Management Company 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Sunrise Management Company 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

**General**

The Plan covers employees of San Diego Sunrise Management Company (the Company) and its affiliates, CloudTen Residential (adopted the Plan effective October 22, 2021), and Property Solutions Group (adopted the Plan effective March 1, 2024). Both affiliates were retroactively admitted to the plan on April 1, 2025. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is the Plan's Sponsor and serves as the Plan Administrator. The Plan Administrator is responsible for oversight of the Plan as well as determining and reviewing the appropriateness of the Plan's investment offerings.

The Plan is a defined contribution plan established under the provision of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC. The Plan became effective on November 1, 1992 and was restated in its entirety effective November 7, 2023. The Company contracted with Empower Annuity Insurance Company of America (EAIC) and its subsidiary Empower Retirement LLC (Empower) to provide Plan recordkeeping and to serve as Custodian of the Plan's assets through January 11, 2023 and Reliance Trust Company thereafter to serve as Trustee and Custodian of the Plan's assets. EAIC will continue to provide Custodial services for the Guaranteed Investment Account held in the Plan, until such time that contract can be terminated. The Company contracted ADP Retirement Services (ADP) to provide recordkeeping and compliance services for the Plan on January 12, 2023. Effective January 1, 2025, the Company contracted with ADP Retirement Trust Services, LLC (ADP Trust), an agent of ADP Retirement Services, to serve as the Custodian and Trustee of the Plan's assets. The president of the Company is the Trustee of the Plan.

**Eligibility**

Generally, an employee is eligible to participate in the Plan upon attaining age 18 and completing one month of service. Plan entry dates are on the first day of the month coinciding with or following the date eligibility requirements are met.

**Participant Contributions**

The Plan provides for an automatic employee deferral contribution at the rate of 3% of pay unless the participant affirmatively elects otherwise. Participants may affirmatively elect a different percentage from 0% to 100% of their annual compensation into a pre-tax deferral account up to the maximum allowed by the Internal Revenue Service (IRS) limitations or, effective November 7, 2023, an after-tax Roth account. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions (rollovers) from other qualified plans.

**Employer Contributions**

The Company may provide for discretionary matching and profit-sharing contributions; however, no such contributions were made or declared for the period presented.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions, (b) plan earnings, and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investments**

Participants direct the investment of all assets attributable to their account. Each participant designates the percentage of any one or more of their accounts that is to be invested in each of several authorized investment funds designated by the Plan's Trustee.

**Notes Receivable from Participants**

The Plan allows participants to borrow against their vested account balances. Loans may not be made for less than \$1,000 and may not exceed the lesser of \$50,000 or 50% of a participant's vested account balance. The interest rate for loans is based on 1 percentage point over the prime interest rate at the date of loan origination. Principal and interest are paid ratably through monthly payroll deductions not to exceed five years unless the note proceeds were used for the purchase of a principal residence. Only one loan can be outstanding at a time for any participant.

**Payment of Benefits**

On termination of service due to death, disability, retirement or termination of employment, a participant may elect to receive a lump-sum amount or paid as a direct rollover to an individual retirement account (IRA) or to another employer's tax qualified plan. Active participants may withdraw any part of their account in a single sum in the event of undue financial hardship or attainment of age 59 1/2. If a terminated participant's account is \$5,000 or less, the Plan may distribute the account balance to an IRA without prior approval of the participant.

**Vesting**

Participants are immediately 100% vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and profit-sharing contribution, if any, is based on years of continuous service. A year of service is obtained upon completing 1,000 hours of service during a year. A participant is vested in the Company's contributions based on the following schedule:

**Forfeited Accounts**

Generally, a participant's unvested portion of the Company's contributions is forfeited upon termination of employment. Forfeitures are maintained in a separate account and can be used to reduce matching contributions or pay Plan expenses.

Non-vested forfeited account balances at December 31, 2024 and 2023 were \$1,813 and \$1,761, respectively. During the year ended December 31, 2024, no forfeitures were used by the Company.

**Administrative Expenses**

Fees related to the administration of loans and distributions are deducted from participant accounts and are included in administrative expenses. All other administrative expenses of the Plan are paid directly by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Certain investment management fees and other charges paid to the Custodian are offset against fund performance in the net appreciation section of the Statement of Changes in Net Assets Available for Benefits and are not, therefore, separately reflected as administrative expenses.

**Plan Termination Provision**

Although the Company has not expressed any intent to do so, it has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants become fully vested in their account balances.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting which is in accordance with accounting principles generally accepted in the United States of America (GAAP). Employee and employer contributions are recognized in the period that contributions are due.

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that may affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments, other than the Guaranteed Interest Account, are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policy utilizing information provided by the Plan Custodian. See Note 3 for discussion of fair value measurements. The Guaranteed Interest Account is fully benefit-responsive; therefore, contract value is the relevant measure for reporting purposes because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded.

**NOTE 3 - FAIR VALUE MEASUREMENT**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level

1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under GAAP are described as follows:

Level 1    Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2    Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3    Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

*Registered investment companies (mutual funds):* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Stable value collective trust:* A stable value fund that is composed primarily of fully benefit-responsive investment contracts and cash equivalents that is valued at the NAV of units of the bank collective trust. The fund is designed to preserve principal and provide stable returns by investing in high-quality fixed income securities and utilizing wrap contracts issued by third-party financial institutions. These wrap contracts provide assurance that participant-initiated withdrawals will be made at contract value. The underlying assets of the fund are owned by the Plan and valued at net asset value (NAV) per unit of the bank collective trust and is structured like mutual fund. The fair value of the fund is determined at the end of each day that markets are open, and the daily value is used for both buying and selling shares of the

**NOTE 4 - GUARANTEED INTEREST ACCOUNT**

The Plan's investment offering included a prior fully-benefit responsive contract fund, Empower Key Guaranteed Portfolio Fund (GIA). Under the terms of the contract, a crediting interest rate is established for amounts invested in the GIA and participants may direct permitted withdrawals and/or transfer transactions of all or a portion of their account balance at contract value. Contract value represents contributions plus credited interest, less participant withdrawals and fees. The declared interest rate at December 31, 2024 was 1.41%. As of December 31, 2024 and 2023, the contract value of the investment in the contract was \$111,822 and \$168,439 respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan) (2) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions; or (3) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

Effective January 12, 2023, the Key Guaranteed Portfolio Fund with Empower was terminated due to change in the recordkeeper and custodian, and the investment option is currently frozen. The remaining funds will be transferred to ADP in installments over 5 years with the last scheduled payment in January 2028.

**NOTE 5 - INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America, Empower Trust Company and Reliance Trust Company, the Trustees and Custodians of the Plan, have certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants reflected on the accompanying Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

The Guaranteed Interest Account (Note 4), is maintained by Empower Annuity Insurance Company, an affiliate of Empower.

**NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Reliance Trust Company on behalf of ADP and Empower Annuity Insurance Company. ADP is the Custodian and Recordkeeper and Empower is the Custodian of all insurance products as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Plan administrative service providers and investment advisor fees are paid by the Plan and are therefore considered exempt party-in-interest transactions.

**NOTE 7 - TAX STATUS**

The IRS has informed the Plan sponsor by a letter dated June 30, 2020 for the prototype plan adopted by the Plan, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investments securities, it is at least reasonably possible that changes in risks in the near term would materially affect
