Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Plan 1081.01(d) de Ashford Presbyterian Community Hospital (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1 - Description of plan

The following description of the Plan 1081.01(d) de Ashford Presbyterian Community Hospital (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established on February 9, 2001 as a defined contribution plan, covering all regular employees of Presbyterian Community Hospital, Inc. (the Plan Sponsor), who have 21 years of age or older and have completed 1 year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and Section 1081.01 of the Puerto Rico Internal Revenue Code (the Code).

Contributions

Each year, participants may contribute an amount of their compensation not exceeding the maximum deferral as specified by local law. Participants may also contribute amounts representing distributions from other qualified plans, subject to the conditions and limitations set forth in the Plan agreement. The Plan's Sponsor makes discretionary matching contributions and contributed 50% of participant contributions up to 1.5% of the participant compensation. The Plan Sponsor may also make profit sharing contributions.

Investments options

The Plan Sponsor's and participants' contributions are invested in various investment funds provided by the Custodian as permitted in the Plan agreement.

Participant accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution and allocations of: (a) the Plan Sponsor's contribution and (b) Plan earnings. Allocations of Plan earnings are based on the participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Plan's Sponsor matching portion of their accounts plus actual earnings thereon is based on years of continuous service since the inception of the Plan.

Notes receivable from participant

Notes receivable from participants are not permitted.

Excess participant's contribution payable

Participants may contribute excess contributions which will be reimbursed to the participants. Excess contributions are recorded as a liability and as a reduction of participant-directed contributions for the year in the Plan's financial statements.

Payments of benefits

On termination of service due to death, disability or retirement, a participant or participant's beneficiaries may elect to receive a distribution equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or periodic installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In addition, the Plan provides for in-service distributions in certain circumstances, including financial hardship withdrawals, subject to certain limitations.

Also, in-service distributions may be available to participants as special disaster distributions, as determined by the Puerto Rico Treasury Department.

Forfeitures

Upon participant's termination from employment or withdrawal from the Plan for any reason other than death, retirement or disability, the Plan Sponsor contributions on behalf of the participants not then vested are forfeited. Forfeitures shall be used to pay Plan expenses, allocate to the participant accounts, or to reduce the Plan Sponsor contribution. At December 31, 2024 and 2023, the forfeitures account balance amounted to \$14,182 and \$24,399, respectively.

Administrative expenses

The Plan Sponsor is responsible for the general administration of the Plan. All administrative fees, to the extent not paid from the Plan's assets, are paid by the Plan Sponsor.

Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become one hundred percent (100%) vested in their accounts.

Note 2 - Summary of significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting and in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Note 2 - Summary of significant accounting policies – (continued)

Investments valuation and income recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded when received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. During the year ended December 31, 2024, the Plan's investments appreciated in value by \$369,357.

Payment of benefits

Benefits are recorded when paid.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Benefits payable

The Plan accounts for benefits payable in accordance with the guidance provided by the American Institute of Certified Public Accounts (AICPA) *Audit and Accounting Guide, Audits of Employee Benefit Plans*. This guidance requires that benefits payable to persons who have withdrawn from participation in a defined contribution plan be disclosed in the notes to the financial statements rather than recorded as liability of the Plan. As of December 31, 2024 and 2023, benefits payable due to participants amounted to nil and \$11,392, respectively.

Note 3 - Information certified by Custodian (unaudited)

The plan administrator has elected the method of compliance permitted by Section 103(a)(3)(C) of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Accordingly, Empower Trust Company, LLC (the Custodian), has certified as to the completeness and accuracy of all investment related information reflected in the accompanying financial statements as of December 31, 2024 and 2023, and for the year ended December 31, 2024, and the related notes to the financial statements, and the schedule H, part IV, line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024. The Custodian maintains all records, executes investment transactions, and holds all the assets of the Plan.

Note 4 - Fair value measurements

In accordance with the provisions of Financial Accounting Standards Board (FASB), Accounting Standards Codification (ASC) No. 820, *Fair Value Measurements*, the Plan uses valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs to the extent possible to estimate fair values.

The Plan determines fair values based on assumptions that market participants would have used in pricing an asset or liability in the principal or most advantageous market.

ASC 820 provides a fair value hierarchy that prioritizes the use of observable inputs in the valuation techniques used to measure fair value, as follows:

Following is a description of the valuation methodologies used by the Plan for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds are valued at the net asset value of shares held by the plan at year end. These investments are classified as Level 1.

Fixed annuities are valued based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider. These investments are classified as Level 2.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Non-exempt transactions

On April 08, 2024, the Plan fully corrected late participant contributions corresponding to the years ended December 31, 2022, and 2021 amounting to \$51,102 and \$54,188, respectively, under the Voluntary Fiduciary Correction Program.

Note 6 - Non-discrimination test

The Plan did not comply with the discrimination test for the years ended December 31, 2024 and 2023. This test requires compliance with a determined percentage of contributions to the Plan as established in Section 1081.01 of the Code. The Plan Sponsor elected to reimburse highly compensated employees the excess contributions made during the years ended December 31, 2024 and 2023, amounting to \$9,152 and \$17,413, respectively. Such participants received the 2024 and 2023 excess contributions in August 2025 and June 2024, respectively.

Excess contributions are recorded as a liability in the accompanying statements of net assets available for benefits.

Note 7 - Tax status

The Plan constitutes a qualified plan exempt from income taxes under the provision of Section 1081.01 of the Puerto Rico Income Tax Code (the Code). The Plan is required to operate in conformity with the Code to maintain its qualification.

The Plan obtained its latest determination letter on August 5, 2016, in which the Commonwealth of Puerto Rico tax authorities stated that the Plan, as then designed, was in compliance with the applicable requirements of the Code.

Management has evaluated the Plan tax position and concluded that the Plan has maintain its tax-exempt status and had a taken no uncertain tax positions that require adjustment to the financial statements.

Note 8 - Subsequent event

The Plan's management evaluated subsequent events through October 4, 2025, which is the date the financial statements were available to be issued. Except as described in Note 6, no other events have occurred subsequent to the statement of net assets available for benefits date and to the date the financial statements were available to be issued, that would require adjustment to, or disclosure in, the financial statements.
