NOTE A -- SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of A&B Packing 401(k) Plan (the Plan) are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

The annual change in the difference between the fair value and cost of investments held is combined with realized gains and losses on sales of investments and is reported in the statements of changes in net assets available for benefits as net appreciation or depreciation in the fair value of investments. Realized gains and losses on sales of investments represent the difference between the proceeds received and the original cost of investments sold.

Use of Estimates: The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits: Benefits are recorded when paid.

Expenses: Substantially all operating expenses of the Plan are paid by the Company and are therefore excluded from these financial statements. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

Date of Management's Review: Subsequent events were evaluated through the date of the report, which is the date the financial statements were available to be issued.

NOTE B -- DESCRIPTION OF THE PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of A&B Packing Equipment, Inc. (the Company) who have completed 90 days of service as defined by the Plan and are age 18 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Administration: The Plan is administered by A&B Packing Equipment, Inc. (the Company). Information about the plan agreement, participant investment alternatives, and the vesting and benefit provisions is available from the Company.

Contributions: Participants may elect to contribute a portion of their compensation, as defined in the Plan, which is not greater than the maximum annual amount allowed by the Internal Revenue Code. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate. Effective October 26, 2024, the default deferral rate is set at 4% of eligible compensation and is automatically increased by 1% annually, up to a maximum of 6%, unless the participant elects a different deferral percentage. The default deferral rate was previously set at 3% of eligible compensation with automatic increases of 1% annually, up to a maximum of 4%, unless a different deferral percentage was elected by the participant. The Company matches 100% of employee contributions, up to 4% of compensation that a participant contributed to the Plan. .

The Company may also make a profit-sharing contribution as determined solely at the discretion of the Company. No profit-sharing contribution was made for 2024 or 2023.

Participants may also contribute amounts representing distributions from other qualified retirement plans.

Investment Options: Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various investment options. Contributions are automatically invested in a designated balanced fund unless changed by the participant. The net investment income or loss attributable to each investment fund is allocated to individual participant accounts on a daily basis by the custodian.

Payment of Benefits: Account balances of terminated participants may be distributed in accordance with plan provisions at the discretion of the employee.

Forfeited Accounts: During the years ended December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0.

NOTE B -- DESCRIPTION OF THE PLAN--(Continued)

Participant accounts: Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and Plan earnings, or losses, and charged with an allocation of any administrative expenses paid by the Plan, in accordance with the terms of the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions and employer matching contributions plus actual earnings thereon. Vesting in the Company's discretionary or other contributions, if any, is based on years of eligible service. A participant is 100% vested in any employer discretionary or other contributions after three years of eligible service.

Notes Receivable from Participants: The Plan was amended effective August 20, 2024 to allow participants to obtain loans based on their vested balances. Prior to this amendment, loans to participants were not permitted. Loan amounts are restricted by Internal Revenue Service (IRS) guidelines. The notes are secured by the balance in the participant's account and bear interest based on prevailing rates as determined by the Plan. Principal and interest is paid ratably through payroll deductions.

NOTE C -- FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs would be used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are considered to be actively traded. The fair value of pooled separate accounts and collective investments trusts are based on quoted pricing inputs of the underlying investments which are used in determining the net asset value (NAV) of the pooled separate accounts and collective investment trusts. The NAV is the basis for current transactions and the pooled separate accounts and collective investment trusts can be redeemed at NAV as of the measurement date. Pooled separate accounts typically can be redeemed on a daily basis, without restriction.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023, are reported in net appreciation (depreciation) in fair value of investments.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no transfers between Levels 1 and 2 and no transfers into or out of Level 3.

NOTE D -- TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt. The Plan currently has no audits for any tax periods in process and has not taken any uncertain positions.

NOTE E -- PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

NOTE F -- RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are funds managed by Principal Financial Group. Principal Financial Group is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the trustee for administrative services amounted to \$11,023 and \$11,077 for the years ended December 31, 2024 and 2023, respectively.

The Plan is administered by the Company. Certain administrative functions are performed by the officers and employees of the Company. No such officer or employee receives compensation from the Plan. Fees incurred for legal, accounting and administrative services rendered by parties-in-interest were based on customary and reasonable rates for such services. All legal and accounting fees were paid by the Company on behalf of the Plan.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
