**NOTES TO FINANCIAL STATEMENTS**

**December 31, 2024 and 2023**

**NOTE 1 - PLAN DESCRIPTION**

The following description of the ADT Security Corporation Retirement Savings and Investment Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan and is available to certain salaried, union, and non-union hourly employees of The ADT Security Corporation (formerly named The ADT Corporation) (“ADT”, “Company” or “Employer”), upon their date of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”) and the Internal Revenue Code of 1986, as amended (the “IRC”).

The Plan is a successor to and continuation of the portion of the Tyco International Retirement Savings and Investment Plan (the “Tyco Plan”) representing the assets and liabilities of participants whose employment was transferred to the Company together with such assets and liabilities of participants who are former employees designated by Tyco (now known as Tyco Integrated Security, a subsidiary of Johnson Controls) as employees employed in the ADT North American residential security business. The Plan was spun off from the Tyco Plan effective September 28, 2012. Effective September 28, 2012, ADT LLC, a wholly-owned subsidiary of the Company, became the Plan Sponsor of the Plan.

On May 2, 2016, the Company became an indirect wholly-owned subsidiary of ADT Inc. ADT Inc. is majority owned by Prime Security Services TopCo Parent, L.P. (“Ultimate Parent”). Ultimate Parent is majority owned by Apollo Investment Fund VIII, L.P. (“Apollo”) and its related funds that are directly or indirectly managed by affiliates of Apollo Global Management, Inc. As of March 2024, Apollo owns less than 50% of ADT Inc. stock.

Effective January 1, 2022, the Plan was amended to change the employer matching contribution formula where the employer will make an additional 50% employer contribution on the first 5% of eligible compensation deferred for those participants who are actively employed as of the last day of the Plan year or who retire or die during the Plan year.

Effective May 1, 2023, the Plan was amended to include certain provisions under the Setting Every Community Up for Retirement Enhancement Act (the “SECURE Act”) to reflect required minimum distributions based on the attainment of age 73 (previously age 72) and permit interns to participate in the Plan effective January 1, 2024 to comply with the long-term part time participation requirements pursuant to the SECURE 2.0 Act.

Effective October 2, 2023, the Plan was amended as follows: a) the Company divested its commercial business (the “Commercial Business”) (the “Commercial Divestiture”). Following the Commercial Divestiture, the Plan became a multiple employer plan due to the Commercial Business’ continued participation in the Plan, b) participants who transferred out of the Plan in connection with the Commercial Divestiture became 100% vested in ADT LLC earned employer match under the Plan, c) removed the requirement which states that participants must attain the age of 18 prior to be eligible in the Plan, d) extended the exemption for pre-death Required Minimum Distributions (“RMDs”) for Roth, and e) allowed surviving spousal beneficiaries of deceased participants to opt for RMD rules as if they were the deceased participant. During the year ended December 31, 2024, \$392,535,798 was transferred out of the Plan to other qualified plans in connection with the Commercial Divestiture.

***Contributions***

Each year, participants may contribute a percentage of their eligible compensation up to a specified amount, on a before-tax, Roth, and/or after-tax basis, subject to certain limitations as specified by the IRC. The Plan also provides for catch-up contributions for participants who reach the age of 50 by the end of the Plan year. Certain participant contributions are eligible to receive matching employer contributions. The Company provides a matching contribution of 50% on the first 5% of eligible compensation a participant contributes to the Plan and an equal discretionary matching contribution is posted after year-end if certain eligibility requirements are met. Discretionary employer contributions of \$15,361,450 and \$23,697,644 were made to eligible contributing participants of the Plan for the years ended December 31, 2024 and 2023, respectively. These amounts are included in employer contribution receivables in the statements of net assets available for benefits as of December 31, 2024 and 2023.

***Participant Accounts***

Each participant's account is credited and/or debited with the participant's contributions, employer contributions, and a proportionate share of Plan earnings/losses, investment fees, and any other administrative expenses paid out of the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

***Retirement, Death or Disability***

An employed participant is entitled to 100% of his or her account balance upon attainment of age 55 or upon death, or disability.

***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the remainder of their accounts, plus earnings thereon, is based on years of service. Participants are fully vested in all employer contributions following completion of three years of continuous service. Employer contributions associated with employees of merged plans will vest according to the respective pre-merger plan documents.

***Payment of Benefits***

Upon termination of service, death, disability, or retirement, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, in accordance with the plan document.

***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Principal and interest are paid through payroll deductions. Participants are allowed a maximum of two outstanding loans at any time.

***Forfeitures***

Forfeitures of employer contributions are used to offset future employer contributions or administrative expenses of the Plan. The balances of forfeitures available to offset future employer contributions and administrative expenses as of December 31, 2024 and 2023 were \$287,582 and \$516,629, respectively. Total forfeitures used to reduce employer contributions and administrative expenses for the year ended December 31, 2024 were \$2,787,928.

***Administrative Expenses***

The Plan's trustee expenses, service charges, audit fees, and certain administrative fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Origination fees and fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Expenses that are paid directly by the Company are excluded from these financial statements.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect amounts reported in the financial statements and the accompanying notes. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net realized and unrealized appreciation (depreciation) in fair value of investments includes the Plan's gains (losses) on investments bought and sold as well as held during the year. Certain investment transaction fees are offset against interest and dividend income.

***Notes Receivable from Participants***

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. The notes receivable from participants do not have an allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan agreement.

***Payment of Benefits***

Benefits are recorded when paid.

***Risks and Uncertainties***

The Plan provides options to investments in a variety of securities. Securities, in general, are exposed to various market risks, such as interest rate, liquidity, and credit risks. Due to the level of risk and uncertainty associated with securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**NOTE 3 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions and earnings thereon.

**NOTE 4 - CERTIFIED INVESTMENTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments, at fair value and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivables from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the trustee for the Plan ("Trustee").

**NOTE 5 - FAIR VALUE MEASUREMENTS**

U.S. GAAP provides the framework for a fair value hierarchy used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, Level 1, and the lowest priority to unobservable inputs, Level 3.

The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and require significant management judgement or estimate for the fair value measurement.

A financial instrument's level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. As of December 31, 2024, there have been no changes in the methodologies used since the year ended December 31, 2023.

***Mutual Funds***

The fair values of mutual fund investments are considered Level 1 measurements as they are determined by obtaining quoted prices on nationally recognized securities exchanges.

***Collective Trusts***

The fair values of participation units held in collective trusts are based on the net asset value (“NAV”) reported by the fund managers as of the financial statement dates and recent transaction prices. Each collective trust provides for daily redemptions by the Plan at reported NAV per share with no advance notice requirements. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. There are no unfunded commitments.

The methodologies described above may produce a fair value measurement that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 6 - PARTIES-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer, and certain others. Certain investments of the Plan are managed by the Trustee, through Fidelity Investments and Fidelity Institutional Asset Management Trust Company. As described in Note 1, the Plan paid certain administrative expenses related to plan operations and investment activity to various service providers. These transactions, as well as notes receivable from participants, are parties-in-interest transactions under ERISA.

**NOTE 7 - TAX STATUS**

The Internal Revenue Service ("IRS") has determined and informed the Plan by a letter dated April 24, 2017 that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC. Plan management evaluates tax positions taken by the Plan and recognizes a tax asset or liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. As of December 31, 2024 and 2023, no uncertain tax positions have been taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 - SUBSEQUENT EVENTS**

Management has evaluated subsequent events for recognition and disclosure through October 14, 2025, which is the date the financial statements were available to be issued, and determined that there were no circumstances that warranted recognition or disclosure in the financial statements as of December 31, 2024.
