To the Plan Administrator and Participants

Littleton Regional Healthcare Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Littleton Regional Healthcare Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Littleton Regional Healthcare Retirement Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedules, other than that agreed to or derived the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Notes to Financial Statements

1. Description of Plan

The following description of Littleton Regional Healthcare Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan's document and adoption agreement for more information.

General

The Plan is a defined contribution plan sponsored by Littleton Regional Healthcare (Organization). The Plan is available to all employees except students and non-resident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 as amended (ERISA). Principal Life Insurance Company (Principal) is the recordkeeper and custodian of the Plan.

Contributions

Participants may contribute up to 100 percent of pretax annual compensation, as defined by the Plan, subject to certain Internal Revenue Code (IRC) limitations. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers several mutual funds and a group annuity contract as investment options for participants. Participants who are over age 50 may take additional pre-tax "catch-up" contributions pursuant to the IRC limitations. In addition, participant contributions may consist of transfers from other qualified retirement plans.

The Plan has an automatic enrollment feature which provides that newly eligible employees who do not affirmatively elect either to participate in the Plan, or decline participation in the Plan, will automatically be enrolled in the Plan, and will defer 3% of their eligible compensation into the Plan.

After a year of service and obtaining the age of 18 years old, as defined by the Plan, the Organization contributes matching contributions of fifty percent (50%) of the participant contributions up to six percent (6%) of compensation. In addition, the organization may make discretionary contributions. For the year ended December 31, 2024, the Organization did not make discretionary contributions.

Littleton Regional Healthcare Retirement Plan

Notes to Financial Statements (Continued)

1. Description of Plan (continued)

Vesting

Participants are vested immediately in their employee elective contributions into the Plan. Vesting in the Organization's contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after two years of credited service.

Distributions

Participants are entitled to a distribution following severance of employment as soon as administratively practical following severance, with the exception of financial hardship withdrawals which are payable immediately. Benefits may be distributed to participants upon severance of employment by reason of retirement, disability, death or other separation from service. Benefits may be paid in a lump sum or in installments.

The Plan allows for age 59 ½ withdrawals and hardship withdrawals, as defined in applicable regulations.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Organization contributions, if any, and plan earnings or losses, and is charged with an allocation of administrative expenses, as applicable. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, or up to ten years for the purchase of a primary residence. The loans are secured by the balance in the participant's account, and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably via payroll deductions.

Notes to Financial Statements (Continued)

1. Description of Plan (continued)

If the loan is not repaid, it will automatically be treated as a distribution to the participant after three months. Interest rates on outstanding loans at December 31, 2024 and 2023 ranged from 4.25% to 9.50% with various maturities through August 2031.

Forfeitures

Forfeited balances are used to reduce future company contributions or pay plan expenses. Forfeitures that have not been used to pay administrative expenses or used to reduce employer contributions shall be allocated to participants as of the last day of the Plan year. There were no unallocated forfeiture balances as of December 31, 2024 and 2023. For the year ended December 31, 2024, the organization used forfeitures of \$12,226 to pay administrative expenses and \$34,382 to reduce employer contributions.

Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, participants will become 100 percent vested in their accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis in accordance with U.S. generally accepted accounting principles.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts in the financial statements and accompanying notes and supplemental schedules. Actual results could differ from those estimates.

Littleton Regional Healthcare Retirement Plan

Notes to Financial Statements (Continued)

2. Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition

Investments are stated at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The group fixed annuity contract is stated at contract value (see Note 4).

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Organization. Administrative expenses paid by the Plan include record keeping and custodian fees. Certain fees incurred by the Plan are included in net depreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

Payment of Benefits

Benefits payments to participants are recorded upon distribution.

Subsequent Events

Management has considered transactions or events occurring through October 14, 2025, which is the date that the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

3. Information Prepared and Certified by Custodian

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedules, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, dividends and interest income on notes receivable from participants for the year ended December 31, 2024 was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Principal Trust Company and Lincoln National Life Insurance Company.

4. Investment Contract with Insurance Company

The Plan's Lincoln Financial Group stable value option with Lincoln National Life Insurance Company met the fully benefit-responsive investment criteria and, therefore are reported at contract value. Contract value, as reported to the Plan by the custodian, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There is no reserve against contract value for credit risk of the contract issuer or otherwise.

The issuer, Lincoln National Life Insurance Company, maintains the contributions to the Lincoln Group Stable Value Fund. The account is credited with participant contributions plus earnings and charged for participant withdrawals and administrative expenses. The issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 1%. Such interest rates are reviewed and may be reset on a quarterly basis.

Certain events limit the ability of the Plan to transact at contract value with the insurance company under the group annuity contract. Such events include (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures, or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the Trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such events that would limit the Plan's ability to transact at contract value with participants is probable.

Notes to Financial Statements (Continued)

5. Fair Value Measurement

FASB ASC Topic 820, Fair Value Measurement, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means;
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

Notes to Financial Statements (Continued)

5. Fair Value Measurement (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair measurement at the reporting date.

6. Income Tax Status

On March 31, 2017, Principal Life Insurance Company Prototype Non-standardized 403(b) Plan received a favorable opinion letter in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (Code). The Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Plan management has indicated that it will take the necessary steps, if any, to bring the Plan's operations into compliance with the Code.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Parties-in-interest and Related Parties

Certain administrative expenses are included in net depreciation in fair value of investments on the statement of changes in net assets available for benefits, as they are paid through revenue sharing, rather than direct payment. In addition, loans to participants qualify as party-in-interest transactions. Other direct administrative expenses charged to the Plan for the year ended December 31, 2024 totaled \$95,256.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

9. Other Employer Contribution Receivable

In 2022, it was determined that the Plan was not operating in accordance with the Plan adoption agreement as it relates to the definition of Plan compensation. Accordingly, the Plan Sponsor calculated and recorded other employer contribution receivable to correct the operational failures. Other employer contributions receivable total \$16,543 at December 31, 2022. In 2023, it was determined that the Plan missed a participant's deferral election. Accordingly, the Plan Sponsor calculated and recorded other employer contribution receivable to correct the missed deferral and employer matching contributions totaling approximately \$30,000 at December 31, 2023.

10. Late Contributions

The Company failed to remit timely to the Plan's trustee certain employee contributions and loan payments totaling \$133,230 and \$10,828, for the years ended December 31, 2024 and 2023, respectively. The late contributions for the year ended December 31, 2023 were fully corrected. The Company will make contributions to the affected participants' accounts to compensate those participants for the lost investment income due to the delays with the late contributions for the year ended December 31, 2024.
