Opinion

NOTE 1 - DESCRIPTION OF THE PLAN

The Southern California Glaziers, Architectural Metal and Glass Workers Health and Welfare Plan (the "Plan") is a multiemployer welfare benefit plan providing medical, dental, vision, life, accidental death and dismemberment, disability and vacation benefits to eligible participants and their dependents. Except for disability and vacation benefits, all benefits are funded by insurance contracts or are provided by contracts with prepaid health plans. Disability benefits are provided to eligible participants on a self-insured basis. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Active participants are eligible for those benefits specified in their collective bargaining agreement. Dependents of certain eligible active participants are also eligible to receive certain benefits. Retired participants covered under the eligibility rules for retired participants and their dependents are eligible for limited benefits under the Plan if the requirements set forth for participation are met and upon payment of the full cost of their benefit. Retired participants and their dependents who are eligible for Medicare coverage must join Medicare.

The Plan documents include detailed rules for each situation. Participants should refer to the Plan agreement and any amendments regarding specific provisions of the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan were prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Contributions

Employer contributions as reported are contributions made by employers on behalf of employees for health and vacation hours worked during the year. Employer contributions receivable is estimated based on contributions received subsequent to the end of the year. No allowance is provided for estimated uncollectible accounts.

Retiree, employee and COBRA self-payments are reported on the financial statements on the accrual basis and represent monthly contributions from participants for coverage during the year.

D. Employer Compliance Examination Program

Employer remittance reports were accepted as submitted, without examination or verification of employers' payroll records. The system of internal control provides for examination of employers' records under a separate employer compliance examination program.

E. Investment Valuation and Income Recognition

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs are generally unobservable and typically reflects management estimates and assumptions that market participants would use in pricing the asset or liability.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The valuation methodology used for mutual fund investments is the closing price reported on the active markets in which the mutual funds are traded.

The non-lending common trust fund is valued at the net asset value (“NAV”) of shares held by the Plan at year end.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Fund seeks an investment return to approximate a custom index, comprised of 10% Dow Jones U.S. Select REIT IndexSM, 25% Bloomberg Roll Select Commodity IndexSM, 25% S&P Global LargeMidCap Commodity and Resources Index, 20% Bloomberg Barclays US Government Inflation-Linked 1-10 Year Bond Index, and 20% S&P Global Infrastructure Index.

Purchases and sales of securities are recorded on the trade date basis. Dividends are recorded on the ex-dividend date and interest income is recorded on the accrual basis. Realized and unrealized gains and losses are computed using investments' carry values for financial statement purposes. For Form 5500 reporting, realized and unrealized gains and losses are computed using investments' market values as of the beginning of the year.

F. Tax-Exempt Status

No provision for federal or state income tax has been made. The Plan has received tax-exempt status from the federal government under Internal Revenue Code Section 501(c)(9) and the state of California under Revenue and Taxation Code Section 23701i.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

G. Administration

Pacific Southwest Administrators (“PSWA”) serves as the contract administrator of the Plan for a monthly fee of \$9.86 per reported participant. Effective January 1, 2024, the monthly fee increased to \$10.35 per reported participant.

H. Transactions with Related Trusts

Through a lockbox system, the Plan collects employer remittances to the Plan and other related organizations, and transmits to those organizations, the amounts collected on their behalf.

Total benefits per the financial statements are premiums and claims paid during the year. Total benefits per the Form 5500 is the total of premiums for coverage during the year, claims incurred during the year, and the increase or decrease in the estimated cost to provide future benefits for participants, dependents and beneficiaries.

NOTE 4 - RISKS AND UNCERTAINTIES

Plan investments are exposed to various risks such as interest rate, market fluctuations, and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

NOTE 5 - UNAPPLIED CONTRIBUTIONS

The balances of unapplied contributions as of December 31, 2024 and 2023 totaling \$1,447,898 and \$1,156,821, respectively, are pending future allocations and distributions.

NOTE 6 - CONCENTRATION OF CREDIT RISK

The Plan maintains cash accounts at a financial institution which exceeded the Federal Deposit Insurance Corporation limit of \$250,000 per institution. The amount in excess of the limit was subject to risk if the financial institution did not perform. These accounts include the lockbox account which holds contributions from other Trusts that are distributed at the beginning of the following month and accounts for the excess amount of funds in the account at the end of the month. The Plan has not incurred any losses on the uninsured balance.

NOTE 7 - PLAN TERMINATION

Except as may be otherwise provided by law, in the event of termination of Agreement and Declaration of Trust, the Plan provides that any and all monies remaining after payment of all expenses and obligations shall be expended and used for the continuance of purposes of the Plan until such monies are exhausted.

NOTE 8 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 12, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.



