NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following brief description of the Masonic Care Community of NY 403(b) Retirement Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan available to all employees of the Masonic Care Community of NY (the Company). The Plan is administered by management who is appointed by authorized officers of the Company. Hand Benefits and Trust Company (Hand) is the custodian of the Plan's assets. Benefit Plans Administrative Services, LLC is the Plan's third-party administrator and provides recordkeeping services to the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established with an effective date of January 1, 2011.

Eligibility

All employees of the Company are eligible to participate in the Plan. An employee is eligible to begin salary deferrals upon his or her first day of employment. Only non-union employees are eligible to receive employer discretionary and employer matching contributions. These participants become eligible to receive employer discretionary and employer matching contributions upon completion of 1,000 hours of service within a consecutive 12-month period, the attainment of 21 years of age, and contingent on withdrawing from the Masonic Hall & Asylum Retirement Fund Plan, which was frozen in October 2010, effective January 1, 2011.

Effective November 15, 2021, full-time and part-time union employees were admitted into the plan. Company contributions for newly hired employees will be from the first hour worked. If the newly-hired employee continues employment after a 350-hour probationary period, assuming the new employee is otherwise eligible; contributions will be received for all hours paid up to 1,950 hours annually. In the event that the newly hired employee does not continue employment after the 350-hour probationary period, contributions will be forfeited by the employee. Part-time union employees must work a minimum 240 hours each quarter to receive contributions for that quarter.

Contributions

Active participants may make voluntary contributions in the form of salary deferrals at a maximum contribution of the lesser of 100% of the participant's total compensation for the plan year or the maximum amount permitted by Section 415(d) of the Internal Revenue Code (IRC) and any applicable rollovers from other qualified plans, subject to certain limitations of the Plan and the IRC under Section 403(b). Eligible participants, who attain the age of 50 before the end of the plan year, are eligible to make catch-up contributions, subject to certain limitations of the IRC.

The Company makes matching contributions for all non-union eligible employees of 50% of their elective participant contribution, up to a maximum of 3%. The Company may also make additional discretionary contributions to the Plan. In 2024 and 2023, the Company contributed 2% of eligible compensation for all non-union eligible employees.

1. DESCRIPTION OF PLAN (Continued)

Contributions (Continued)

Effective November 15, 2021, the Company makes bi-weekly contributions to the Plan on behalf of full-time union employees at the rate of seventy-five cents effective January 1, 2023 and eighty cents effective January 1, 2024. Part-time union employees will receive contributions at this rate for each calendar quarter in which the employee has been paid for at least 240 hours.

Participant Accounts

Each participant's account is credited with the participant's contributions, employer contributions, and Plan earnings (losses) on all investments and charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Non-union participants are fully vested in their contributions, and actual earnings thereon, immediately upon participation in the Plan. Contributions made through employer matching and discretionary contributions and the earnings (losses) thereon vest at a rate of 20% per year beginning with completion of the second year of service, with full vesting occurring after six years of service.

Union employees will be vested in the Plan once they have completed 750 hours of service in a calendar year. Generally, an hour of service is an hour that an employee works in employment for which a contribution to this plan is required. Employer contributions are subject to a 5-year graded schedule with 20% vesting per year.

Notes Receivable from Participants

Participants are permitted to borrow a minimum of \$1,000 from their individual accounts up to the lesser of \$50,000 or 50% of their vested balance. The term of the loan may not exceed 5 years, unless the loan shall be used for the purpose of acquiring a primary residence for the participant, in which case the maximum term of the loan is 25 years. The loans are collateralized by the vested balance in the participant's account and bear interest at the prime rate plus 1%, fixed at the time of the loan. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Participants are generally able to receive distributions of their vested benefits upon termination of employment, retirement, or due to death or disability. Additionally, the Plan provides for in-service withdrawals once a participant has reached the age of 59 ½, even if still employed. The Plan also provides for minimum distributions once a participant reaches age 73.

Hardship Withdrawals

Hardship withdrawals from the Plan are permitted from a participant's account. All hardship withdrawals must comply with the rules relating to hardships, which are uniformly applicable to all participants.

Participant Rollovers

Participants are allowed to transfer or rollover funds into the Plan from other qualified plans subject to approval by the plan administrator.

1. DESCRIPTION OF PLAN (Continued)

Administrative Expenses

A majority of the administrative expenses of the Plan are paid by the Company, however management fees and operating expenses charged to the Plan for investments are paid for by the Plan.

Forfeitures

Forfeitures of non-vested account balances are used to reduce employer contributions to the Plan or pay administrative expenses of the Plan. For the years ended December 31, 2024 and 2023, discretionary employer contributions were reduced by forfeitures of \$17,136 and \$79,855, respectively. At December 31, 2024 and 2023, unapplied forfeitures were \$70,307 and \$16,790, respectively. No amounts were used to reduce administrative expenses during 2024 and 2023.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investments

Investments are reported at fair value except those at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. All investments are participant directed.

The Plan's mutual funds are stated at fair value.

The Plan invests in a MetLife Stable Value Fund which holds fully benefit responsive investment contracts which are provided under a group annuity contract. Assets are invested in a MetLife separate account with guaranteed principal and accrued interest, based on credited interest rates, for participant-initiated withdrawals as long as the contract remains active. These investments are stated at contract value.

Risks and Uncertainties

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is possible that changes in their values could occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the financial statements.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value Measurement - Definition and Hierarchy

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

The assets or liabilities fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Allowance for Credit Losses

The Plan records a receivable for the employer contribution that is remitted to the Plan subsequent to the Plan's year end. The Plan recognizes an expected allowance for credit losses that is updated to reflect any changes in credit risk since the receivable was initially recorded. The estimated allowance for credit losses is based on historical, current, and expected future conditions. The Plan has not experienced any historical credit losses relative to contributions receivable. Current and future economic conditions are not expected to change relative to historical financial information and the full amount outstanding was received subsequent to year end. Therefore, management has determined that no allowance for credit losses is necessary as of December 31, 2024 and 2023.

Benefit Payments

Benefit payments are recorded when paid.

Estimates

The preparation of financial statements in accordance with GAAP requires the plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

The Plan's MetLife Stable Value Fund (the Fund) invests in benefit responsive investment contracts with MetLife provided under a group annuity contract. Assets are invested in a MetLife separate account comprised of fixed income securities such as US Governmental Agencies and Treasuries, mortgages, asset backed securities, corporate debt and cash equivalents. MetLife guarantees principal and accrued interest, based on credited interest rates, for participant-initiated withdrawals as long as the contract remains active. Interest is credited to the contract at interest rates that reflect the performance of the underlying portfolio. Upon suspension of the contract and the receipt of written instructions, MetLife will withdraw the contract's balance in the fund and pay such balance as directed.

Because the Fund's investment in guaranteed investment contracts is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Therefore, the guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported by MetLife, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents, including complete or partial Plan termination or merger with another plan or (2) bankruptcy of the plan sponsor. The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

6. PLAN TERMINATION

Although the Company has not expressed any intent to do so, it has the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, each participant's account will become fully vested.

7. INCOME TAX STATUS

The Plan has been established using a volume submitter plan designed and maintained by the Plan's third-party administrator. The IRS has determined and informed the volume submitter sponsor by a letter dated March 31, 2017, that the volume submitter plan is designed in accordance with applicable sections of the Code. The Plan has been amended since receiving the determination letter; however, the plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the Code.

8. PARTY-IN-INTEREST TRANSACTIONS

Hand is the custodian of the Plan's assets. As such, transactions between Hand and the Plan qualify as party-in-interest transactions. Additionally, transactions involving notes receivable from participants qualify as party-in-interest transactions.

9. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

Certain items have been classified differently between the financial statements and Form 5500. Net assets available for benefits and changes in net assets available for benefits per the financial statements agreed to Form 5500 in total as of and for the years ended December 31, 2024 and 2023.

10. SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued.
