Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements

We have performed audits of the financial statements of GLS Industries, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

1. Plan Description and Summary of Significant Accounting Policies

The following description of the GLS Industries, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering substantially all employees (other than collectively bargained, non-resident alien and leased employees) of GLS Industries, Inc., Rockwood Retaining Walls, Inc., Alliance Concrete Concepts, Inc., Equipment, Inc., Mid-Atlantic Concrete Products, Inc., Silver Creek Stoneworks, Inc., Rockwood Retaining Walls Manufacturing, Inc., Mortarless Systems Engineering, Inc., Rochester Concrete Products, LLC., South Atlantic Concrete Products, LLC., and Interlock Concrete Products, Inc. (collectively, the Company). The Plan became effective July 1, 1996, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Most recently, the Plan was amended for the 2024 Plan year to change the age requirement for participation in employer contributions from age 21 to age 18.

Administration - The Plan is administered by GLS Industries, Inc. and advised by a committee whose members are appointed by the Board of Directors of GLS Industries, Inc. The Custodians of the Plan's assets are Reliance Trust Company and Principal Life Insurance Company (the Custodians). The Custodians execute transactions based upon direction from the Plan's administrator and the Plan's participants.

Participation – To be eligible to make salary deferrals to the Plan, employees are immediately eligible with no age or service requirements. For all other aspects of the Plan, employees are eligible after one year of service (as defined in the plan document) and attaining age 18. Entry dates begin on the first day of the month on or after the completion of the initial requirements.

Contributions – Contributions to the Plan include salary reduction, rollover contributions, and catch-up contributions authorized by participants, and matching and profit sharing (if any) contributions made by the Plan Sponsor.

Participant salary reduction contributions are initially set up through an automatic contribution arrangement. The automatic contribution arrangement begins with salary reduction contributions of 4%, with automatic, annual increases of 2% up to a maximum automatic contribution percentage of 10%. Participants are allowed to make an election to "opt out" of the automatic contribution arrangement if they prefer to set up their own contribution arrangement. Participant salary reduction contributions are allowed up to 90% of compensation and may be made on a pre-tax or post-tax (Roth) basis.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

1. Plan Description and Summary of Significant Accounting Policies (Continued)

Contributions (continued) - The Company makes matching contributions to the Plan for participants who are eighteen years of age and who have completed one year of service (one thousand hours) with the Company. For the years ended December 31, 2024 and 2023, the Plan matched 50 percent of employee elective deferrals up to the first 6 percent of eligible wages. Matching contributions totaled \$202,882 and \$181,486 for 2024 and 2023, respectively.

Participant Accounts - Each participant's account is updated to include the participant's contribution and an allocation of (a) the Plan Sponsor's contributions, (b) plan earnings (losses), and (c) plan expenses, as applicable. The Plan uses a daily valuation system for each participant's individually-directed account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

The Plan provides for participants to direct the funds in which their account balances are invested. The participants' funds are invested in various common collective trust funds, mutual funds, and pooled separate accounts held by the Custodians.

Vesting - Full vesting rights are achieved for matching and employer discretionary contributions after six years of service. Participants are fully vested at all times in all other contributions. Participants vest in employer matching and discretionary contributions as follows:

Benefits - On termination of service, disability, death, retirement, reaching normal retirement age or reaching age 59 1/2, participants or their beneficiaries, as applicable, are eligible to receive a distribution in an amount equal to their vested account balance. If the participants' vested account balance is less than \$5,000, the Plan will distribute their vested account balance in a lump-sum payment or roll the balance over to an IRA set up for the benefit of the participant with or without the participant's authorization. If the participants' vested account balance exceeds \$5,000, the participant may elect to take a lump-sum distribution, distribute their account balance in substantially equal amounts, take distributions in the form of partial withdrawals, or to leave their vested balance in the Plan. Participants are also able to take a hardship distribution from their vested account balance in an amount not to exceed the participant's financial hardship, as defined by the Plan document.

1. Plan Description and Summary of Significant Accounting Policies (Continued)

Plan Termination - Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

Basis of Accounting

The financial statements are prepared on the accrual basis from the financial records supplied by Reliance Trust Company and Principal Life Insurance Company.

Employer contributions are recorded as receivable at the time of their approval by the Board of Directors of the Company. Employee contributions are recorded as receivable as soon as the contributions can be isolated from the general assets of the company and before they have been received by the Plan.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion on fair value measurements.

All purchases and sales of securities have been recorded on a trade-date basis. Income is recorded as earned. The increase or decrease in the fair value of investments represents the net difference between the current value of securities held at the beginning of the year or cost of securities purchased during the year and the current value of securities held at the end of the year.

Notes Receivable from Participants

The plan does not allow for participants to borrow from their fund accounts.

Benefit Payment

Benefit payments are recorded upon distribution to participants.

Expenses

Expenses of maintaining the Plan are paid by the Plan Sponsor and the Plan. Administrative expenses paid by the Plan are included in the statement of changes in net assets available for benefits.

Forfeitures

Forfeited nonvested amounts can be used to pay administrative expenses of the Plan or to reduce employer matching contributions. Forfeited, non-vested accounts had a \$11 balance at December 31, 2023 and a \$20 balance at December 31, 2024. Forfeitures during 2024 and 2023 totaled \$9,619 and \$13,193, respectively. During 2024, forfeited non-vested accounts in the amount of \$9,614 were used to reduce employer matching contributions. During 2023, forfeited non-vested accounts in the amount of \$13,194 were used to reduce employer matching contributions.

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Reclassifications

Certain amounts presented in the prior year have been reclassified in order to be consistent with the current year's presentation.

2. Financial Information Certified by the Custodian

Reliance Trust Company and Principal Life Insurance Company (the Custodians) have provided the Plan Administrator with certifications as to the completeness and accuracy of total investments for participants of the Plan held by the Custodians aggregating \$12,805,121 and \$10,872,667 as of December 31, 2024 and 2023, respectively, and the related total investment income of \$1,614,974 and \$1,683,456, respectively, for the years then ended. Such amounts and all related financial data are included in the accompanying financial statements and supplemental schedule of the Plan based on such certifications from the Custodians.

Under the terms of the Custodian agreements, the Custodians have non-discretionary authority over Plan assets and maintain investment funds on behalf of the Plan. The Custodians have been granted authority to make purchases and sales of investments at the direction of the Plan Sponsor and plan participants and maintain records of all participant and Plan transactions and accounts.

3. Fair Value Measurements

Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Observable market-based inputs or unobserved inputs that are corroborated by market-data. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

3. Fair Value Measurements (Continued)

The following is a description of the valuation methodologies used for assets measured at fair value:

Pooled Separate Accounts: Pooled separate accounts are valued based upon the unit values of such pooled accounts held by the Plan at year end. Unit values are based on the fair value of the underlying assets of the fund derived from inputs principally from or corroborated by observable market data by correlation or other means, although not based upon quoted prices in an active market. The underlying investments of the pooled separate accounts consist of mutual funds, each of which follows a separate investment strategy. Due to the nature of these pooled accounts, there are no unfunded commitments or redemption restrictions.

Mutual Funds: The mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust Funds: The collective trust funds are valued at the net asset value of units of a bank collective trust. The net asset value, as provided by the Trustee, is published as the fund's fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. The common collective trust funds held by the Plan are deemed to be actively traded.

The methods described above may produce fair values that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Party-in-Interest Transactions

Transactions resulting in Plan assets being transferred to or used by a related party are considered prohibited transactions under ERISA unless a specific exemption exists. Certain plan investments include pooled separate accounts, mutual funds and common collective trust funds that are managed by Reliance Trust Company or Principal Life Insurance Company (the Custodians); and therefore, these transactions qualify as party-in-interest transactions. However, the transactions are not considered prohibited transactions as ERISA regulations provide for a specific exemption for such transactions.

Additionally, certain employees of the Company provide certain accounting and administrative services to the Plan for which no fee is charged. These transactions are also permitted under ERISA regulations.

5. Tax Status

The prototype plan document utilized by the Plan has obtained an IRS opinion letter, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. The Plan evaluates all significant tax positions as required by generally accepted accounting principles in the United States. As of December 31, 2024, the Plan does not believe that it has taken any tax positions that require the recording of any additional tax liability nor does it believe that there are any unrealized tax benefits that would either increase or decrease within the next twelve months.

The Plan's informational returns are subject to examination by the appropriate regulatory authorities as of December 31, 2024, and the Plan's federal informational returns generally remain open for a period of three years.

6. Risks and Uncertainties

The Plan offers a number of investment options to participants that are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect amounts reported in the statements of net assets available for benefits and participant accounts.

7. Subsequent Events

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 3, 2025, the date the financial statements were available to be issued.

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2024 and beyond. Plan management is evaluating the impact of the adoption and implementation of this legislation on the Plan.
