INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of the
Bil-Jim Construction Co., Inc. and Maple Lake, Inc. Pension Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Bil-Jim Construction Co., Inc. and Maple Lake, Inc. Pension Plan (hereafter referred to as the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from US Bank, a qualified institution, as of December 31, 2023 and for the period of January 1, 2024, through September 31, 2024, and Lincoln National Life Insurance Company, a qualified institution, as of December 31, 2024, and for the period of August 1, 2024, through December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.



Notes to the Financial Statements

NOTE 1: DESCRIPTION OF PLAN

The following description of the Bil-Jim Construction Co., Inc. & Maple Lake, Inc. Pension Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was established on February 1, 1986, and was amended and restated effective September 1, 2024. The Plan is a 401(k) defined contribution plan covering all eligible employees of Bil-Jim Construction Co., Inc. and Maple Lake, Inc. (collectively the “Company” or “Employer”). The Plan previously included Central Jersey Hot Mix Asphalt, LLC and Recycling of Central Jersey, LLC, which ceased participation effective September 1, 2024.

An employee of the Company, who is not an hourly employee, other than (1) field laborer (2) field operator, union or leased employee, independent contractor or a non-resident alien or is otherwise covered by a collective bargaining agreement, can enroll in the Plan who has one year or 1,000 hours of continuous service with the Company. Employees working under a prevailing wage contract are eligible to participate in the Plan for purposes of receiving any prevailing wage contributions on the date their employment becomes covered under the contract, unless the prevailing wage contract provides otherwise. For the period of January 1, 2024, through September 30, 2024, the Plan was managed by US Bank. Effective October 1, 2024, Plan management was transferred to and is managed by Lincoln National Life Insurance Company (“Lincoln Financial”).

Contributions

Employee

Each year, eligible participants, may contribute up to 100 percent of their eligible compensation, are subject to the maximum Internal Revenue Service (“IRS”) limitations, during the Plan year. For the year ended December 31, 2024, the applicable dollar amount was \$23,000. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The maximum catch-up contribution was \$7,500 for the year ended December 31, 2024. Participants may also contribute Roth deferrals, as well as amounts representing distributions from other qualified defined benefit or defined contribution plans. Participant contributions to the Plan are recorded in the period that payroll deductions are made by participants.

Employer

Nonelective contributions

The Company makes non-elective prevailing wage contributions in accordance with the Act and shall contribute for each “eligible” participant who performs services covered by the “applicable prevailing wage law” such amount as may be required under such laws to meet the required benefit levels for such plan year. For the year ended December 31, 2024, a prevailing wage contribution in the amount of \$17,473 was made to the Plan.

In accordance with the provisions of the Plan document, the Company may elect to provide a non-elective contribution to eligible participants, in addition to prevailing wage contributions. For the year ended December 31, 2024, the Employer contributed \$96,656 to the Plan which was funded subsequent to year-end in 2025.

Employer(continued)

Contributions receivable as of December 31, 2024 and 2023 were \$96,656 and \$100,000, respectively, and are included in employer contributions receivable on the accompanying statements of net assets available for benefits.

Matching contribution

The Company may make a discretionary matching contribution equal to a uniform percentage or dollar amount based upon participant elective deferrals. No such contribution was made during the year ended December 31, 2024.

Participant Accounts

Participants' investments are self-directed from a choice of investments provided by the Custodian. Each participant's account is credited with the participant and Company contributions, Plan earnings, and an allocation of administrative expenses. The participant's account is reduced by withdrawals, losses on investments, administrative fees, and any forfeitures. Allocations are based on a percentage of contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their accounts.

Notes Receivable from Participants

Participants may borrow from their funds a minimum of \$1,000 up to a maximum amount of the lesser of: a) 50% of the participant's vested account, reduced by any outstanding loan balance, or b) \$50,000, reduced by the highest outstanding loan balance during the one-year period ending on the day before the loan is made. The loans are secured by the balance in the participant's account and bear interest at rates between 2.25% and 5.60%, as of December 31, 2024, which are commensurate with local borrowing rates as determined quarterly by the Plan administrator. Note terms generally range from one to five years, with longer terms available for the purchase of a primary residence. Principal and interest are repaid through monthly payroll deductions. Spousal consent is required for participants to borrow from their accounts.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Upon termination of employment, the Plan has a mandatory cash-out provision for participants with less than \$5,000 in their account, which does not require consent from the participant. In-service distributions are allowed for participants after reaching age 55, which is defined as normal retirement age, per Plan provisions.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Cash and Cash Equivalents

The Plan maintains its cash deposits with financial institutions of high credit quality. Such deposits are insured by the Federal Deposit Insurance Corporation (FDIC) up to a limit of \$250,000 per institution.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s trustees determine the Plan’s valuation policies utilizing information provided by the investment advisers and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases making loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payments of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net depreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

NOTE 3: INFORMATION CERTIFIED BY US BANK AND LINCOLN FINANCIAL

US Bank Certification

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at September 30, 2024, and interest, dividends, and net appreciation in fair value of investments for the period of January 1, 2024 through September 30, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by US Bank as of September 30, 2024.

Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the above information which appears throughout the financial statements and supplemental schedules.

Transfer from US Bank to Lincoln Financial

At the request of the Plan Sponsor, all Plan investments were transferred to Lincoln Financial. The transfer of investments was completed in September 2024, followed by the receipt of trailing net appreciation, interest, and dividends. As of October 2024, all investments, including trailing net appreciation, interest, and dividends, had been fully received by Lincoln Financial.

Lincoln Financial Certification

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024, and net depreciation in fair value of investments for the period of October 1, 2024 through December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Lincoln Financial as of December 31, 2024.

Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the above information which appears throughout the financial statements and supplemental schedules.

NOTE 4: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

Common stocks: Valued at the closing price reported on the active market on which the individual securities are traded.

NOTE 5: RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are managed by Lincoln Financial; therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment manager services are included in net depreciation in the fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

NOTE 6: TAX STATUS

The Plan adopted a Volume Submitter Profit Sharing Plan (the "Plan") with CODA (cash or deferred arrangement). The Internal Revenue Service ("IRS") has issued an opinion date to the Company by a letter dated March 31, 2014, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Company believes the Plan is generally no longer subject to income tax examination for years prior to 2022.

NOTE 7: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. The Company also reserves the right to amend, modify, suspend or terminate the Plan permanently or temporarily, at such time as they deem appropriate.

NOTE 8: RISKS AND UNCERTAINTIES

The Plan provides for various investment securities options. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
