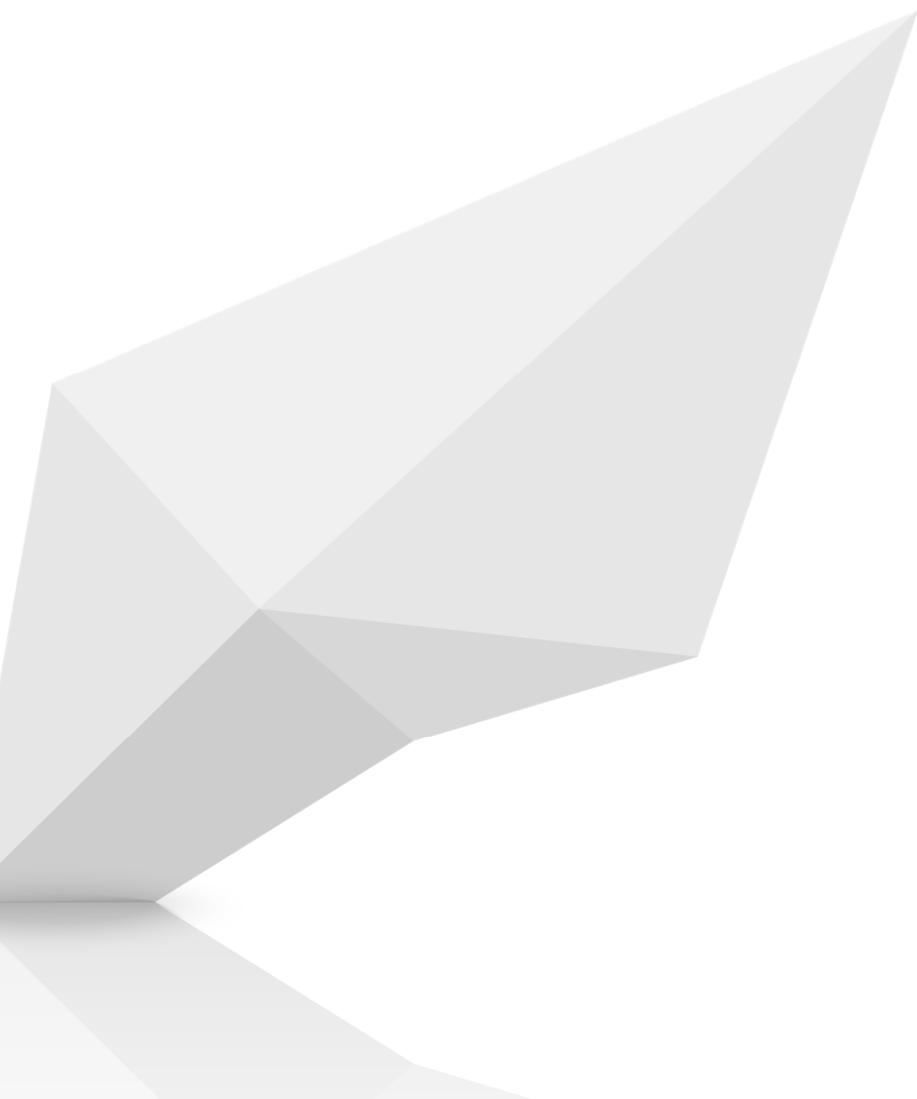

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of The Free Library of Philadelphia Foundation 403(b) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

## Note 1: Description of Plan

The following description of the The Free Library of Philadelphia Foundation 403(b) Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

### General

The Plan is a participant-directed defined contribution plan established for a not-for-profit organization, commonly known as a Code Section 403(b) savings plan. Free Library of Philadelphia Foundation (the "Foundation") is the plan sponsor and is a not-for-profit corporation as described in Section 501(c)(3) of the Internal Revenue Code (IRC). Full-time employees, working 20 hours or more per week are eligible for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan is intended to satisfy the requirements under Section 404(c) of ERISA and, therefore, provides that participants may choose to direct their contributions and/or all or part of their account balances among the Plan's investment alternatives. All investments are participant-directed.

The Foundation has appointed both Teachers Insurance and Annuity Association of America (TIAA) and College Retirement Equities Fund (CREF), collectively TIAA-CREF, as custodian of all assets held under the Plan.

### Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions, with respect to Internal Revenue Service limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Foundation may make matching contributions at their discretion. Participants become eligible for a Foundation contribution after attaining age 18 and working a minimum of one year or 1,000 hours. During the year ended December 31, 2024, the Foundation made matching contributions of \$95,446 to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

### Investment Options

Participant contributions and Foundation matching contributions are allocated among the available investment options as directed by each participant. By designating these investment alternatives for participants, allowing frequent fund transfers and providing the necessary fund information to participants, it is intended that the Plan be treated as an ERISA 404(c) Participant-Directed Account Arrangement.

## **Note 1: Description of Plan** (Continued)

### **Participant Accounts**

Each participant's account is credited with the participant's contributions, Foundation matching contributions, and an allocation of plan earnings (losses). Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are fully and immediately vested in all contributions, plus actual earnings (losses) thereon.

### **Notes Receivable From Participants**

Upon a participant's request, plan loans are issued as separate contracts by TIAA as contemplated under IRC section 72(p)(5) and do not represent plan assets. Loans are collateralized using a participant's TIAA Traditional account balance in an amount equal to 110% of the outstanding loan balance. Principal and interest are paid ratably by the participant to TIAA and each payment will reduce amounts collateralized by the borrowing participant's TIAA Traditional account balance. There were no plan loan balances outstanding from participants to TIAA as of December 31, 2024 and 2023.

### **Payment of Benefits**

On termination of employment, retirement, death, or disability, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

## **Note 2: Summary of Significant Accounting Policies**

### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (GAAP).

### **Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

## **Note 2: Summary of Significant Accounting Policies** (Continued)

### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts (FBRICs). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year, and all earnings on investments.

FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Foundation. Expenses that are paid by the Foundation are excluded from these financial statements. Certain investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net appreciation/depreciation in fair value of investments.

### **Subsequent Events**

The Plan has evaluated subsequent events through October 15, 2025, which is the date the financial statements were available to be issued.

#### Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of the relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Pooled separate accounts:* Accumulation Unit Values of College Retirement Equities Fund (CREF) and TIAA Access account investments are primarily valued using market quotations or prices obtained from independent pricing sources. Accumulation Unit Values of TIAA Access accounts are based on the value of the underlying mutual fund investments. CREF Money Market Account holdings are generally valued at amortized cost. Each account determines its unit value each day. The TIAA Real Estate Account (REA) generally invests in real estate properties and real estate-related investments. The REA's value is principally derived from the market value of the underlying real estate holdings or other real estate-related investments as well as such liquid fixed-income investments. Real estate holdings are valued principally using external appraisals, which are estimates of property values based on a professional's opinion. The REA also holds liquid, fixed-income investments. These are generally priced using quoted prices in active markets or values obtained from independent pricing sources. Unit values are calculated daily.

*Fixed annuity contracts:* Fixed annuity contracts which are non-fully benefit-responsive are valued at contract value which approximates fair value. This determination is made by the custodians by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer. As the participants transact at contract value, fair value is determined annually for financial statement reporting purposes only. In determining the reasonableness of the methodology, the Retirement Plan Committee evaluates a variety of factors including review of existing contracts, economic conditions, industry and market developments and overall credit ratings. Certain unobservable inputs are assessed through a review of contract terms (for example, duration or payout date) while others are substantiated utilizing available market data (for example, swap curve rate)

The following tables set forth by level, within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits.

## **Note 4: Fully Benefit-Responsive Investment Contracts (FBRICs)**

TIAA Traditional Annuity (TIAA Traditional) is an unallocated fixed-annuity contract that is fully and unconditionally guaranteed by TIAA. TIAA Traditional provides a guarantee of principal, a guaranteed 3% minimum rate of interest, and the potential for additional interest, if declared by TIAA. Additional interest, when declared, remains in effect for the "declaration year," which begins each March 1. Additional interest is not guaranteed for future years. Contributions to a participant's account purchase a guaranteed amount of lifetime annuity income. When a participant's account in the TIAA Traditional is converted to an annuity, based on life expectancy, the present value of the stream of payments is equal to the account balance. The subsequent stream of annuity payments occurs outside of the plan and does not represent an obligation of the plan. Terms may apply which impose liquidity restrictions on redemptions of the accumulations account which could impact the value realized upon exiting the contract.

TIAA Traditional annuity accumulations are credited with interest based on when contributions and transfers are received, and a participant's performance will vary based upon amounts and timing of funds received. The interest rate applied to contributions for the year ended December 31, 2024 was 5.25%. TIAA Traditional Annuity is valued at contract value which equals the accumulated cash contributions, interest credited, and transfers, if any, less any withdrawals and transfers. The contract value of fully benefit-responsive investment contracts with TIAA was \$172,806 and \$167,944 at December 31, 2024 and 2023, respectively, and is included in investments at contract value on the statements of net assets available for benefits. Investment contracts that are non-fully benefit-responsive are included in the financial statements at fair value, as reported to the Plan by TIAA.

The TIAA Traditional Annuity meets the criteria for fully benefit-responsive investment contracts. FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan. Certain events limit the Plan's ability to transact at contract value with the issuers, including plan termination and other events as specified in the contracts. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants or the issuers are probable of occurring. The contract does not permit the issuers to terminate the agreements prior to the scheduled maturity dates.

## **Note 5: Information Prepared and Certified by the Custodian**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation/depreciation in fair value of investments for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Teacher's Insurance and Annuity Association and College Retirement Equities Fund (TIAA-CREF), the Custodian of the Plan.

## **Note 6: Related-Party Transactions and Party-in-Interest Transactions**

Plan investments are managed by TIAA-CREF, the Custodian, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. These transactions are exempt from the prohibited transaction rules of ERISA.

## **Note 7: Plan Termination**

Although it has not expressed any intent to do so, the Foundation has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

## **Note 8: Tax Status**

The Plan has adopted a Volume Submitter 403(b) Plan sponsored by TIAA-CREF. The IRS has determined and informed the plan by a letter, that the plan and related trust are designed in accordance with applicable sections of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

## **Note 9: Risks and Uncertainties and Concentration of Investments**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

At December 31, 2024 and 2023, four investment securities represented 60% and three investment securities represented 59% of plan net assets, respectively.

## **Note 10: Prohibited Transactions**

Under DOL Reg. 2510.3-102(b), the Foundation is required to remit the employee contributions to the Plan at the earliest date such amounts can be reasonably segregated from the Foundation's general assets, but no later than the fifteenth business day of the month following the date that participant contributions are withheld by the Foundation. As reported on Schedule H, Line 4a – Schedule of Delinquent Participant Contributions, certain contributions for payrolls during the plan year ended December 31, 2024 including contributions from previous years that remain uncorrected as of December 31, 2024, totaling \$4,704, were remitted outside the 15-day requirement. These transactions constitute a prohibited transaction as defined by ERISA.
