## INDEPENDENT AUDITORS' REPORT

### Opinion

We have audited the accompanying financial statements of the Vigilant Construction Trust of Arizona Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024, and the related statements of changes in net assets available for benefits and changes in benefit obligations for the year then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and benefit obligations of Vigilant Construction Trust of Arizona Plan (the Plan) as of December 31, 2024, and the changes in its net assets available for benefits and of changes in benefit obligations for the year then ended in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## Notes to Financial Statements

### Note 1 – Description of the Plan and Trust

The Vigilant Construction Trust of Arizona Plan (the Plan) was established on May 1, 2019. The Plan was established to provide programs of health and other welfare benefits for participating employers under the employee benefit plans they maintain for their employees and dependents. The following description of the Plan provides only general information. Participants should refer to the Plan documents, summaries, and other descriptive plan literature for a more complete description of the Plan's provisions.

This plan is considered a "multiple employer welfare arrangement" as defined by the regulations promulgated under the Employee Retirement Income Security Act of 1974 (ERISA). ERISA regulations define a "multiple employer welfare arrangement" as an employee welfare benefit plan or any other arrangement, which is established or maintained for the purpose of offering or providing any welfare benefit to the employees of two or more employers, or to their beneficiaries. The types of benefits available under the Plan through December 31, 2024, are described as follows: medical, hospital, surgical, prescription drug, dental, vision, life, accidental death and dismemberment, and employee assistance benefits.

An employer is entitled to participate in the Plan once the employer has completed and filed a master application adopting the trust agreement, has been accepted for participation by the insurers, and has made all contributions required by the related trust. The employer must be engaged in the construction industry in the geographic area covered by the Plan.

Each participating employer agrees to promptly remit contributions to the related trust to adequately cover the payment of insurance premiums for its participants and beneficiaries and its share of any reasonable and necessary obligations and expenses incurred during its participation. The Board of Trustees may bring action to collect contributions if coverage has been provided or if benefits have been paid, and no contributions or incorrect amounts of contributions have been paid.

Employer and participant contributions are received and held by the related trust pending payment of approved insurance premiums. Such contributions are determined pursuant to rules adopted by the Board of Trustees.

The endorsing sponsor of the Plan is Vigilant. During the years ended December 31, 2024 and 2023, the Plan and related trust were administered by the Board of Trustees, with the assistance of Vigilant Services, Inc. (VSI) (a wholly owned subsidiary of Vigilant); Vimly Benefit Solutions, Inc., a contract administration organization; Brown and Brown Insurance Services, Inc. dba DiMartino Associates, a benefits consulting services firm; and Barlow Coughran Morales & Josephson, P.S., a legal services firm. Effective April 1, 2025, the Plan engaged Turner, Stoeve & Gagliardi, P.S. for the provision of legal services. Financial statement accounting and auditing services were provided by Anastasi, Moore & Martin, PLLC and Schoedel & Schoedel, PLLC for the years ended December 31, 2024 and 2023, respectively. The Plan is marketed to employers by various insurance brokers.

### Note 2 – Summary of Significant Accounting Policies

- a. **Basis of accounting** – The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.
- b. **Use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Board of Trustees to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.
- c. **Investment valuation** – The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for a discussion of fair value measurements.
- d. **Contributions** – Employer and participant contributions are recognized as the Plan becomes obligated for the payment of insurance premiums. Therefore, contributions received after December 31 for benefits provided before the beginning of the subsequent year are recognized as contributions receivable. On the other hand, contributions received before December 31 for benefits provided in the subsequent year are recognized as unearned.
- e. **Payment of insurance premiums** – Insurance premiums are recognized when paid.
- f. **Subsequent events** – Subsequent events have been evaluated through October 9, 2025, which is the date the financial statements were available to be issued.

### Note 3 – Income Tax Status

The trust established under the Plan to hold the assets of the Plan is qualified as a tax-exempt organization under Section 501(c)(9) of the Internal Revenue Code (IRC) and, accordingly, the net investment income of the trust is exempt from income taxes. The trust obtained its latest tax determination letter from the Internal Revenue Service (IRS) with an effective date of exemption of December 21, 2021. In the letter, the IRS stated that the trust, as then designed, was in compliance with the applicable requirements of the IRC. The Board of Trustees and legal counsel believe the trust and related Plan are designed and have been operated through December 31, 2024, in accordance with applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be substantiated upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

## Notes to Financial Statements

### Note 3 – Income Tax Status (Continued)

The Plan is subject to routine audits by taxing jurisdictions, and the Plan could be subject to income tax if certain issues were found by the IRS that could result in the disqualification of the tax-exempt status; however, there are currently no audits for any tax periods in progress.

### Note 4 – Priorities Upon Termination

The Plan may be terminated at any time, by action of the Board of Trustees, provided that such action requires the written approval of Vigilant (or its successor). Upon the termination of the Plan, the Board of Trustees will wind up the affairs of the Plan. Where the termination occurs as a result of a merger, any and all monies and assets remaining in the Plan, after the payment of expenses, will be transferred to the successor plan. With respect to any other termination, any and all monies and assets remaining in the Plan, after the payment of expenses, will be used for the continuance of the benefits, for participating employees then covered by the Plan, until such monies and assets have been exhausted or until such assets are no longer sufficient to provide any sort of meaningful benefit to participating employees. At this point, the remaining assets may be disposed in any manner permitted by law. In no event will any of the remaining monies or assets be paid to or be recoverable by any participating employer, or paid in cash to participating employees, unless such disposition is required by applicable laws.

### Note 5 – Risks and Uncertainties

In determining the fair value of financial instruments, the Board of Trustees uses a variety of methods and assumptions that are based on market conditions and risks existing at the date of the statements of net assets available for benefits. All methods of assessing fair value result in a general approximation of value, and such value may never actually be realized.

Currently, the Plan operates as a fully insured arrangement and, therefore, is contracted with particular insurance carriers. In the Plan's service area, there are limited qualified insurance carriers willing and capable of meeting the Plan's insured benefit needs.

The Plan maintains accounts at one financial institution which, as of December 31, 2024, is insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. At times, the Plan's cash balances may exceed the FDIC insurance limit.

The Plan and related insurance carriers face an increasingly challenging regulatory environment. Certain interpretations of laws, rules, and regulations could potentially result in adverse effects to the Plan. However, it is not expected that the Plan will significantly change operations or terminate prior to December 31, 2025.

### Note 6 – Related-party Transactions

VSI (a wholly owned subsidiary of Vigilant) performs consulting and administration services for the Plan. Additionally, an employee of VSI serves as an unpaid trustee of the plan. For the years ended December 31, 2024 and 2023, the Plan recognized expenses totaling \$52,732 and \$51,988, respectively, for such services. As of December 31, 2024, amounts due to VSI totaled \$80. As of December 31, 2023, the Plan had a credit for future services of \$75.

On occasion, VSI may pay certain administration expenses on behalf of the Plan. As of December 31, 2024 and 2023, amounts due to VSI for the reimbursement of these expenses totaled \$-0-.
