NOTE A. DESCRIPTION OF PLAN

The following description of the Riley Industrial Services, Inc. 401(k) Retirement Plan provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

1) *General*

The plan is a 401(k) salary deferral and profit sharing plan which provides benefits to substantially all employees of Riley Industrial Services, Inc. The plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

Prior to July 2023, the plan was administered by Principal Financial Group, which includes Principal Life Insurance Company. In July 2023, the plan sponsor elected to move custody of the plan assets to Automatic Data Processing, Inc. (ADP Retirement Services). In connection with this move, substantially all of the investments held at Principal Financial Group were "mapped" by the plan trustee to investments considered similar at ADP Retirement Services. The only balance in the plan that remains at Principal Financial Group as of the date of these financial statements is the Principal U.S. Property account which is in the process of being liquidated and transferred to ADP Retirement Services.

In addition to the transfer of assets to ADP Retirement Services, in July 2023, all net assets of the Riley Industrial Profit Sharing Plan were transferred and merged into the Riley Industrial Services, Inc. 401(k) Retirement Plan. Detail of the transfer is as follows:

Employees of the company are generally eligible for participation in the plan (salary deferrals and employer match contribution) after reaching age twenty-one and after completing six months of service or as agreed to in employment contracts approved by the plan trustee. Participants must complete at least 12 months and 1,000 hours of service during the plan year to be eligible for any employer paid profit sharing plan contributions for such year.

2) *Contributions*

Participants are permitted to defer a portion of their compensation by an amount that does not exceed the maximum allowed under Internal Revenue Service (IRS) rules and regulations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants who have attained age fifty before the end of the plan year are eligible to make catch-up contributions. The company may contribute a discretionary match of the deferral contribution that a participant makes to the plan. Additional profit sharing amounts may be contributed at the option of the board of directors. Company contributions are made during or shortly after the year to which they apply. Contributions are subject to regulatory limitations.

3) *Participant accounts*

Each participant account is credited with the participant's contributions and allocations of the company's contribution, plan earnings, and administrative expenses. Allocations are based upon account balances or participant earnings, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

4) *Vesting*

Participants are immediately vested in their deferral contributions plus actual earnings. Vesting in the company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of continuous service. Participants with vested balances of \$1,149,088 and \$664,079 had terminated, but not been paid out of the plan as of December 31, 2024 and 2023, respectively.

5) *Investment options*

Upon enrollment in the plan, the participant may direct the administrator to invest the assets of the participant's account among any of the funds maintained by the plan. All investments are participant directed. The plan is primarily invested in mutual funds. After initial enrollment, participants are able to change the allocation of their account balances by phone or on the internet.

6) *Payment of benefits*

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the vested account balance or installments over a period of time for required minimum distributions only. For termination of service for other reasons, a participant may receive the value of the vested account as a lump-sum distribution. Vested amounts in excess of \$1,000 may be left in the plan. In-service distributions are permitted as long as the participant is at least 59 ½ years of age and the distribution can be taken from employee or employer sourced balances.

7) *Administrative expenses*

Certain administrative expenses incurred by the plan are routinely paid by the company. These expenses totaled \$19,263 and \$9,501 for the plan years ended December 31, 2024 and 2023, respectively.

8) *Notes receivable from participants*

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear an interest rate currently of 9.5% at December 31, 2024 and 2023, respectively. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case the loan must be repaid within a reasonable period of time, not to exceed thirty years. Principal and interest is paid ratably through payroll deductions.

9) Forfeited accounts

Forfeited non-vested accounts totaled \$10 at December 31, 2024 and 2023, respectively. Forfeited amounts of \$13,361 and \$6,162 in 2024 and 2023 were used to pay plan expenses or to reduce employer contributions.

10) Plan modification or termination

Although it has not expressed any intent to do so, the company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

NOTE B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1) Basis of accounting

The financial statements of the plan are prepared on the accrual method of accounting in accordance with principles generally accepted in the United States of America.

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain amounts and disclosures. Actual results could differ from those estimates. Certain amounts in the 2023 financial statements have been reclassified to conform to the 2024 presentation.

2) Investment valuation

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

3) Payment of benefits

Benefits are recorded when paid.

4) Subsequent events

Plan management has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued. No subsequent events requiring disclosure were noted.

NOTE D. FAIR VALUE MEASUREMENTS

FASB ASC 820 provides the framework for measuring fair values. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements). Level 2 measurements are described as quoted prices for similar assets or liabilities in active markets; or quoted prices for identical or similar assets or liabilities in inactive markets. Level 3 measurements are described as derived from unobservable inputs, or derived principally from or corroborated by observable market data by correlation or other means. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds are publicly traded and valued at the daily closing price as reported by the fund. The mutual funds held by the plan are deemed to be actively traded and the fair value for these funds is Level 1 measured value.

The common/collective trust fund held by the plan is one of a series of collective trust funds established and maintained by The Goldman Sachs Trust Company, N.A., and is valued at the daily closing price as reported by the fund. The net asset value of a common/collective trust fund is based on the market value of its underlying investments and is not a publicly quoted price in an active market, therefore, is valued using level 2 measurements.

These fair values are generally obtained from third party pricing services or determined through the use of valuation models or methodologies, including Principal pricing, using substantially all observable inputs. Prices are validated through an investment analyst review process including direct interaction with external sources, recent trade activity or through the use of internal models. As of December 31, 2024, and 2023, there are no unfunded commitments related to the PSA. Fair values for PSAs are Level 2 measured values.

NOTE D. FAIR VALUE MEASUREMENTS (CONTINUED)

The mutual funds in the blend class invest a majority of assets in common stocks of a broad range of domestic companies, including small, medium, and large capitalization companies. Management will look at stocks with value and/or growth characteristics and construct an investment portfolio that has a blend of stocks with these characteristics. These managements do not have a policy of preferring one of these styles over the other.

The mutual funds in the fixed income investment class invest primarily in fixed securities such as asset backed securities, commercial and residential mortgage-backed securities, corporate bonds or commercial real estate, which includes mortgage loans that are backed by the associated properties.

The mutual funds in the growth investment class seek long-term growth of capital. The funds normally invest at least 80% of their net assets, plus any borrowings for investment purposes, in equity securities of companies with medium to large market capitalizations (with investment objectives similar to the companies in the Russell 1000® Growth Index) at the time of purchase. They invest in growth equity securities; growth orientation emphasizes buying equity securities of companies whose potential for growth of capital and earnings is expected to be above average. The funds also invest in securities of foreign companies.

The mutual funds in the international equity investment class seek to invest a majority of assets in companies (1) with their principal place of business or principal office outside of the United States, (2) for which the principal securities trade on a foreign exchange, (3) with small to medium market capitalizations and (4) that derive 50% or more of their total revenue from goods or services produced or sold outside of the United States.

The mutual funds and PSA in the real estate investment class invest the majority of assets in U.S. commercial real estate holdings. It focuses on properties that return both lease income and appreciation of the buildings' marketable value. The property holdings usually contain real estate from the multi-family, office, warehouse/manufacturing, and retail sectors. This investment option is subject to investment and liquidity risk and other risks inherent in real estate such as those associated with general and local economic conditions.

The mutual funds in the target date investment class seek a total return consisting of a balance of long term growth of capital and current income. The mutual funds and PSAs invest in underlying domestic and foreign equity, real estate investments and fixed income funds according to an asset allocation strategy designed for investors having various investment time horizons.

The mutual funds in the value investment class invest the majority of assets in companies with market capitalizations similar to those of companies in the Russell Mid Cap Value Index. Management will select investments primarily on the basis of fundamental security analysis, focusing on the company's financial stability, sales, earnings, dividend trends, return on equity and industry trends. They may invest up to 25% of assets in foreign securities.

NOTE F. RISKS AND UNCERTAINTIES

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE G. CONCENTRATIONS

Substantially all of the cash and investment assets of the plan are maintained at a registered insurance company and are not covered by FDIC insurance. The non-interest bearing cash account did not exceed FDIC insurance limits as of December 31, 2024 or 2023. The company periodically evaluates the soundness of its investments and does not feel that the risk of loss of these funds is excessive.

NOTE H. RELATED-PARTY TRANSACTIONS

Certain plan investments are shares of pooled separate accounts and, previously, a guaranteed interest contract managed by Principal Financial Group, an affiliate of Principal Trust Company, the previous plan custodian. Transactions with the Principal Financial Group qualify as party-in-interest transactions. Fees paid by the plan to Principal Financial Group and its agents and affiliates totaled \$0 and \$6,343 for the years ended December 31, 2024 and 2023.

NOTE I. INCOME TAX STATUS

The plan uses a prototype plan document sponsored by ADP, LLC. The prototype plan received an opinion letter from the IRS, dated October 6, 2020, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code (IRC). The plan itself has not received a determination letter from the IRS and the prototype has been amended since receiving the opinion letter. However, the plan's management believes that the plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the plan's financial statements.
