We have performed audits of the financial statements of the Fragomen, Del Rey, Bernsen & Loewy, LLP 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Notes to Financial Statements

Note 1. Plan Description

The following description of the Fragomen, Del Rey, Bernsen & Loewy, LLP 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan established by Fragomen, Del Rey, Bernsen & Loewy, LLP (the Partnership) in order to provide eligible employees with an additional source of retirement income and survivor benefits. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: Each employee becomes eligible to participate once they have been employed for 30 days and have attained age 21.

Contributions: The Plan provides that each participant, who has met eligibility requirements, as defined, may contribute to the Plan and elect to defer a percentage or an amount of their eligible compensation, as defined, on a pretax basis or after-tax basis not to exceed the maximum allowable under the Internal Revenue Code (IRC) for any plan year (\$23,000 for 2024). Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions (\$7,500 for 2024). The Partnership determines, prior to the beginning of each plan year, whether and to what extent to make a matching contribution on behalf of the participants who make a pretax or after-tax contribution in each plan year. Effective February 2024, the Partnership elected to reinstate the match of up to 20% of participant contributions. The Partnership determines, prior to the beginning of each plan year, whether and to what extent to make a profit-sharing contribution. In order to be eligible, the participant must have completed 500 hours of service during the plan year. For 2024, there was no profit-sharing contribution to participants.

Participant accounts: Each participant makes self-directed elections to have his or her account balances invested in one or more investment funds. Investment elections can be changed on a daily basis. Each participant's account is credited with the participant's contribution, employer contributions and an allocation of the Plan earnings. Allocations of the profit-sharing contribution are based on participant compensation as a percentage of total compensation paid to all participants. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: The balance in each participant's pretax or after-tax (Roth) contribution account and any rollover contribution account including earnings thereon are fully vested at all times. The nonforfeitable percentage of the balances in each participant's employer matching and profit-sharing contribution accounts are determined based on years of continuous service. A participant whose participation in the Plan terminates before they are fully vested for any reason other than retirement, disability or death, shall forfeit any portion of their interest in the Plan which is not vested. In the event of the death of a participant while serving in the military, credit for vesting is given during the period of military service.

Notes receivable from participants: Participants may borrow from their vested account balances an amount up to the lesser of \$50,000 or 50% of their account balance. Participants cannot have more than two loans outstanding at any time, and no loan may be for an amount less than \$1,000. The maximum loan term is five years unless the loan is for the purchase of a primary residence for which the maximum loan term is 15 years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined from time to time by the Plan Administrator. Principal and interest are paid ratably through payroll deductions or other methods as approved by the Plan Administrator. Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. As of December 31, 2024, the annual interest rates ranged from 4.25% to 9.50%.

Payment of benefits: On termination of service due to retirement, resignation, dismissal or death, a participant's account balance is distributed to the participant or designated beneficiary by payment in a lump sum for accounts valued at less than \$1,000. For accounts valued in excess of \$1,000, the participant may elect to remain in the Plan, withdraw a lump-sum payment, or withdraw equal monthly payments over a fixed period. For accounts valued in excess of \$5,000, the participant may also elect to require the Plan to purchase an annuity from an insurer.

Forfeitures: Forfeitures are used to reduce future employer contributions or pay Plan expenses. Forfeited nonvested amounts totaled \$60,009 and \$244,624 at December 31, 2024 and 2023, respectively. During 2024, \$184,216 was used to pay administrative expenses and \$366,146 was used to reduce employer contributions. Accumulated forfeitures will be applied to pay administrative expenses and/or reduce employer contributions in 2025.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The accompanying financial statements have been prepared using the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Contributions to the Plan are recognized when received, and deductions from net assets are recognized when paid. Investments are valued at fair value in accordance with Financial Accounting Standards Board Accounting Standards Codification 820.

Note 2. Summary of Significant Accounting Policies (Continued)

Use of estimates: The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment valuation and income recognition: The Plan's investments and related earnings are stated at fair market values as reported to the Plan by the trustee of the Plan, Empower Trust Company, LLC, (the Trustee) as of December 31, 2024 and 2023, and for the year ended December 31, 2024. Participant accounts are represented by contributions, plus earnings, less participant withdrawals and administrative expenses. Purchases and sales of securities are recorded on a trade-date basis. Dividends and interest are recorded upon receipt. See Note 4 for discussion of fair value measurements.

Expenses: Certain expenses of maintaining the Plan are paid directly by the Partnership and are excluded from these financial statements. Administrative expenses include fees related to the administration of notes receivable that are charged directly to the participant's account and certain recordkeeping fees paid by the Plan. Investment-related expenses are included in net depreciation in fair value of investments.

Note 3. Information Certified or Provided by the Trustee

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedules, that was prepared by or derived from information provided by the Trustee and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Trustee that information provided to the Plan Administrator by the Trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information that appears throughout the financial statements and ERISA-required supplemental schedules related to the following assets:

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the best level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts (SDBAs): SDBAs primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices. The mutual funds and common stocks held in these accounts are deemed to be actively traded.

Variable annuities: Variable annuities are valued daily by taking the quoted price for the underlying mutual fund and adjusting the price to apply the expense factor disclosed in the annuity contract.

Common collective trust: Units held in collective trusts are valued using the NAV practical expedient of the collective trust as reported by the collective trust managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the collective trust, minus liabilities, and then divided by the number of units outstanding. The NAV practical expedient of a collective trust is calculated based on a compilation of primarily observable market information.

Note 5. Related-Party and Party-in-Interest Transactions

Empower Retirement is the recordkeeper and Empower Trust Company, LLC is the Trustee, as defined by the Plan; therefore, any transactions with these entities qualify as party-in-interest transactions. Participant loan transactions are also party-in-interest transactions.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Partnership has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 7. Tax Status

The Plan is based on the nonstandardized preapproved Profit Sharing Plan with CODA (cash or deferred arrangement) document sponsored by Great-West Trust Company, LLC. The preapproved plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the preapproved plan was designed in accordance with provisions of the IRC. The Plan has not yet filed for its own determination letter from the IRS. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes due from the Plan has been included in the Plan's financial statements.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. In the event the Plan is subject to interest and/or penalties, interest would be included as a component of interest expense, and penalties would be included as a component of administrative expenses.

Note 8. Risk and Uncertainties

The Plan is permitted to invest in a combination of stocks and bonds, fixed income securities, mutual funds and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect the amounts reported in the statements of net assets available for benefits (modified cash basis) and the statement of changes in net assets available for benefits (modified cash basis).

Note 9. Prohibited Transactions

During 2022, the Partnership inadvertently failed to deposit \$107,016 of participant contributions within the required time frame as stated by the DOL regulation. The Partnership intends to deposit lost earnings to correct this failure in 2025. The Partnership will file Form 5330 and pay applicable excise tax to the IRS. The correction and any excise taxes, if applicable, will be made from the Partnership's assets and not from the assets of the Plan.

Note 10. Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

On April 1, 2025, the Plan Sponsor executed Amendment Number Two to the Fragomen, Del Rey, Bernsen & Loewy, LLP 401(k) Profit Sharing Plan. The amendment revised the default beneficiary provisions under Section 7.05(C), establishing a hierarchy whereby the Participant's spouse is designated as the primary default beneficiary, followed by the Participant's estate.
