## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Twenty 20 Management Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the year ended December 31, 2024 and 2023, and the related notes to the financial statements.

**NOTE 1. PLAN DESCRIPTION**

The following description of the Twenty 20 Management Inc 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General:** The Plan is a defined contribution plan covering substantially all employees of Twenty 20 Management Inc (the Sponsor). The Plan is a qualified trust under Sections 401(a) and 401(k) of the Internal Revenue Code. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Matrix Trust Company is the Plan’s Trustee for the year ended December 31, 2024. Employees become eligible on the first day of the following month after the date of hire. Participants may join at any given time during the year once eligible.

**Contributions:** Participants may elect to contribute a percentage of their compensation up to the maximum permitted by law. For 2024, participants can contribute up to \$23,000 (participants age 50 and over are eligible to make catch-up contributions for a maximum of \$30,500). The Plan permits rollover contributions from qualified retirement plans and IRAs; however, the Plan Administrator may adopt separate procedures limiting the type of rollover contributions it will accept. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, common stocks, bonds, and an insurance investment contract as investment options for participants. The Employer will make Qualified Matching Contributions (QMAC) equal to 50% of elective contributions up to 2% of eligible earnings. The Employer may also make a special discretionary Qualified Non-Elective Employer Contribution (QNEC) to eligible participants as determined under the plan.

**Participant accounts:** Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s matching contribution and, (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the plan and (c) loans and loan repayments. Generally, the expenses of administering the Plan are paid from Plan assets the Administrator has directed to be used for such purpose. Any remaining expenses are shared among all participants’ accounts as a flat fee or a percentage of the expense determined in the ratio that the value of each participant’s account bears to the total value of all accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting:** Participants are immediately vested in their contributions plus actual earnings thereon. Participants become 100% vested in Employer contributions after 6 years of service. Participants are immediately vested in Employer contributions classified as Qualified Matching (QMAC) and Qualified Non-Elective Contributions (QNEC). In addition, if a participant dies or becomes disabled, their account becomes 100% vested. Upon termination of employment, the non-vested balances accumulated are subsequently redistributed to a separate forfeiture account.

**Payment of benefits:** The participants’ benefit will equal the sum of the salary deferral, the after-tax contributions, the rollover contributions, and the vested portion of the Employer’s contribution plus net income and net losses resulting from the investment of these amounts as valued on the valuation date as defined. If the vested interest is \$5,000 or less, a participant will be eligible to receive a distribution of the entire vested balance as soon as administratively feasible following termination of employment. The benefit may be paid in a lump sum payment or by direct rollover to an IRA or other eligible retirement plan. If the vested balance is between \$1,000 and \$5,000 as of the distribution date and that participant does not consent to a distribution, the vested balance will be automatically rolled over to an IRA selected by the Plan Administrator. If the total vested account balance is \$1,000 or less as of the distribution date, the entire vested account balance will be distributed to the participant in a lump sum even without consent. If the value of the vested interest in a participant’s account exceeds \$5,000, distribution of such account balance will be made as soon as administratively feasible following termination of employment. However, if the participant doesn’t consent to distribution, the account balance will remain in the Plan. Distribution of participants’ accounts while still employed is allowed once the participant obtains normal retirement age or becomes disabled. However, no in-service distributions of salary deferrals may be made prior to age 59 ½ other than a distribution as a result of a disability. Rollover contributions may be withdrawn at any time.

**NOTE 1. PLAN DESCRIPTION, continued**

If a participant dies prior to the distribution of the full value of their vested account, distribution will be made to the participant's beneficiary as designated on the appropriate designated beneficiary form. If a participant does not designate a beneficiary to receive their benefits upon death, the benefits will be first distributed to a participant's spouse. If there is no spouse, then benefits will be distributed equally to the participant's children. If there are no children, the benefits will be distributed to the participant's estate.

**Forfeited accounts:** Forfeitures may first be used to pay any Plan expenses. Any remaining forfeitures are used to offset the Employers' matching contributions and are accounted for as a component of employer's contributions in the accompanying statements of changes in net assets available for benefits. Forfeited non-vested accounts totaled \$4,568 and \$3,194 at December 31, 2024 and 2023.

**Termination of plan:** Although it has not expressed any intent to do so, the Employer has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Date of management's review:** Subsequent events were evaluated through October 15, 2025, which is the date the financial statements were available to be issued.

**Use of estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Basis of accounting:** The accompanying financial statements have been prepared on the accrual basis of accounting.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the loan balance is reduced and a benefit payment is recorded,

**Investment valuation and income recognition:** Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan. Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

**Excess contributions payable:** Amounts payable to participants totaling \$-0- for contributions in excess of amounts allowed by the IRS are recorded as accounts payable for the years ended December 31, 2024 and 2023.

**Payment of benefits:** Benefits are recorded when paid.

**Administrative expenses:** The Company may pay administrative and trust expenses. All expenses not paid by the Company shall be paid by the Plan. The Company employees also administer the Plan.

**NOTE 3. INCOME TAX STATUS**

The Internal Revenue Service has determined and informed the trustee of the Plan by the most recent letter dated April 2, 2018, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code. The volume submitter plan from which the Plan was drafted is a standardized 401(k) savings/profit sharing plan. The Plan administrator operates the Plan as a qualified trust under Sections 401(a) and 401(k) of the Internal Revenue Code, and is therefore exempt from federal income taxes under provisions of Section 501(a).

The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2022.

**NOTE 4. FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1), and Level 3 are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 2 inputs were available to the Plan, and Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

**Level 1 Fair Value Measurements:** The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end. The fair values of common stock, corporate bonds, and U.S. Government securities are based on the closing price reported on the active market where the individual securities are traded.

**Level 2 Fair Value Measurements:** The Fixed Account investment option is provided through a Group Annuity Contract or Group Funding Agreement. Under the terms of the Contract, a crediting rate is established for amounts invested in the Fixed Accounts. The Company determines fair value of its investments using the market approach. Liquidation value is based on an actuarial formula as defined under the terms of the Contract. There are no unobservable inputs used and investment meets the definition of Level 2.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 6. ADMINISTRATION OF PLAN ASSETS**

The Plan's assets are held by Matrix Trust Company (Matrix), the Trustee of the plan. The trustee provides record keeping services to the Plan and maintains the participant's retirement account information.

Employer and participant contributions are managed by Matrix which invests cash received, interest and dividend income, and makes distributions to participants.

Such information has been certified as being complete and accurate in accordance with Section 2520.103-5 of the Department of Labor's

Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Act of 1974 and the Plan Administrator has elected to use this information without audit.

**NOTE 7. RELATED PARTY TRANSACTIONS**

Certain Plan investments are shares of mutual funds and an investment contract managed by Matrix. Matrix is the trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions.

**NOTE 8. RISKS AND UNCERTAINTIES**

The Plan provides for various investment options in any combination of stocks, mutual funds and other investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
