Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, and to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. - Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, which raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### ***Other Matters - Supplemental Schedule Required by ERISA***

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

# UNITED BANK CORPORATION 401(k) PLAN

## NOTES TO FINANCIAL STATEMENTS

### (1) Description of Plan

The following description of the United Bank Corporation 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan for the exclusive benefit of eligible employees and their beneficiaries. The Plan was created January 1, 2018, as a spin-off of the cash or deferred arrangement of the United Bank Corporation Profit Sharing Stock Plan (Former Plan). The Plan was restated effective January 1, 2022, to include features of a Qualified Automatic Contribution Arrangement (QACA). Effective January 1, 2024, the Plan was restated under the ADP Non-Standardized Defined Contribution Pre-Approved Plan document. Employees become eligible to participate in the Plan at 21 years of age and completion of 90 days of employment during which the employee completes 500 hours of service. Participants enter the Plan on the first day of the quarter following completion of the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Retirement Plan Committee is responsible for oversight of the Plan. The Retirement Plan Committee determines the appropriateness of the Plan's investment offerings, monitors the investment performance, and reports to the board of trustees. United Bank Corporation (the Company) absorbs certain costs of the Plan.

#### *Contributions*

Participants may contribute up to 50 percent of their annual compensation, as defined by the Plan, or the maximum allowed by law. Unless an eligible employee elects otherwise or opts out of enrollment, they are automatically enrolled in the Plan at a three percent rate which increases one percent per year, to a maximum of six percent. Participant contributions may be traditional elective deferrals (pre-tax) or Roth elective deferrals (after-tax). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company's QACA matching contribution is 100 percent of the first two percent of the employee's eligible compensation plus 50 percent of the next four percent. The Company may also make discretionary contributions in an amount or percentage determined by the Company. The Company made no such discretionary nonelective contributions during 2024. Contributions are subject to certain limitations.

#### *Participant Accounts*

Individual accounts are maintained for each participant. Each participant's account is credited with the participant's contributions, the Company's contributions, qualified rollover contributions, and adjusted for gains and losses based on the investment performance of a participant's account, less any distributions and associated transaction fees. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## **(1) Description of Plan (Continued)**

### *Investment Options*

Participants direct the investment of all contributions into various investment options offered by the Plan. Participants may change their investment options at any time.

As Plan sponsor, the Company through its Trust Department provides ongoing due diligence on all mutual fund investment options and periodically makes recommendations to the United Bank Retirement Plan Committee regarding any potential changes to those investment options. As of December 31, 2024, the Plan offered diversified investment options consisting primarily of mutual funds.

### *Notes Receivable from Participants*

Participants may borrow from the vested portion of their account balances. Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Only one loan may be outstanding at any time. Loans are secured by the balance in the participant's account and bear interest at a rate commensurate with rates charged by lenders for similar loans. Principal and interest are paid through payroll deductions over the term of the loan. Loan terms may not be more than five years unless the loan is used for the purchase of a residence. Interest rates ranged from 3.25 percent to 8.50 percent as of December 31, 2024. Effective for loans issued on or after January 1, 2022, upon termination of employment, the entire unpaid principal sum and accrued interest is due and payable.

### *Vesting*

Participants are 100 percent vested in their voluntary contributions, safe harbor matching contributions and rollover contributions. Participants employed prior to January 1, 2022 are fully vested in the Company QACA Contribution account. Participants hired after January 1, 2022 become vested in the Company QACA contribution account following completion of two years of vesting service. The Company's prior plan matching contribution account and discretionary employer contributions are subject to a six-year graded vesting schedule. Vesting is based on years of continuous service. After two years of service, participants are 20 percent vested, and vesting percentages increase at a rate of 20 percent each year thereafter. The participant is fully vested after the sixth year of employment.

### *Payment of Benefits*

Upon termination of service due to retirement or other reason, a participant is entitled to receive 100 percent of their vested account balance (a) in one lump-sum payment, or (b) in cash payments in installments over a period not to exceed 20 years, for balances in excess of \$5,000. Balances of \$1,000 or less are distributed in a lump sum, and balances greater than \$1,000 but less than or equal to \$5,000 are automatically rolled over to an individual retirement plan, unless the participant timely elects to receive a direct distribution. The Plan also allows for certain hardship withdrawals prior to termination of employment.

### *Hardship Withdrawals*

In the event funds are needed because of extreme financial hardship, as defined by the law, the participant may be allowed to make a withdrawal from their vested account balance from eligible accounts, as defined by the Plan. In accordance with the Internal Revenue Code, benefits withdrawn prior to age 59 ½ may be subject to additional taxes.

## **(1) Description of Plan (Continued)**

### *Forfeited Accounts*

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits from the discretionary employer contributions under the Plan. Forfeited amounts are to be used to pay administrative expenses or to reduce the employer's contribution, as applicable. As of December 31, 2024 and 2023, the balance in the forfeiture account was \$22,324 and \$6,183, respectively. Forfeitures were not used in 2024.

## **(2) Summary of Significant Accounting Policies**

The accounting policies of the Plan are maintained in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the *Accounting Standards Codification (ASC)* and related Accounting Standards Updates (ASUs). The following describes the more significant of those policies:

### *Basis of Accounting*

The accompanying financial statements have been prepared on the accrual basis of accounting.

### *Use of Estimates*

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of Plan assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, trustee and recordkeeper. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's realized and unrealized gains and losses on investments bought and sold as well as held during the year. Earnings on investments are allocated to individual participant accounts based on the performance of the investments selected by the participant.

For notes receivable from participants, the portion of interest included in each loan payment made by a participant is recognized as interest income in the participant's individual account.

### *Contributions*

Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

## **(2) Summary of Significant Accounting Policies (Continued)**

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent loans are treated as distributions based upon the terms of the Plan document.

### *Payment of Benefits*

Benefits are recorded when paid.

### *Administrative Expenses*

Fees related to participant benefit payments and participant loans are charged directly to the participant's account and are reflected in administrative expenses on the statement of changes in net assets available for benefits. Investment related expenses are included in net appreciation/depreciation of fair value of investments. Certain other investment-related advisory and third-party administration expenses are absorbed by the Company and are excluded from these financial statements.

## **(3) Information Prepared and Certified by the Trustee (Unaudited)**

Reliance Trust Company, the trustee of the Plan as of December 31, 2024 and 2023, has certified to the completeness and accuracy of the following data included in the accompanying financial statements.

- Investments, at fair value, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, and interest and dividend income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements, including related footnote disclosures and supplemental schedule.

Cash held by the Plan in a separate bank account was not included in the information certified by the trustee and, accordingly, was subject to audit procedures performed in accordance with auditing standards generally accepted in the United States of America.

#### **(4) Fair Value Measurements**

Financial Accounting Standards Board *Topic 820* provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Cash - Interest Bearing* - Represents cash on deposit in an interest earning money market account.

*Mutual Funds* - Valued at the daily closing price as reported by the funds. The funds held by the Plan are open-end funds that are registered with the United States Securities and Exchange Commission (SEC), required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### (5) Income Tax Status

The prototype plan sponsor received a favorable opinion letter from the Internal Revenue Service dated March 31, 2014, which states that its prototype plan, in form, meets the requirements of Section 401(a) of the Code and, therefore, is tax-exempt under the provisions of Section 401(a). The Plan has not received a determination letter specific to the Plan itself; however, the Retirement Plan Committee believes the Plan is operating in compliance with the applicable requirements of the Code.

Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently operated in compliance with the applicable requirements of the IRC. As such, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## (6) Related Party and Party-in-Interest Transactions

A party-in-interest is defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain Plan assets are investment options offered through Reliance Trust Company, the trustee; therefore, these transactions qualify as party-in-interest transactions. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan, and are specifically exempted from the prohibition of party-in-interest transactions under ERISA. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee received compensation from the Plan. The Company pays certain administrative fees on behalf of the Plan including all legal and accounting fees.

## (7) Plan Termination

Although it has not expressed an intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Should the Plan terminate in its entirety, participants will become fully vested in their accounts.

## (8) Risks and Uncertainties

The Plan invests in various investment securities, primarily mutual funds. Investment securities are exposed to various risks such as interest rate risk, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.
