## **INDEPENDENT AUDITORS' REPORT**

To the Plan Administrator, Participants and Beneficiaries of  
ASMG 401k Plan and Trust

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements***

We have performed an audit of the financial statements of ASMG 401k Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the year then ended, the stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### ***Opinion on the 2024 Financial Statements***

- the information in the accompanying 2024 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion on the 2024 Financial Statements***

We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the 2024 financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **NOTE A - DESCRIPTION OF PLAN**

The following description of ASMG 401k Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### **[1] General:**

The Plan is a defined contribution plan covering eligible employees of All States Materials Group, Inc. and its subsidiaries, and WT Terminal, LLC and its subsidiaries (collectively, the "Employer", "Company" or "Plan Administrator"). Employees are eligible to participate in the Plan as of the first day of the month coinciding with or next following the date subsequent to the completion of three months of service and having attained the age of eighteen. Employees who are subject to a collective bargaining agreement and leased employees are excluded from participating in the Plan. The Plan was originally adopted by the Employer on January 1, 1993 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The custodian of the Plan is Matrix Trust Company and the recordkeeper is Sentinel Benefits Group Inc.

##### **[2] Contributions:**

Each year, participants may make pre-tax elective contributions and Roth 401(k) contributions of up to 100% of eligible compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also rollover amounts representing distributions from other qualified plans. For each Plan year, the Employer shall contribute to the Plan a non-elective "Safe Harbor" contribution equal to 3% of participants' eligible compensation. The Employer may also make discretionary matching contributions. The Employer may also make a discretionary non-elective contribution. All contributions are subject to certain Internal Revenue Service ("IRS") limitations. For the Plan year ended December 31, 2024, the Company made \$2,251,244 of Safe Harbor contributions and \$974,914 of non-elective employer contributions. For the year ended December 31, 2024 there were no discretionary matching contributions.

The Plan has an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible participants' compensation.

##### **[3] Participant accounts:**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions, (b) Plan earnings (losses), and may be charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### NOTE A - DESCRIPTION OF PLAN (CONTINUED)

##### [4] Vesting:

Participants are immediately vested in their contributions and Employer Safe Harbor contributions plus actual earnings thereon. Vesting in the portion of their accounts arising from Employer discretionary contributions plus actual earnings thereon is based on years of continuous service. Vesting in the Company's discretionary matching contribution and non-elective employer contributions, plus actual earnings thereon, is as follows:

<u>Years of Service</u>	<u>Vesting</u>
0 - 1 year	0%
2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 years	100%

A participant who attains normal retirement age or who becomes disabled or dies will be considered 100% vested, regardless of the vesting schedule.

##### [5] Payment of benefits:

Upon a disability, retirement, or termination of employment with the Company for any reason, the participant will be entitled to receive a lump-sum distribution of the total vested portion of his or her account. The Plan may automatically make distributions to terminated participants, without their consent, if the value of their vested account balances does not exceed \$5,000 and if such amount is at least \$1, such amount will be rolled over to an individual retirement account if the participant does not make an affirmative election to either receive or rollover the distribution.

Active participants may take a distribution from the pre-tax and Roth portion of their account if they are at least age 59½ or through a hardship distribution. Participants may make a distribution from their rollover account at any time.

##### [6] Forfeitures:

As of December 31, 2024 and 2023, the balance of forfeited non-vested accounts totaled \$72,016 and \$13,392, respectively. The forfeitures of unvested account balances may be used to reduce future Employer contributions to the Plan. In 2024, Employer contributions were reduced by \$14,444 from the forfeiture of non-vested accounts. Also, the employer contribution receivable was reduced by \$72,016 from forfeited nonvested accounts available at the time the amount was paid.

#### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### [1] Basis of accounting:

The financial statements are prepared under the accrual method of accounting.

##### **[2] Subsequent events:**

The Plan has evaluated subsequent events through October 14, 2025, the date which these financial statements became available to be issued.

##### **[3] Investment valuation and income recognition:**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note E for discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### **[4] Payment of benefits:**

Benefits are recorded when paid.

##### **[5] Plan expenses:**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in the net appreciation in value of investments.

##### **[6] Use of estimates:**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities and changes therein, and when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

##### **[7] Cash:**

Cash consists primarily of balances held in demand deposit accounts with the custodian. The Plan has cash deposits in a financial institution that at times may exceed federally insured limits.

#### **NOTE C - INVESTMENT CERTIFICATION**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Matrix Trust Company, the custodian of the Plan, has certified to the completeness and accuracy of all investments and related investment activity in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024 and the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.

#### NOTE D - NON-PARTICIPANT DIRECTED INVESTMENTS

All of the Plan's investment holdings are non-participant directed and managed by an independent investment advisory firm. See Note E for the investments by general type for the non-participant directed investments.

#### Unitized Investment Structure

The Plan utilizes a unitized investment structure for its investment option, which combines multiple underlying investments into a single fund for participant allocation purposes. Although the fund is unitized for recordkeeping and participant reporting, the Plan owns the underlying investments directly. Accordingly, the underlying investments are presented in the financial statements at fair value and not as an interest in a master trust or pooled investment vehicle.

#### NOTE E - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board's Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2* – Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; or (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Common stocks*: Valued at the closing price reported on the active market on which the individual securities are traded.
- *Exchange traded funds ("ETFs")*: Valued at the daily closing price. ETFs are investment companies whose shares are traded intraday on stock exchanges at market-determined prices, which may be greater or less than net asset value. Plans may buy or sell ETF shares through a broker or in a brokerage account just as they would the shares of any publicly traded company. ETFs are registered with the SEC, and generally, are structured as open-ended investment companies (open-ended funds) or unit investment trusts.
- *Mutual funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### NOTE E - FAIR VALUE MEASUREMENTS (CONTINUED)

- *Corporate bonds:* Valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields, maturities, call features, and ratings of currently available on comparable securities of issuers with similar credit ratings.
- *U.S. government agency bonds, and municipal bonds:* Valued using pricing models maximizing the use of observable inputs for similar securities.
- *Government zeros:* Valued using pricing models maximizing the use of observable inputs for similar securities.
- *Government obligations:* Valued using pricing models maximizing the use of observable inputs for similar securities.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

#### **NOTE F - TAX STATUS**

The Plan has adopted a non-standardized pre-approved profit sharing/money purchase/CODA plan sponsored by Sentinel Benefits Group Inc. On November 30, 2020, the IRS stated in an opinion letter that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code ("IRC") and therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

#### **NOTE G - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Section 3(14) of ERISA defines a party in interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan, including the Plan Administrator or an employer whose employees are covered by the Plan. The Plan pays recordkeeping and investment advisory fees. As service providers to the Plan, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for recordkeeping were \$150,051, investment advisory fees were \$281,280 and audit fees were \$25,050 for the year ended December 31, 2024.

#### **NOTE H - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

#### **NOTE I - MUTUAL FUND**

Certain investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. 12b-1 fees are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940. These annual fees are used to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity, and thus not separately identifiable as an expense.

#### **NOTE J - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

### **Note K - Nonexempt Party-in-Interest Transaction**

#### **Prohibited transaction for late remittances**

During the year ended December 31, 2023, it was discovered that certain amounts withheld were not timely remitted to the Plan. The Plan Administrator deposited \$146 representing lost earnings into the Plan on October 7, 2024, in order to make the affected participants whole.
