## PROFESSIONAL HEALTHCARE RESOURCES 401(k) PLAN NOTES TO FINANCIAL STATEMENTS

### NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Professional Healthcare Resources 401(k) Plan (the "Plan"), sponsored by Professional Healthcare Resources, Inc. (the "Company"), provides general information only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan, originally effective January 1, 2001, and restated January 1, 2022, is a defined contribution plan covering all employees of the Company who have attained the age of 21 and completed three months of credited service, except for employees governed by collective bargaining agreements, nonresident aliens, and leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions** - Participants may contribute up to 100 percent of pretax and/or 100 percent of after-tax annual compensation, as defined in the plan document and allowed by law. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Company contributions are discretionary. During 2024, the Company did not make any contributions.

**Participant Accounts** - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, if any, and (b) Plan earnings, and is charged with an allocation of administrative expenses that are paid by the Plan, if any. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. Participants become 100 percent vested upon completing three years of service.

**Payment of Benefits** - Benefits are payable upon termination of employment, retirement, death or total disability. Participants may elect to receive benefits in a lump-sum or installments.

**Hardship Withdrawals** - The Plan allows for "hardship" withdrawals in accordance with the Internal Revenue Service regulations as specified in the Plan summary.

**Plan Expenses** - All costs and expenses with regard to the purchase or sale of investments are paid by the plan. Fees related to the administration of notes receivable from participants are charged directly to the participant's account. Investment related expenses are included in net appreciation of fair value of investments. Expenses paid by the Company are excluded from these financial statements. Personnel and facilities of the Company have been used by the Plan for its accounting and other activities at no charge to the Plan.

## PROFESSIONAL HEALTHCARE RESOURCES 401(k) PLAN NOTES TO FINANCIAL STATEMENTS

### NOTE 1 - DESCRIPTION OF THE PLAN (Continued)

**Forfeitures** - At both December 31, 2024 and 2023, forfeited non-vested accounts totaled \$9,268. These accounts will be used to reduce future company contributions and pay plan expenses.

**Notes Receivable from Participants** - Participants may borrow the lesser of \$50,000 (reduced by the participant's highest outstanding loan balance during the 12-month period ending on the date of the loan) or 50 percent of their vested account balance with a minimum loan amount of \$1,000. Loan terms range up to five years but may be extended if the proceeds are to be used for the purchase of a primary residence. Loans are secured by the balance in participants' accounts and bear interest at a rate from 3.25 to 10.5 percent. Principal and interest is paid ratably through payroll deductions.

### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Presentation** - The Plan financial statements have been prepared on the accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Risks and Uncertainties** - The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

*Payment of Benefits* - Benefits are recorded when paid.

*Fair Value Measurements* - ASC Topic 820 *Fair Value Measurements* defines fair value, establishes guidelines for measuring fair value, and expands disclosure regarding fair value measurements. The Plan follows the guidance in ASU 2015-07 which removed the requirement to categorize within the fair value hierarchy all investments for which fair value is measured using the net asset value (“NAV”) per share as quoted on a private market that is not active.

*Notes Receivable from Participants* - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

*Expenses* - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments.

*Disclosure of Subsequent Events* - Management has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

**NOTE 3 - SUMMARY OF CERTIFIED FINANCIAL DATA (UNAUDITED)**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company (“John Hancock”), the custodian for the Plan, has certified as to the completeness and accuracy of the investments and investment transactions of the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024. The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by John Hancock:

**NOTE 4 - INVESTMENTS MEASURED AT NAV USING THE PRACTICAL EXPEDIENT**

The Plan's pooled separate accounts are measured at NAV as a practical expedient to estimate fair value and, therefore, have not been classified in the fair value hierarchy.

Investments measured at NAV, which represents investments at fair value, were \$4,867,846 and \$4,850,541 at December 31, 2024 and 2023, respectively. Participants can redeem their investments in pooled separate accounts daily without notice. There are no unfunded commitments.

The Plan has identified the following classes of investment for its pooled separate accounts based on the nature and risks of the underlying investments. The following describes the significant investment strategies of each major class of investment.

- Target funds - Seeks to provide capital appreciation and current income with an asset allocation designed for those planning to retire and leave the workforce within a few years of the target date.
- Fixed income - Some funds in the category invest in debt securities such as bonds, U.S. government and agency securities, mortgage-backed securities, and zero-coupon securities with the goal of current income, capital preservation, and, to a lesser extent, capital appreciation.
- Small cap - Seeks to provide long-term growth of capital by primarily investing in companies with small market capitalizations.
- Mid cap - Seeks to provide long-term growth of capital by primarily investing in companies with mid-market capitalizations.
- Large cap - Seeks to provide long-term growth of capital by primarily investing in companies with large market capitalizations.
- U.S. equity - Funds are invested directly and/or indirectly in a diversified portfolio of domestic stocks to achieve a variety of investment goals including capital appreciation, current income, specific industry exposure, and/or domestic equity index replication (e.g., S&P 500 index).
- International equity - Funds are invested directly and/or indirectly in a diversified portfolio of stocks of companies internationally to achieve a variety of investment goals including capital appreciation and/or current income.

**NOTE 5 - TAX STATUS**

The Company has adopted a volume submitter plan document that received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020. The plan administrator believes the Plan has been operated in accordance with the applicable provisions of the Internal Revenue Code (IRC). The Company routinely self-reviews the administration of the Plan and self-corrects any compliance issues in accordance with the Employee Plan Compliance Resolution System. Accordingly, the plan administrator believes that the Plan is designed in accordance with the applicable sections of the IRC and, accordingly, are exempt from income taxes.

Accounting principles generally accepted in the United States of American require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for the plan years ending on December 31, 2021 or prior.

**NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS**

John Hancock is the Insurer of the Plan and holds and manages investments. Transactions with John Hancock are party-in-interest transactions, as defined by ERISA.

**NOTE 7 - TERMINATION PRIORITIES**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would immediately become 100% vested in their employer contributions.


