1. Description of Plan

The following description of the Pave Academy Charter School 401(k) Retirement Plan (the "Plan") is provided for general purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Pave Academy Charter School (the "School" or "Employer"). An employee is eligible for participation in the Plan upon the first day of the month following their hire date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Each year, eligible employees may elect to contribute on a pre-tax or after-tax (Roth) basis up to 80% of eligible compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. There is an annual limit as to the amount that can be deducted from the compensation that is determined by the Internal Revenue Code ("IRC"). Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The School will make a matching contribution equal to 100% of participant elective deferrals not to exceed 2% of participant eligible earnings.

Vesting

Participants are vested immediately in their contributions plus allocated earnings thereon. Vesting in the School's matching contributions are as follows:

<u>Years of Service</u>	<u>Percentage Vested</u>
Less than 1 year	0%
At least 1, but less than 2 years	50%
2 years or more	100%

Notes Receivable from Participants

Participants may borrow from their accounts a minimum amount of \$500 up to a maximum amount of the lesser of \$50,000 or 50% of the participant's vested account balance, reduced by, if any, of the participant's highest outstanding loan balance from the Plan during the previous one-year period. Loans must be repaid over a term not to exceed 5 years unless the proceeds of the loan are used to purchase the participant's principal residence, in which case the term is not to exceed 30 years. Principal and interest is paid ratably through periodic payroll deductions. Participants may have no more than one loan outstanding at any time.

1. Description of Plan (continued)

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the School's contributions and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

Upon termination of service due to death, disability, retirement or other reason, a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in his or her account.

Forfeitures

If a participant terminates their employment with the Company, the non-vested contributions may be used to reduce future Employer contributions. As of December 31, 2024 and 2023, the balance in the forfeiture account was \$2,404 and \$1714. During 2024, \$16,851 of forfeitures was used to reduce Employer contributions.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Also, certain administrative expenses of the Plan are paid by the Plan. Investment related expenses are included in net appreciation in fair value of investments.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

2. Summary of Significant Accounting Policies (continued)

Fair Value Measurements (continued)

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the net asset value (“NAV”) per share as a practical expedient are not categorized within the fair value hierarchy.

Investment Valuation and Income Recognition

All the Plan’s investments are stated at fair value. Mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily NAV and to transact at that price. These mutual funds are deemed to be actively traded. The common/collective trusts are valued at the NAV of units held by the Plan. The NAVs, as provided by the trustees, are used as a practical expedient and are based on the underlying investments held by the funds less their liabilities.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 14, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year), including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, a qualified institution.

5. Common/Collective Trusts

At December 31, 2024 and 2023, certain assets of the Plan were invested in State Street Common Collective Trusts, which include the: State Street Russell Small Cap Index Class VIII, State Street Cash Series US Govt, State Street S&P Mid Cap Index Class IX, State Street S&P 500 Index Class IX, and State Street International Index SL Class VIII.

The NAV per unit of each trust is determined each business day. Issuances and redemptions may be made on such days, based upon the NAV per unit as of the valuation date last preceding the date on which such order to contribute or redeem assets is received. The trustee of each trust, in its sole discretion, reserves the right to value any contribution or redemption as of the next succeeding valuation date or another date as the trustee deems appropriate.

6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

7. Tax Status

The prototype plan document preparer, ADP, LLC, has obtained an opinion letter dated October 6, 2020 from the Internal Revenue Service (“IRS”) stating that the Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

8. Party-in-Interest Transactions

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA.

9. Non-Exempt Party-in-Interest Transactions

For the 2024 and 2023 plan years, the Employer failed to transmit to the Plan contributions and loan repayments for participants totaling \$7,900 and \$8,271 within the period prescribed by Department of Labor regulations. The Company made the necessary corrections for the 2023 delinquent contributions during 2024 and is in the process of making the necessary corrections for the 2024 delinquent contributions.

10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
