## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator  
Rad Source Technologies, Inc. 401k Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the financial statements of Rad Source Technologies, Inc. 401k Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

**NOTE 1: PLAN DESCRIPTION**

The following description of the Rad Source Technologies, Inc. 401k Plan, (the "Plan") provides general information regarding the Plan. Refer to the Plan document for a complete description of Plan provisions.

*General*

The Plan is a defined contribution plan established by Rad Source Technologies, Inc. (the Plan "Sponsor" and "Company") under the provisions of Section 401(a) of the United States Internal Revenue Code (the IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company and any adopting participating employers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as well as certain provisions of the federal income tax laws.

*Administration*

The Company is the administrator of the Plan and, as such, carries out the duties imposed under ERISA. The Administrator has delegated certain responsibilities for the operation and administration of the Plan.

*Eligibility*

The Plan allows most employees who are age twenty-one or older to begin participating in the Plan after two months of service. Upon satisfying the eligibility requirements, employees may participate in the Plan on the first day of the next month.

*Contributions*

The Plan is funded through employee elective deferrals and Company contributions. Each year, participants may elect to contribute a portion of their compensation up to 100%, subject to certain maximum limitations imposed by Section 402(g) of the IRC. At the discretion of the Plan administrator, participants may be permitted to deposit or "roll over" into the Plan distributions they have received from other plans and certain Individual Retirement Accounts (IRAs). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Company has elected to operate the Plan as a safe harbor 401(k) plan, which makes the Plan exempt from certain compliance testing requirements. The Company makes enhanced safe harbor matching contributions of 110% of the participant's deferral up to 6% of the participant's salary contributed to the Plan.

*Vesting*

Participants are immediately 100% vested in their elective deferrals, including catch-up contributions, rollover contributions from other plans, safe harbor matching contributions, and actual earnings thereon. Accordingly, there were no forfeited amounts or balances in or at December 31, 2024 or 2023.

*Loans*

Participant loans are not allowed as part of the Plan.

*Benefit Payments*

On termination of service due to death, disability, retirement, or termination of employment, a participant may receive a lump-sum distribution or may elect annuity payments. In-service distributions may be taken for hardships as specified in the Plan document or when the participant reaches age 65.

*Participant Accounts and Investment Options*

Each participant's account is credited with the participant's contribution, allocation of the Company's contributions, and Plan earnings or losses, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations may be charged based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Upon enrollment in the Plan, a participant may direct the contributions made to the Plan, for or on behalf of the participant, to any one or more of the investment funds determined at the discretion of the Plan Administrator and Plan Sponsor and in such multiples as the participant prescribes. A participant may change his or her investment direction with respect to future contributions or redirect the investment of his or her account balances.

*Plan Expenses*

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

*Termination of the Plan*

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination, no further contributions will be made to the Plan, and all amounts credited to the participant's account will become 100% vested. The Company will direct the distribution of the participant's account in a manner permitted by the Plan as soon as practicable.

**NOTE 2: SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("US GAAP").

*Use of Estimates*

The preparation of financial statements in conformity with US GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Presentation, Valuation, and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

*Investment Presentation, Valuation, and Income Recognition (continued)*

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments, including realized gains and losses on sales during the year and current changes in unrealized appreciation (depreciation) in the market value of investments held at year-end, is presented in the statement of changes in net assets available for benefits.

*Contributions*

Contributions from Plan participants and employer contributions are recorded in the year in which the participant contributions are withheld from compensation.

*Payment of Benefits*

Benefits are recorded when paid.

**NOTE 3: INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE**

As of December 31, 2024, and for the year then ended, the Plan administrator elected, as permitted by Section 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, to have financial information certified by the trustee, Fidelity Management Trust Company. The following information was certified by the trustee as being complete and accurate and not subjected to normal audit procedures:

- a. Statement of Net Assets Available for Benefits – all investments at fair value.
- b. Statement of Changes in Net Assets Available for Benefits – Interest and dividend investment income, and net appreciation (depreciation) in fair value of investment accounts.
- c. Schedule H, Line 4i – Supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024.

**NOTE 4: FAIR VALUE MEASUREMENTS**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Accounting standards generally accepted in the United States establishes a hierarchy of inputs to valuation of that price using three levels described in the following:

Level 1 -- unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 -- other observable inputs (such as prices for similar assets in active markets, or the same asset in an inactive market)

Level 3 -- unobservable inputs based on the best information available in the circumstances, to the extent observable inputs are not available.

The hierarchy gives the highest priority to Level 1 inputs and the lowest to Level 3 inputs. Accordingly, the degree of judgement exercised in determining fair value is greatest for Level 3 assets.

**NOTE 4: FAIR VALUE MEASUREMENTS (continued)**

The Plan measures assets at fair value on a recurring basis and does not have any liabilities measured at fair value. Additionally, there are no assets or liabilities at fair value on a nonrecurring basis.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Interest-bearing cash and cash equivalents: Interest-bearing cash is valued at the market value of cash held by the Plan at year end.

Mutual funds: Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end based on quoted market prices.

Corporate stocks: Corporate stocks are valued at the closing price reported in the active market in which the individual securities are traded.

Corporate debt securities: Corporate debt securities are valued based on quoted market prices or model-driven valuations using significant inputs derived from or corroborated by observable market data.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5: PARTIES IN INTEREST**

The Plan used the services of Janney Montgomery Scott, LLC (investment advisor), Mersereau, Lazenby and Rockas, LLC (audit services), Fidelity Workplace Services, LLC (recordkeeping services), and Fidelity Management Trust Company (trustee and custodian services), which are parties in interest with respect to the Plan. Transactions with these service providers are not considered prohibited transactions under the IRC and are not prohibited by ERISA. Substantially all of the expenses of maintenance are paid directly by the Company and are excluded from these financial statements. However, certain fees for distributions from the Plan are charged directly to the participant's account and included in fees in the financial statements.

**NOTE 6: RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 7: TAX STATUS**

The Plan Sponsor adopted a plan that received a favorable volume submitter opinion letter from the Internal Revenue Service dated June 30, 2020, which states that the Plan is designed in accordance with the applicable sections of the IRC and is, therefore, not subject to tax under present income tax law. The Plan is required to operate in conformity with the IRC to maintain its qualification. Management is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not, based on the technical merits, would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the statute of limitations for the IRS to assess taxes on a plan expires three years from the due date of the return or the date on which it was filed, whichever is later.

**NOTE 8: SUBSEQUENT EVENTS**

Subsequent events have been evaluated through October 13, 2025, which represents the date the financial statements were available to be issued.
