Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan of Island Creek Associates, LLC (Company) and was established on January 1, 2013. The Plan is subject to the provisions of ERISA.

During January 2024, the Company provided written notification to John Hancock Life Insurance Company (U.S.A.) (John Hancock) of its termination of recordkeeping services for the Plan. Effective March 1, 2024, the Plan adopted the ADP Retirement Services Pre-Approved Plan (ADPRS plan) and the Company engaged ADP Retirement Services (ADPRS) as recordkeeper and administrative services provider to the Plan and Reliance Trust Company as directed trustee for the Plan. The Plan's assets were transferred from John Hancock to Reliance Trust Company on March 1, 2024. Significant changes to plan provisions upon the adoption of the ADPRS plan are discussed through these financial statements.

On December 29, 2022, the SECURE 2.0 Act of 2022 ("SECURE 2.0 Act") was signed into law. The SECURE 2.0 Act makes various required and optional changes applicable to tax qualified retirement plans with varying effective dates through 2027. Plan management is evaluating the impact of SECURE 2.0 Act and only mandatory changes to plan provisions have been made and are discussed throughout these financial statements. The plan document is required to be amended in regard to the requirements of SECURE 2.0 Act by December 31, 2026.

Eligibility: Employees are eligible to participate and enter the Plan for deferral contribution purposes once they have attained one month of service (one hour of service prior to March 1, 2024). Employees who are covered by a collective bargaining agreement, nonresident aliens with no U.S. earned income, leased employees, part-time employees (as defined), interns, individuals considered to be an independent contractor, and effective March 1, 2024, residents of Puerto Rico, are not eligible to participate in the Plan. Eligibility requirements for the Company safe harbor matching and discretionary matching contributions mirror those for deferral contributions.

Employees are eligible to participate in the Company non-elective contribution portion of the Plan upon attaining one year of service. Prior to March 1, 2024, employees must have also attained age 21. Entry dates are January 1 or July 1 following the date the eligibility requirements are met.

Contributions: Each year, participants may elect to contribute from 1% up to 90% of their eligible compensation (as defined) (100% prior to March 1, 2024), up to the maximum allowable contribution under the Internal Revenue Code (IRC). These contributions may be made as pre-tax or after-tax Roth deferral contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company provides for the following contributions on behalf of participants:

A safe harbor matching contribution, on a pay period basis, equal to 100% of the participant's elective deferrals not to exceed 4% of compensation, which include catch-up contributions. The Company's safe harbor matching contribution for 2024 totaled \$239,548.

Contributions - continued:

A discretionary matching contribution as determined by the Company. The contribution is to be allocated as a uniform percentage of matched employee contributions which include catch-up contributions. No discretionary matching contribution was made for 2024.

A discretionary non-elective contribution as determined by the Company. The contribution will be allocated in the same ratio as each participant's compensation bears to the total of such compensation of all participants. Prior to March 1, 2024, the contribution was allocated based upon the allocation group to which a benefiting participant is assigned. Participants will be eligible to share in the allocation of the discretionary non-elective contribution if they complete 1,000 hours of service in a plan year and are employed on the last day of the year. No non-elective discretionary contribution was made for 2024.

Qualified Nonelective Contributions (QNECs) and Qualified Matching Contributions (QMACs), as defined in the Plan. No QNECs or QMACs were made for 2024.

Participant Accounts: Each participant's account is credited with the participant's contributions and Company contributions, as well as allocations of plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings/losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options: Effective March 1, 2024, participants may direct the investment of their contributions and Company contributions into various registered investment companies (mutual funds) offered by the Plan. Prior to March 1, 2024, participants could direct the investment of their contributions and Company contributions into a Group Annuity Contract (the Contract) with John Hancock which contained various pooled separate accounts. For those participants who do not make an investment selection, their contributions and the related Company contributions are automatically invested in the Plan's qualified default investment account.

Vesting: Participants are immediately vested in their contributions, safe harbor contributions, prevailing wage contributions (previously contributed to the Plan), QNECs and QMACs plus earnings thereon. Vesting in the Company's discretionary matching and non-elective contributions are based on years of continuous service. A participant is 100 percent vested after six years of credited service. Regardless of the vesting schedule, participants will become fully vested upon death, total and permanent disability, or upon reaching the normal retirement age while still employed.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account, bear interest at prime plus 1% and can only exceed a repayment period of five years for the purchase of a principal residence. Only one note may be outstanding at a time. Principal and interest can be paid directly by the participant (at least quarterly) or through bi-weekly payroll deductions.

Payment of Benefits: Benefit payments may be in the form of lump sums, partial withdrawal payments, or substantially equal installments (effective March 1, 2024) and are payable upon termination of employment, death, disability or retirement at age 65. The Plan shall make automatic distributions of vested account balances that are less than \$7,000 in accordance with plan provisions. Effective March 1, 2024, distributions from a participant's rollover account may be made at any time. Hardship withdrawals and in-service withdrawals at age 59 ½ are also permitted, subject to provisions defined in the plan document.

Forfeitures: Forfeitures of the Company discretionary contribution portion of participants' accounts (due to participants' termination prior to full vesting) are to be used to pay administrative expenses. Any remaining forfeitures will be used first to restore previous forfeitures of participants' accounts of rehired employees and then are either allocated to participants as a discretionary contribution or used to reduce any combination of employer contributions. There are no forfeitures available in the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Basis of Accounting: The Plan's financial statements are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Plan's investment advisor, ADPRS and John Hancock (prior to March 1, 2024). See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Unit Values: Individual participant accounts for the pooled separate accounts (John Hancock through February 29, 2024) were maintained on a unit value basis. Participants did not have beneficial ownership in the specific underlying securities or other assets in the accounts, but did have an interest therein represented by units valued daily. The accounts earned dividends and realized gain distributions which were automatically reinvested in additional units. Unit values were calculated daily before taking into consideration unitholders' contributions and withdrawals made on that day. These transactions were then valued using those unit values and recorded for that day.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes are reclassified as distributions based on the terms of the plan document.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

Contributions: Contributions from plan participants and the safe harbor matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits: Benefits are recorded when paid. As of December 31, 2024 and 2023, there were no significant amounts due but unpaid to participants.

Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment management fees of individual fund investments are charged to the respective investment and included in the net appreciation/depreciation of the investment, as they are paid through revenue sharing. ADPRS and John Hancock recordkeeping fees, investment advisor fees, and fees related to the administration of notes receivable from participants and participant distributions were charged directly to the participant's account and were included in administrative expenses.

NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2

Inputs to the valuation methodology include (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; and (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts (through February 29, 2024): Unit value, as determined by John Hancock, based on the observable NAV of the underlying investments and adjusted for reinvested investment income or distribution of investment income from the underlying investments and John Hancock levied charges. The unit value is not a publicly-quoted price in an active market.

The underlying investments of the pooled separate accounts consisted solely of mutual funds, each of which followed a separate investment strategy. The Plan's pooled separate accounts were concentrated in target retirement date funds and their primary investment strategy was to seek capital growth and income until the account's target retirement date. The accounts primarily invested in assets in underlying funds using a predetermined "glide path". The glide path represented the shifting of asset classes over time with each account's asset allocation becoming more conservative as it approached its target retirement date.

The pooled separate accounts did not have unfunded commitments or significant restrictions on redemptions, as they could be redeemed daily. However, in the event an underlying investment or John Hancock determined that a fund transfer resulted in disruptive short term trading, trading restrictions may have been imposed and may have included restricting, the number of transfers made during a defined period, the dollar amount of transfers, the method used to submit transfers, and transfers into and out of certain investments.

NOTE 4 - INFORMATION CERTIFIED BY THE QUALIFIED INSTITUTIONS

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income on notes receivable from participants and dividend income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company and John Hancock, the qualified institutions.

NOTE 5 - TAX STATUS

The Internal Revenue Service (IRS) has determined and informed ADP, LLC, by a letter dated October 6, 2020, that the prototype plan adopted by the Plan effective March 1, 2024, is designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

The IRS had determined and informed CCH Incorporated, DBA ftwilliam.com, by a letter dated June 30, 2020, that the prototype plan adopted by the Plan through February 29, 2024, was designed in accordance with applicable sections of the IRC. Although the Plan had been amended since receiving the opinion letter, the plan administrator believed that the Plan was designed, and was currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believed that the Plan was qualified, and the related trust was tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

ADPRS provides certain administrative services to the Plan pursuant to the Administrative Services Agreement (the Agreement) between the Company and ADPRS. Pursuant to the Agreement, participants pay to ADPRS an annual recordkeeping fee and transactional fees relative to notes receivable from participants and participant distributions. In addition, ADPRS receives, as additional compensation, certain fees from one or more of the Plan's investment funds, or from affiliates or agents of such investment funds, for services provided by ADPRS with respect to such investment funds. These fees reduce the amount of expenses that would otherwise be payable pursuant to the Agreement. Further, ADPRS receives compensation in the form of interest or similar income (float) on contributions, plan loan repayments and withdrawals in process from the Plan. The Plan or Company may have made payments to ADPRS for administrative expenses not covered by revenue sharing. Fees paid by the Plan to ADPRS amounted to \$16,346 for 2024.

Prior to March 1, 2024, plan investments consisted of pooled separate accounts managed by John Hancock and therefore, these transactions qualify as party in interest transactions.

John Hancock provided certain administrative and recordkeeping services to the Plan pursuant to the Recordkeeping Agreement (the Hancock Agreement) between the Company and John Hancock. As stated in the Hancock Agreement, John Hancock received an asset charge based on the value of investments calculated monthly and fees related to the administration of notes receivable from participants and participant distributions. In addition, John Hancock received, as additional compensation, certain fees paid by the underlying source of the Plan's pooled separate accounts, for recordkeeping and other services provided to the Plan and short-term interest (float). The Plan or Company could make payments to John Hancock for administrative expenses not covered by revenue sharing. Fees paid by the Plan to John Hancock and included in administrative expenses amounted to \$4,018 for 2024.

NOTE 6 - RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS - CONTINUED

UBS Financial Services Inc. (UBS) provides certain investment management services pursuant to the UBS Retirement Plan Consulting Services Agreement (Services Agreement) between UBS and the Company. The Services Agreement provides for an annual fee, payable in quarterly installments, based on a percentage of the market value of plan assets. Fees paid by the Plan to UBS amount to \$12,031 for 2024.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their employer contributions.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits. As of December 31, 2024 and 2023, 75% and 79%, respectively, of net assets available for benefits is invested in the State Street Target Retirement Funds and John Hancock State Street Target Retirement separate accounts, respectively; however, by their nature, these accounts are a diversified mix of equities and fixed income that rebalance over time.

NOTE 9 - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, ADP Retirement Trust Services, LLC was appointed as the Plan's trustee upon the resignation of Reliance Trust Company on December 31, 2024.
