### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Sports Endeavors, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**Basis for Opinion**

#### Note 1. Description of Plan

The following description of the Sports Endeavors, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General:** Sports Endeavors, LLC (the Employer) established the Plan to provide employees with a systematic means of savings and investing for the future. Effective January 1, 2024 all employees are eligible to enroll for participation in the Plan after attaining 19 years of age and 90 days of service. An eligible employee enters the Plan on the first day of the new quarter upon satisfying the eligibility requirements described herein, unless participation is declined. Employees are eligible to receive Employer matching contributions upon the completion of one year of service, as defined by the Plan. The Sports Endeavors LLC 401(k) Retirement Plan Committee of the Employer control and manage the operation and administration of the Plan. Charles Schwab Trust Bank serves as the custodian of the Plan. MVP Plan Administrators, Inc. serves as the recordkeeper of the Plan. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Employer's Retirement Plan Committee is the Plan Administrator and is responsible for oversight of the Plan. The Retirement Plan Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance. All investments are 100% participant directed.

**Contributions:** Each year, participants may contribute compensation, as defined in the Plan document, subject to certain Internal Revenue Code (IRC) limitations. Participant salary deferrals may be traditional 401(k) (pretax) and/or Roth 401(k) (after-tax). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover contributions).

The Employer makes a safe harbor matching contribution of 100% of the first 3% and 50% of the next 3% of eligible compensation that a participant contributes to the Plan. Additional non-elective contribution amounts may be contributed at the discretion of the Employer's Board of Directors. No such additional contributions were made during the year ended December 31, 2024. Contributions are subject to certain limitations.

**Investment options:** Participants direct the investments of their accounts into various investment options offered by the Plan. The Plan currently offers mutual funds and a stable value collective trust fund as options for participants.

**Participant accounts:** Each participant's account is credited with the participant's contributions, Employer's contributions, and allocation of Plan earnings. Accounts are charged with benefit payments and allocations of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in participants contributions, Employer safe harbor matching contributions, rollover contributions, and Employer non-elective contributions plus actual earnings thereon upon enrollment in the Plan.

**Notes receivable from participants:** Participants may borrow from their accounts a minimum of \$750 up to a maximum equal to the lesser of \$50,000 reduced by the highest outstanding note balance on their account during the prior 12-month period, or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator, usually prime plus zero percent at the time of loan origination. Notes may not exceed five years unless the purpose of the loan is to acquire a primary residence. Principal and interest are paid ratably through payroll deductions.

#### Note 1. Description of Plan (Continued)

**Payment of benefits:** On termination of service, death, disability, retirement or other reasons a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or installments as provided by the Plan. Participants may make in-service withdrawals in cases of financial hardship, upon reaching the age of 59 ½, minimum required distributions upon reaching the age of 72, withdrawals of rollover contributions, qualified reservist distributions, and participants performing qualified military service. Participants may not withdraw an amount greater than the amount in their account.

#### Note 2. Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP).

**Use of estimates:** The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amount of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimate.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Payment of benefits:** Benefits are recorded when paid.

**Administrative expenses:** The Plan's administrative expenses are paid by the Plan or the Employer, as provided by the Plan document. Certain administrative functions are performed by employees of the Employer. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions (notes receivable from participants and distributions) are charged directly to the participant's account.

**Subsequent events:** The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

#### Note 4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Shares of registered investment companies:** These shares are valued at the daily closing price as reported by the fund. Shares of registered investment companies held by the Plan are open ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The shares of registered investment companies held by the Plan are deemed to be actively traded.

**Units of common/collective trust fund:** Valued at the NAV of units of the common/collective trust fund. The NAV, as provided by Fidelity, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

**Changes in fair value levels:** To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investment from one fair value level to another. In such instances, the transfer is reported at the end of the reporting period.

Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no significant transfers in or out of Level 3.

#### **Note 5. Plan Termination**

Although it has not expressed any intent to do so, the Employer has a right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

#### **Note 6. Tax Status**

The Plan adopted a non-standardized prototype non-standardized profit sharing plan sponsored by Schwab. The prototype plan has obtained a favorable determination letter dated June 30, 2020, in which the Internal Revenue Service stated that the prototype plan is in compliance with the applicable requirements of the IRC and, therefore, is exempt from income taxes. The prototype plan's opinion letter has been relied on by the Plan. The Plan has been amended since receiving this letter. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

#### **Note 7. Related-Party Transactions**

Certain plan investments are managed by Charles Schwab Trust Bank (the custodian) as defined by the Plan and, therefore, these transactions qualify as party-in-interest. Fees paid by the Plan to the trustee were \$15,474 for the year ended December 31, 2024.

Certain employees of the Employer are performing services for the Plan and are not compensated by the Plan. Certain other expenses of the Plan are paid by the Employer.

#### **Note 8. Risks and Uncertainties**

The Plan invested in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur in the near term and that such changes would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
