INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee and participants of the
Lionsgate 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Lionsgate 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (the financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of the report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current Plan instrument, including all Plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is substantial likelihood that, individually or in the aggregate, they would influence the judgement made by a reasonable user based on the financial statements.

For information

included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. Description of the Plan

The following description of the Lionsgate 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering eligible employees of Lions Gate Entertainment, Inc. and its subsidiaries and certain affiliates, as defined in the Plan document (collectively, the Company). All employees except union, nonresident aliens, leased employees, and residents of Puerto Rico become eligible to participate in the Plan immediately upon their date of hire, provided they are 18 years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2024, the Plan was amended to include Entertainment One Television Copyrights, Ltd. (eOne) as a participating employer following an acquisition by the Company. On January 1, 2024, employees of eOne were automatically enrolled in the Plan at the same contribution rate they used previously for the qualified retirement plan sponsored by eOne.

Effective April 16, 2024, the Plan was amended to merge the Pilgrim Studios 401(k) Plan (the Pilgrim Plan) into the Plan following an acquisition by the Company, and \$11,934,359 in assets were transferred into the Plan from the Pilgrim Plan. On January 1, 2024, previous participants of the Pilgrim Plan were automatically enrolled in the Plan at the same contribution rate they used previously in the Pilgrim Plan. For employees that were previously not eligible for the Pilgrim Plan who became eligible to participate in the Plan on January 1, 2024, were automatically enrolled in the Plan as if they were a new hire of the Company.

On December 16, 2024, the Company initiated a spin off of its Starz subsidiary. Effective December 30, 2024, a blackout of transactions in the Plan for employees in the Starz subsidiary was initiated, and the related assets were reallocated to the money market fund. On January 6, 2025, subsequent to year-end, approximately \$122 million in assets was transferred from the Plan to the Starz 401(k) Plan, a new plan for the spin off Starz entity.

Contributions

An employee is automatically enrolled in the Plan at a pre-tax contribution rate of 4% within 90 days after they satisfy the Plan's eligibility requirements, unless the employee elects otherwise. Participants may elect to contribute pre-tax and/or Roth contributions up to 90% of eligible compensation as defined by the Plan document, not to exceed \$23,000 in 2024. Additional catch-up contributions of up to \$7,500 may be made by those participants who have attained age 50 by the end of the Plan year. The Plan also provides for participant rollover contributions from other qualified retirement plans, including after-tax Roth contributions and in-plan Roth rollover contributions.

The Company makes a matching contribution to all eligible employees in the Plan, except those who were previously employed by Starz and certain subsidiaries, and are classified as an employee of the Starz business unit (Tenured Starz Employees), as defined in the Plan document. The matching contribution is equal to 100% of each participant's contribution up to 4% of their eligible compensation. The Company makes a matching contribution to Tenured Starz Employees equal to 100% of each participant's contribution up to 6% of their eligible compensation.

In addition, the Company may make an additional discretionary qualified matching contribution or profit sharing contribution. Employees must be employed on the last day of the Plan year to be eligible for the discretionary profit sharing contribution. For 2024, there were no qualified matching or profit sharing contributions made to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, the Company's contributions, and earnings and losses on the investments in their account, and is charged with certain fees related to specific transactions. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and rollovers plus actual earnings thereon. Vesting in the Company contributions portion of their accounts is based on years of continuous service. Participants vest at the rate of 50% per year from their hire date with 100% vesting occurring after completion of a participant's second year of service. Additionally, if a participant terminates employment due to death, disability, or retirement upon reaching normal retirement at age 55, that participant becomes 100% vested in all contributions plus actual earnings thereon which have been credited to their account. The Plan allows for recognition of service with some prior employers, as stated in the Plan document.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of their account. A participant may have two notes outstanding at any time. The notes are secured by the balance in the participant's account and bear a fixed rate of interest. During 2024, notes had fixed rates of interest ranging from 5.25% to 10.50% for the term of the note, not to exceed 5 years unless used for the purchase of a participant's principal residence. Principal and interest are paid through payroll deductions.

Payment of Benefits

At the time of death, disability, termination of service, or retirement, the participant or their beneficiary may receive payment of the vested interest in their account in a lump-sum distribution or installments. The participant's contributions may also be withdrawn for certain hardship situations. After attaining the age of 59 ½, participants may also be eligible to make an in-service withdrawal of all or part of their vested account. If a participant terminates employment and has an account balance less than \$7,000, the participant will automatically receive a lump-sum payment equal to the value of their account.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$882,725 and \$705,084, respectively. Forfeitures can be used to reduce the Company's contributions to the Plan or pay Plan administrative expenses. During 2024, no forfeitures were used to reduce the Company's contributions or pay Plan administrative expenses.

Administrative Expenses

Certain administrative expenses are permitted to be paid by the Plan in accordance with the Plan's provisions. Loan origination fees and certain transaction fees for withdrawals are charged directly to the respective participants' accounts that initiated such transactions. These expenses are paid to a service provider of the Plan and therefore qualify as party-in-interest transactions. Certain expenses incidental to the administration of the Plan are paid by the Company. The Company does not expect reimbursement from the Plan for any expenses paid on behalf of the Plan.

The Plan has established an ERISA account where the qualified institution deposits revenue sharing payments that are used to pay Plan administrative expenses. The account had an available balance of \$559 and \$342 as of December 31, 2024 and 2023, respectively. During 2024, \$217 of revenue sharing payments and investment earnings was deposited into the account, and no expenses were paid from the account. Fees incurred by the Plan for investment management services are included in net change in fair value of investments, as they are paid through revenue sharing rather than a direct payment.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Contributions

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The Company matching contributions are considered payable to the Plan when the related participant's contributions are payable to the Plan. The Company discretionary contributions are considered payable when they are approved by the Board of Directors of the Company. Any unfunded participant or Company contributions are included in participant or employer contributions receivable on the statements of net assets available for benefits as of December 31, 2024 and 2023.

In accordance with Financial Accounting Standards Board's Accounting Standards Codification 326, *Financial Instruments—Credit Losses*, the Company estimates the current credit risk associated with employer contribution receivables. The Company determined that no allowance for credit loss was necessary as of December 31, 2024 and 2023.

Valuation of Investments

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net change in fair value of investments includes interest and dividends, and realized and unrealized gains and losses on the respective investments. Interest income is recorded when received.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are carried at their outstanding balances plus accrued interest. Interest income is recorded when received by the Plan. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make note repayments and the plan administrator deems the participant note to be in default, the participant note balance is reduced, and a benefit payment is recorded. Notes receivable from participants also qualify as party-in-interest transactions.

Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued.

3. Information Certified by the Qualified Institution

All information in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and the net change in fair value of investments and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Bank of America, N.A., the Plan's qualified institution.

4. Investments

Investments are exposed to various risks such as interest rate, currency, market, and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include healthcare crises, such as a pandemic, international conflicts, supply chain disruptions, global monetary policy decisions, significant exogenous economic influences, significant cybersecurity attacks, or similar events. It is at least reasonably possible that changes in their fair value will occur in the near term and that such changes could materially affect participants' account balances.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for similar assets in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in mutual funds and the money market fund are based on quoted market prices for the identical asset in an active market (Level 1).

Fair value of the common/collective trust fund is determined by prices published daily by the trust manager, which is the net asset value (NAV) of the common/collective trust fund (Level 1). The common/collective trust fund invests in guaranteed investment contracts (GICs), synthetic GICs, and money market instruments. NAV is determined by the fair value of the underlying investments in the common/collective trust fund. Participants can trade the common/collective trust fund daily at its published NAV.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in all Company contributions.

6. Income Tax Status

The Plan is based on a Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA document (pre-approved plan) created by Merrill Lynch Pierce Fenner & Smith Inc (Merrill Lynch), an affiliate of the qualified institution. The Internal Revenue Service has determined and informed Merrill Lynch by a letter dated June 30, 2020, that the pre-approved plan document is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has not received an individual determination letter, and has been amended, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, accordingly, has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by tax authorities and may change upon examination.
