Notes to Financial Statements

Note 1: Description of Plan

The following description of the Hammes Company LLC 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The SECURE 2.0 Act of 2022 (SECURE 2.0), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provisions to elect in the future.

General

The Plan is administered by the Company. Fidelity Management Trust Company (Fidelity) is the trustee and record keeper.

Eligibility

Regular full-time employees are eligible to make salary deferral contributions upon their date of hire and reaching age 21. As of January 1, 2024, long-term part-time (LTPT), seasonal and limited-term employees who worked more than 500 hours in three consecutive years may enter the Plan on the first day of the month subsequent to satisfying their eligibility requirements in addition to reaching age 21. Prior to January 1, 2024, seasonal and limited-term employees were only eligible to participate in the Plan if they worked more than 1,000 hours during the Plan year and would enter the Plan on the first day of the month subsequent to satisfying their eligibility requirements, in addition to reaching age 21.

Participants in the Plan are eligible to receive Company discretionary matching and non-elective contributions following the completion of one year of service with at least 1,000 hours worked and reaching of age 21. The eligibility date for Company matching and non-elective contributions is the following first day of the month completing all eligibility requirements.

Note 1: Description of Plan (Continued)

Contributions

Each year, participants may contribute up to 60% of pretax annual compensation, as defined in the Plan, as well as a separate deferral election that may be made for bonuses received and special voluntary tax-deferred contributions, subject to limitations imposed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan after 30 days of employment unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation.

The Company provided a discretionary matching contribution up to 50% of the first 6% of each participant's eligible compensation for year ended December 31, 2024. Additionally, a non-elective contribution may also be contributed at the discretion of the Company. During the year ended December 31, 2024, there were no discretionary non-elective contributions made.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company matching contributions, and allocations of (a) the Company's non-elective contribution and (b) Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of a participant's account is based on the number of years of service.

Matching and non-elective contributions vest according to the following schedule:

Participants are considered to have completed one year of service for purposes of vesting upon the completion of 1,000 hours of service at any time during 12 consecutive months for non-LTPT employees and 500 hours of service at any time during 12 consecutive months for LTPT employees.

Vesting (Continued)

Participants are automatically fully vested upon attainment of age 62 or upon early retirement at age 55, disability or death.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$51,813 and \$35,342, respectively. These accounts will be used to reduce future Company contributions or to pay administrative expenses of the Plan in accordance with the Plan document. During 2024, \$9,000 was used to reduce administrative expenses from forfeited nonvested accounts.

Payment of Benefits

On retirement, death, disability, or termination, a participant or the participant's beneficiary may elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account. Participant accounts with values less than \$1,000 will be paid in a lump sum distribution as soon as administratively feasible. For participants with account balances ranging between \$1,000 and \$7,000 who have not made an election to rollover their funds or take a cash distribution will have their account distributed into an individual retirement account as directed by the Plan Administrator as soon as administratively feasible. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Participants are limited to one loan outstanding at any given time. The notes are secured by the balance in the participant's account and bear interest at a fixed rate, which is determined by the Plan Administrator. As of December 31, 2024 and 2023, all outstanding loans bear interest at 4.25%. Principal and interest are paid ratably through payroll deductions.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are allocated proportionately to Plan participants based on their respective account balances and are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 9, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels. Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual and money market funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage account: Accounts primarily consists of mutual funds, common stock, preferred stock, and corporate bonds that are valued on the basis of readily determinable market prices.

The following tables set forth by level, within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

Note 4: Information Prepared and Certified by Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivables from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Fidelity.

Note 5: Party-in-Interest Transactions

Transactions involving participant notes receivable and investment funds administered by affiliates of Fidelity are considered party-in-interest transactions. These transactions are not however, considered prohibited transactions under 29 CFR 408(b) for the ERISA regulations.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

Note 7: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8: Tax Status

The Plan adopted a prototype plan with an IRS notification letter which states the prototype plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan Administrator believes the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC and accordingly, believes the Plan is exempt from federal and state income taxes.

Notes to Financial Statements

Note 1: Description of Plan

The following description of the Hammes Company LLC 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The SECURE 2.0 Act of 2022 (SECURE 2.0), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provisions to elect in the future.

General

The Plan is administered by the Company. Fidelity Management Trust Company (Fidelity) is the trustee and record keeper.

Eligibility

Regular full-time employees are eligible to make salary deferral contributions upon their date of hire and reaching age 21. As of January 1, 2024, long-term part-time (LTPT), seasonal and limited-term employees who worked more than 500 hours in three consecutive years may enter the Plan on the first day of the month subsequent to satisfying their eligibility requirements in addition to reaching age 21. Prior to January 1, 2024, seasonal and limited-term employees were only eligible to participate in the Plan if they worked more than 1,000 hours during the Plan year and would enter the Plan on the first day of the month subsequent to satisfying their eligibility requirements, in addition to reaching age 21.

Participants in the Plan are eligible to receive Company discretionary matching and non-elective contributions following the completion of one year of service with at least 1,000 hours worked and reaching of age 21. The eligibility date for Company matching and non-elective contributions is the following first day of the month completing all eligibility requirements.

Note 1: Description of Plan (Continued)

Contributions

Each year, participants may contribute up to 60% of pretax annual compensation, as defined in the Plan, as well as a separate deferral election that may be made for bonuses received and special voluntary tax-deferred contributions, subject to limitations imposed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan after 30 days of employment unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation.

The Company provided a discretionary matching contribution up to 50% of the first 6% of each participant's eligible compensation for year ended December 31, 2024. Additionally, a non-elective contribution may also be contributed at the discretion of the Company. During the year ended December 31, 2024, there were no discretionary non-elective contributions made.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company matching contributions, and allocations of (a) the Company's non-elective contribution and (b) Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of a participant's account is based on the number of years of service.

Matching and non-elective contributions vest according to the following schedule:

Participants are considered to have completed one year of service for purposes of vesting upon the completion of 1,000 hours of service at any time during 12 consecutive months for non-LTPT employees and 500 hours of service at any time during 12 consecutive months for LTPT employees.

Vesting (Continued)

Participants are automatically fully vested upon attainment of age 62 or upon early retirement at age 55, disability or death.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$51,813 and \$35,342, respectively. These accounts will be used to reduce future Company contributions or to pay administrative expenses of the Plan in accordance with the Plan document. During 2024, \$9,000 was used to reduce administrative expenses from forfeited nonvested accounts.

Payment of Benefits

On retirement, death, disability, or termination, a participant or the participant's beneficiary may elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account. Participant accounts with values less than \$1,000 will be paid in a lump sum distribution as soon as administratively feasible. For participants with account balances ranging between \$1,000 and \$7,000 who have not made an election to rollover their funds or take a cash distribution will have their account distributed into an individual retirement account as directed by the Plan Administrator as soon as administratively feasible. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Participants are limited to one loan outstanding at any given time. The notes are secured by the balance in the participant's account and bear interest at a fixed rate, which is determined by the Plan Administrator. As of December 31, 2024 and 2023, all outstanding loans bear interest at 4.25%. Principal and interest are paid ratably through payroll deductions.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are allocated proportionately to Plan participants based on their respective account balances and are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 9, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels. Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual and money market funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage account: Accounts primarily consists of mutual funds, common stock, preferred stock, and corporate bonds that are valued on the basis of readily determinable market prices.

The following tables set forth by level, within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

Note 4: Information Prepared and Certified by Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivables from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Fidelity.

Note 5: Party-in-Interest Transactions

Transactions involving participant notes receivable and investment funds administered by affiliates of Fidelity are considered party-in-interest transactions. These transactions are not however, considered prohibited transactions under 29 CFR 408(b) for the ERISA regulations.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

Note 7: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8: Tax Status

The Plan adopted a prototype plan with an IRS notification letter which states the prototype plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan Administrator believes the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC and accordingly, believes the Plan is exempt from federal and state income taxes.
