

## Notes to Financial Statements

- 1. Description of the Plan** The following description of the Selway Machine Tool Co., Inc. Employee Stock Ownership Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all employees of Selway Machine Tool Co., Inc. (the "Company") who are at least 21 years old and who have completed one year of service, except for nonresident aliens, employees covered by a collective bargaining agreement, and leased employees. Each eligible employee shall become a participant on the January 1 or July 1 coincident with or next following the date eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Contributions:** Each year, the Company makes contributions to the Plan at the discretion of the Company's Board of Directors. In addition, the Company contributes amounts necessary to pay benefits to participants. Effective January 1, 2022, participants must complete at least 1,000 hours of service during the Plan year and be active on the last day of the Plan year to receive an allocation of the Company's contributions. Prior to January 1, 2022, participants were eligible to participate in the Plan retroactively to the first day of the Plan year in which the participant completed 1,000 hours of service. Participants who retire, become disabled, or die during the Plan year are also eligible to receive an allocation of the Company's contributions. There were no Employer contributions for the year ended December 31, 2024. The Plan does not permit any contributions from its participants. Contributions are subject to certain limitations.

**Participant accounts:** Each participant's account is credited with an allocation of Company contributions, if any, Plan earnings (losses) and forfeitures of terminated participants' non-vested accounts, if any. Allocations of contributions and forfeitures, if any, are based on the ratio of the participant's eligible compensation to total eligible compensation for the Plan year, as defined in the Plan document. Allocations of Plan earnings (losses) are based on account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Vesting in the Company contributions is based on years of continuous service of at least 1,000 hours per Plan year. A participant is 20 percent vested after two years of service is completed, and vests an additional 20 percent per year until full vesting after six years. Additionally, if an active participant reaches retirement, dies, or becomes disabled, that participant becomes fully vested in the allocated account.

**Forfeited accounts:** Forfeited nonvested accounts are allocated to remaining participants on an annual basis. Forfeitures of terminated non-vested accounts are allocated to remaining participants on an annual basis as of the last day of the Plan year. Participants must complete 1,000 hours of service and be employed on the last day of the Plan year to be eligible to receive an allocation of the forfeitures. Forfeitures allocated to remaining participants for the year ended December 31, 2024 totaled 155.26567 shares of Company stock.

**Payment of benefits:** Benefits are payable upon retirement after reaching the later of age 65 or five years of participation, disability, death, or termination of employment. Distributions due to retirement, death and disability shall commence no later than the subsequent Plan year. Distributions due to termination shall commence no later than the sixth Plan year following the termination. Benefits are payable in lump sum or substantially equal annual installments over a period not exceeding five years.

**Diversification:** Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments that are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25 percent of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent.

**Put option:** Under federal income tax regulations, any Company stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no active market. The put price is representative of the fair value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

**Administrative expenses:** Certain expenses of maintaining the Plan are paid by the Company.

## Notes to Financial Statements

**Voting rights:** Participants will be entitled to exercise voting rights attributable to the shares of Company stock allocated to their accounts in the Plan with respect to certain major corporate matters, such as mergers, consolidations, sale of all assets, or the liquidation of the Company. The Plan Trustees vote on all other corporate matters.

### 2. Significant accounting policies

**Basis of accounting:** The financial statements of the Plan are prepared under the accrual method of accounting.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the independent appraiser. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Dividend income is accrued on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments held during the year.

**Cash:** The Plan maintains its cash in bank deposit accounts at one commercial bank. These balances can exceed the Federal Deposit Insurance Corporation ("FDIC") insured limit of \$250,000 per financial institution. At December 31, 2024 and 2023, cash balances held at the commercial bank exceeded the FDIC insured limit by approximately \$229,420 and \$561,625, respectively. The Plan has not experienced any losses through the date when the financial statements were available to be issued and believes it is not exposed to any significant credit risk on cash.

**Payment of benefits:** Benefits are recorded when paid.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Subsequent events:** The Plan has evaluated subsequent events for disclosure in these financial statements through October 14, 2025, which is the date the financial statements were available to be issued.

- 4. Fair value measurements** The Plan reports its assets at fair value based on a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

The Plan's investment in shares of the Company's common stock is reported at its fair value as determined by an independent appraiser retained for this purpose by the Plan's trustee. The independent fair value appraisal is dependent upon historical and forecasted operations of the Company as represented by management, and general industry and market conditions affecting the Company's business. The fair value appraisal was determined using a combination of the income and market approaches. Within the income approach, the discounted future cash flow method was used. Within the market approach, the merger and acquisition method was used.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- 6. Tax status** The Internal Revenue Service (“IRS”) has determined and informed the Plan administrator by letter dated June 12, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended and restated since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.
- Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
- 7. Plan termination** Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.
- 8. Party-in-interest transactions** The Plan invests in Company common stock. These are related party and party in interest transactions. As described in Note 1, the Company pays certain plan expenses. The Plan has a number of service providers. Such providers are parties in interest under ERISA.
