Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of HBA Health Systems, LLC 401(k) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (2024 Financial Statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1. Description of Plan

The following description of HBA Health Systems, LLC 401(k) Retirement Savings Plan (the “Plan”), as amended, provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan, which was created on July 1, 1991, is classified as a 401(k) profit-sharing plan, covering employees with at least 1,000 hours of service during the Plan year, with at least one year of service, and who are age 18 or older. The primary purpose of the Plan is to reward eligible employees of HBA Health Systems, LLC and affiliates (collectively, the “Company” / “Plan Sponsor”) for long and loyal service by providing them with financial benefits upon retirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year, participants may elect to contribute up to 50% of their gross compensation, not to exceed Internal Revenue Service (“IRS”) limits, through a salary reduction agreement, and contributions may be made as pre-tax or after-tax (Roth) contributions. The Company contributes 25% of participants’ elective contributions up to 4% of their annual compensation and can make an additional discretionary contribution. During the year ended December 31, 2024, the Company did not make any discretionary contributions in addition to the previously noted matching contribution.

Participant Investment Account Options

Participants direct the investment of their accounts into various investment options offered by the Plan. Investment account options available include a fully benefit-responsive investment contract and registered investment companies.

Participant Accounts

Under the Plan, a separate account is maintained for each participant. Each participant’s account is credited with the participant’s contribution, employer contribution, and allocations of Plan earnings, and charged with an allocation of administrative expenses, if any. Participant contributions and employer matching contributions are allocated, at the participant’s election, to investment funds held at Empower Trust Company, LLC (the “Plan Custodian”). Participants may change their investment options at any time with certain exceptions. Plan earnings are allocated based on the actual earnings of the respective participants’ investments. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant’s account.

Vesting

Participants are immediately vested in their own contributions and rollover accounts, plus actual earnings thereon. Vesting in the employer-contributed portion of their accounts is based on years of continuous service as follows:

Participant Loans

Participant loans are not permitted by the Plan.

Payment of Benefits

Upon the death, permanent disability, or retirement of participants, their entire account balances become fully vested. Distribution of benefits may be made in a lump-sum cash payment or in an annuity. Participants who terminate for reasons other than death, disability, or retirement are entitled only to their vested balances. As of December 31, 2024 and 2023, there were no amounts allocated to the accounts of individuals who have elected to withdraw from the Plan but had not yet been paid.

Note 2. Summary of Significant Accounting Policies

The following is a summary of significant accounting policies followed in the preparation of these financial statements, which have been prepared in accordance with accounting principles generally accepted in the United States of America.

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Forfeitures

Forfeitures of terminated participants' non-vested accounts are used to reduce employer matching contributions. The unallocated balance of forfeitures was approximately \$53,000 and \$2,000 as of December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, no forfeitures were used to reduce employer matching contributions.

Investment Valuation and Income Recognition

Investments in registered investment companies are valued based upon quoted market prices or are valued at net asset values calculated daily by the fund administrator, based upon the market value of the underlying securities held by the fund, less unpaid expenses.

The Plan Custodian offers a fully benefit-responsive investment contract ("FBRIC"), which has a Guaranteed Interest Fund ("GIF") as the only underlying investment option. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to the FBRIC, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan (see Note 4). Contract value, as reported by the issuer, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

The preceding methods described may produce a fair value or contract value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of marketable securities are recorded on a trade-date basis, and interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date.

In accordance with the Plan's policy of stating marketable securities at fair value, the change in fair value for the year is reflected in the statement of changes in net assets available for benefits as net appreciation in fair value of investments.

Contributions

Contributions to the Plan are recorded in the period in which they became obligations of the Plan Sponsor.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative and Expenses

The Plan's administrative expenses are shared by the Plan and the Company, as provided by the Plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles, and with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results may differ from those estimates.

Subsequent Events

The Company has evaluated subsequent events for recognition and disclosure through October 13, 2025, which is the date the financial statements were available to be issued.

Note 3. Certification of Custodian

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan Custodian, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Fully Benefit-Responsive Investment Contracts

The Plan has entered into a Group Fixed Deferred Annuity Contract with Empower Annuity Insurance Company of America (“Empower”) where the contract is deemed fully benefit-responsive. The Plan Custodian is a wholly owned subsidiary of Empower. The GIF is the only available investment option in the contract and is a fixed account that is part of the general account of Empower. Interest earned on the GIF value is compounded daily to the effective annual interest rate. The interest rate to be credited to the Plan’s assets in the GIF during the calendar quarter will be determined by Empower prior to the last day of the previous calendar quarter and shall be reset at least quarterly. The effective annual interest rate will never be less than 0%. The interest rate is declared quarterly, with interest credited on a daily basis at an annual effective rate on a portfolio basis.

The Plan’s ability to receive amounts due in accordance with the fully benefit-responsive contract is dependent upon the third-party issuer’s ability to meet its financial obligations. Empower’s ability to meet its contractual obligations may be affected by future economic and regulatory developments. If a participating plan terminates participation in the contract, the lesser of the guaranteed value or the fair value, as defined in the contract, will be received. The Company believes that there are no events that are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer.

Note 5. Fair Value Measurements

The fair value of financial instruments is presented based upon a hierarchy of levels that prioritize the inputs of valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The three levels of the fair value hierarchy are described below:

- Level 1** Unadjusted quoted prices in active markets for identical assets or liabilities the Plan has the ability to access at the measurement date.
- Level 2** Inputs to the valuation methodology that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3** Significant, unobservable inputs used for valuing the asset or liability in which little or no market data exists.

Note 6. Exempt Party-In-Interest Transactions

Certain plan investments are funds managed by the Plan Custodian as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. During 2024, administrative, advisory services, and other custodian costs associated with investment accounts of approximately \$77,000 were charged directly to the Plan. The Company also absorbs significant costs related to various administrative and investment advisory services on behalf of the Plan.

Note 7. Risks and Uncertainties

The Plan’s investments are not insured and are subject to credit and market risks. Financial information relating to those investments is included in these financial statements based on information provided by the Plan Custodian.

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Income Tax Status

The original plan is a prototype plan prepared and maintained by a third party. The prototype plan obtained its latest determination letter on November 14, 2022, in which the IRS stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). The adopted Plan has been amended since receipt of the determination letter; however, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Note 9. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the termination of the Plan, participants will become 100% vested in their accounts and the Plan assets shall be distributed in proportion to participants' respective account balances as of the date of termination.
