INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the

SCOPE AND NATURE OF THE ERISA SECTION 103(A)(3)(C) AUDIT

We performed audits of the accompanying financial statements of the R.W. Warner, Inc. Profit Sharing and 401(k) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the related Statement of Changes in Net Assets Available for the year ended December 31, 2024, and the related notes to the financial statements.

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTE 1 **DESCRIPTION OF PLAN**

The following brief description of the R.W. Warner, Inc. Profit Sharing and 401(k) Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement for more complete information.

General

The Plan is a defined contribution plan covering all full-time employees of R.W. Warner, Inc. and Warner Service of Frederick, MD LLC (collectively referred to as the Company) who are at least 18 years old and who complete 60 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Investment Options

Upon enrollment in the Plan, a participant may direct contributions to various investment options. Specific information regarding these options may be obtained from the Plan Administrator. Participants may change their investment options at any time.

Contributions

Participants are allowed to contribute up to 100% of compensation to the Plan, as defined, subject to Internal Revenue Code limitations, including catch-up contributions if applicable. Contributions may be designated by the participant for either a pre-tax deferral or an after-tax Roth deferral. All participants are automatically enrolled to make a 3% deferral unless the participant requests otherwise.

The Company may make annual discretionary contributions. These contributions are allocated based on the relative percentage of the participant's contribution to the total of all participant contributions for the year. To receive a Company contribution, the participant must be actively employed on the last day of the Plan year.

Participant Accounts

Each participant's account is credited with the participant's contribution, an allocation of the Plan's earnings, and any discretionary Company contributions. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants become 100% vested in Company contributions after six years of service (except upon death or disability as defined in the Plan Agreement).

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant or participant's beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's account or roll the balance into another qualified plan. If the balance of the account is less than \$1,000, the balance is automatically distributed in a lump-sum payment.

Forfeitures

At December 31, 2024 and 2023, there were \$18 and \$980 outstanding forfeited non-vested accounts, respectively. These accounts are used to reduce Plan expenses. In 2024, Plan expenses were reduced by \$15,545 from forfeited non-vested accounts.

Notes Receivable From Participants

Participants may borrow an amount from the Plan collateralized by their account balances. The maximum note permitted is the lesser of (1) \$50,000 or (2) 50% of the participant's vested account balance. Principal and interest are paid ratably through weekly payroll deductions. Notes receivable mature within five years or a period to be determined by the Company for the purchase of a primary residence.

Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. Upon termination of the Plan, all interests of the participants not previously vested would become vested and nonforfeitable, and the net assets of the Plan would be distributed to participants based upon individual equities in the Plan.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Accounting Standards Codification

All references in the financial statements to the Codification refer to the Accounting Standards Codification and the Hierarchy of Generally Accepted Accounting Principles (GAAP) issued by the Financial Accounting Standards Board. The Codification is the single source of authoritative GAAP in the United States.

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with GAAP in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Valuation of Investments

Investments are stated at fair value. See Note 4 for a discussion of fair value measurements.

Payments of Benefits

Benefits are recorded when paid.

Risks and Uncertainties

The Plan provides for investments in various investment securities, which are exposed to various risks, such as interest rate, credit, and overall volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

Notes Receivable From Participants

Notes receivable from participants are carried at their unpaid principal balance plus accrued interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan Agreement.

Subsequent Events

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through October 8, 2025, the date the financial statements were available to be issued.

NOTE 3 INFORMATION CERTIFIED BY THE TRUSTEE

Matrix Trust Company is the Trustee for the Plan. Financial information related to those investments is included in the accompanying financial statements based on information certified as complete and accurate by the Trustee. NOTE 4 VALUATION OF INVESTMENTS

The Fair Value Measurements and Disclosures Topic of the Codification establishes a hierarchal disclosure framework, which prioritizes and ranks the level of market price observability used in measuring investments and other financial instruments at fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Below is a description of the valuation methodology used for assets measured at fair value. There were no changes in the methodology used at December 31, 2024 and 2023.

Money Market and Mutual Funds: Valued at the net asset value (NAV) of shares held by the Plan at year end. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 TAX STATUS

The Plan adopted a non-standardized prototype plan sponsored by Northwest Plan Services that became effective November 1, 2021. The Internal Revenue Service provided an opinion letter stating the prototype plan is designed in accordance with applicable sections of the Internal Revenue Code. The Plan was amended since receiving the determination letter. The Plan Administrator believes the Plan is currently designed and operating in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes was included in the Plan's financial statements.

GAAP requires Plan management to evaluate uncertain tax positions for recognition in the financial statements. The Plan Administrator concluded there were no uncertain tax positions as of December 31, 2024.

NOTE 6 RELATED-PARTY TRANSACTIONS

The Plan pays audit and investment management service fees to parties in interest. The Plan paid \$90,253 to parties in interest for the year ended December 31, 2024. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA. In addition, administrative fees were paid indirectly through revenue sharing and are included in the net appreciation in fair value of investments.
