## INDEPENDENT AUDITOR'S REPORT

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the financial statements of Questec 401(k) Defined Contribution Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**NOTE 1: DESCRIPTION OF THE PLAN**

The Questec 401(k) Defined Contribution Retirement Plan was established effective as of January 1, 1997, and amended most recently, effective January 1, 2024, to remove the safe harbor match and add a safe harbor non-elective contribution. The Summary Plan Description was rewritten effective January 1, 2024. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering substantially all employees of Questec Constructors, Inc., Questec Arkansas LLC, Questec Base Station LLC, Questec Columbia LLC, Questec Louisville LLC, and Questec St Louis LLC, who are age eighteen or older. There is no service requirement to be eligible for the Plan and the entry date is the first day of each month. If an employee is hired under a prevailing wage contract, for purposes of receiving any prevailing wage contribution made to the Plan, those employees are eligible to participate on the date of hire. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Plan participation is voluntary. Excluded employees are certain nonresident aliens who have no earned income from sources within the United States; employees covered by a collective bargaining agreement; and certain temporary employees.

**Contributions**

Each year, participants may elect to defer up to the maximum established by law, \$23,000 for 2024, with \$30,500 for employees age 50 or older. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Effective January 1, 2024, the Plan will make a safe harbor non-elective contribution to the Plan in an amount equal to 7% of eligible compensation. For the Plan year ended December 31, 2023, the Company made a safe harbor matching contribution to the Plan in an amount equal to 100% of the first four percent of eligible compensation and 50% of the next two percent of eligible compensation. The Company may make annual discretionary profit sharing contributions in an amount to be determined at Plan year end by the employer. Employees must be employed as of the last day of the Plan year to be eligible for the discretionary profit sharing contributions for that Plan year. No discretionary profit sharing contributions were made for the Plan years ended December 31, 2024 and 2023. Contributions are subject to certain limitations.

The Plan contains an automatic enrollment feature which will automatically defer 5% of each participant's compensation upon meeting the eligibility requirements unless a greater or lesser (including zero) percentage is elected by the participant.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions, (b) Plan earnings, (c) loan activity, if applicable, (d) forfeitures of terminated participants' nonvested accounts and charged with an allocation of administrative expenses. Allocations are based on participant earnings, the employee match calculation and compensation, as defined, and the prevailing wage contributions according to prevailing wage laws. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment Options**

Upon enrollment in the 401(k) Plan, a participant may direct Plan assets to any or all 18 investment options offered. Participants may change their investment options at any time.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of one-half of the participant's vested account balance or \$50,000. A participant may only have one outstanding loan at any time. The loans are secured by the balance in the participant's account and bear a reasonable interest rate determined by the Plan Administrator; current loans outstanding are at rates between 5.25% and 10.50%. All loans are considered a directed investment of the participant's account under the Plan, and all payments of principal and interest by the participant on a loan will be credited to the participant's account.

Payment of Benefits

A participant is eligible to request a distribution of their vested account balance based upon any of the following events: death, disability, normal retirement, required minimum distributions, and termination of employment. The payment may be in the form of a single lump-sum payment, direct rollover distribution, or a combination of non-rollover distribution and direct rollover. Installment or partial distributions over a period of not more than the participant's assumed life expectancy can be made with respect to minimum required distributions. For termination of service for reasons other than death, disability or normal retirement, the participant will receive the value of the vested account balance as a complete distribution, either lump-sum payment or direct rollover, if the vested account balance does not exceed \$7,000. The Plan does permit in-service distributions prior to termination of employment of fully vested amounts for participants that have attained 59.5 years of age.

Plan Termination

The employer has the right to amend or terminate the Plan at any time. Each participant in the Plan upon Plan termination will automatically become 100% vested in their account balance.

**NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Plan Merger**

Effective May 1, 2023, the account balances of Clearview Enterprises LLC employees from the HTH Companies, Inc. Retirement Plan were merged into this Plan. Total investments of \$531,213 were transferred from the HTH Companies, Inc. Retirement Plan to this Plan as of May 1, 2023.

**Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$88,379 and \$15,297, respectively. These accounts can be used to pay administrative expenses and any remaining amounts may be used to reduce future employer contributions. For the Plan years ended December 31, 2024 and 2023, employer contributions were reduced by \$0 and \$0, respectively, from forfeited nonvested accounts.

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting.

**Investment Valuation and Income Recognition**

The investments in the underlying mutual funds are carried at fair value. The Plan provider calculates the fair value using internal unit values based upon the change in quoted prices in active markets of the net asset values of the underlying mutual fund investments, dividends and capital gain or loss distributions. See Note 4 for discussion of fair value measurements. Third party administrator expenses are allocated and deducted from each participants' account. Administrative expenses, such as audit and legal fees, are absorbed by the Plan sponsor. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

Investment contracts held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

**Notes Receivable from Participants**

Participant loans are measured at amortized cost, which is their unpaid principal balance plus accrued but unpaid interest. No allowance for doubtful accounts is required as participants have the option of repaying the loan or having the loan distributed to them upon termination. A loan will be processed as a deemed distribution if it is not repaid immediately in full upon termination in accordance with the Plan document.

**Payment of Benefits**

Benefits are recorded when paid.

**Income Tax Status**

The IRS has determined and informed the plan sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the Determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Estimates

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**NOTE 4: FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1     Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has ability to access.
- Level 2     Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3     Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**NOTE 4: FAIR VALUE MEASUREMENTS (CONTINUED)**

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

- Money Market Funds: Valued at net asset value of shares held by the Plan. The assets are valued at published closing price in active markets.
- Mutual Funds: Valued at net asset value of shares held by the Plan. The assets are valued at published closing price in active markets.

**NOTE 5: RELATED PARTY TRANSACTIONS**

Plan investments include shares of mutual funds, managed by Fidelity who is also the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services are absorbed by the mutual funds and reflected in the funds fair value. Certain other expenses are absorbed by the Plan sponsor.

**NOTE 6: RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with the certain investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the Statement of Net Assets Available for Benefits.
