### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Health and Safety Institute 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

## Notes to Financial Statements

---

### 1. Plan Description

The following description of Health and Safety Institute 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan, which covers substantially all employees of HSI Workplace Compliance Solutions, Inc. (the Company) and is designed to provide benefits upon retirement, termination, death, or disability. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### *Administration of the Plan*

Charles Schwab Trust Bank is the Plan custodian. First Hill Trust Company is the trustee. The administrator of the Plan is the Company.

#### *Eligibility*

Employees become eligible to participate upon reaching the age of 21.

#### *Contributions*

Participants may elect to contribute a portion of their compensation through a pre-tax and/or Roth contribution to the Plan, up to the maximum allowed under the Internal Revenue Code (IRC). Participants may also contribute amounts representing rollovers from other qualified plans.

The Company makes a safe harbor matching contribution of 100% of the participant's contribution up to 4% of compensation.

The Company may also contribute a discretionary profit-sharing contribution. Participants must have completed 1,000 hours of service and be employed on the last day of the Plan year to be eligible for the discretionary profit-sharing contribution. The Company did not approve a discretionary profit-sharing contribution for the 2024 or 2023 Plan years.

#### *Vesting*

Participants are immediately 100% vested in their voluntary contributions, safe-harbor Company matching, and profit-sharing contributions.

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions, allocations of the Company's matching and discretionary contributions, and Plan earnings, and charged with an allocation of administrative expenses, as applicable. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investment of their account balances into various investment options offered by the Plan.

### *Payment of Benefits*

Upon termination of service due to death, disability, retirement, or separation, participants may elect to receive their benefits as a lump-sum amount or as installment payments. In-service withdrawal of account balances may be elected by active participants who have reached 59½ years of age. Additionally, under certain circumstances of financial hardship, participants are allowed to withdraw certain funds from the Plan.

### *Notes Receivable from Participants*

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at a reasonable rate, which is the prevailing rate charged by other lenders for similar loans. Interest rates on notes receivable outstanding at December 31, 2024 ranged from 4.25% to 9.50%. Principal and interest are paid ratably over a period of five years or less, unless for the purchase of a principal residence, which may be repaid over ten years. Each participant may not have more than one loan outstanding at any time.

### *Administrative Expenses*

Certain administrative expenses of the Plan are paid by the Company. Administrative expenses not paid directly by the Company generally are allocated to Plan participants in accordance with Plan provisions. Certain participant-specific member requested service fees are paid by the Plan and charged to the respective participant accounts.

## **2. Significant Accounting Policies**

### *Basis of Accounting*

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### *Subsequent Events*

Subsequent events have been evaluated by management through October 14, 2025, the date these financial statements were available to be issued.

### *Use of Estimates*

The preparation of the financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### *Risks and Uncertainties*

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset (an exit price) in the principal or most advantageous market for the asset in an orderly transaction between market participants on the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's realized and unrealized gains and losses on investments bought and sold, as well as those held during the year.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. Defaulted loans, if any, are reclassified as distributions based upon the terms of the Plan agreement.

### *Payment of Benefits*

Benefits are recorded when paid.

## **3. Fair Value Measurements**

In accordance with Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, the Plan utilizes a fair value hierarchy for valuation inputs that gives the highest priority to quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The three levels of the fair value hierarchy are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets.

*Level 2* - Inputs to the valuation methodology include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in inactive markets, and other inputs that are observable or can be corroborated by observable market data.

*Level 3* - Inputs to the valuation methodology are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 or 2023. The following valuation methodologies were used to measure the fair value of the Plan's investments:

*Money Market Fund* - Valued at the daily closing price as reported by the fund.

*Mutual Funds* - Mutual Funds are public investment vehicles valued at quoted market prices in an exchange and active market, which represents the NAV of shares held by the Plan and is classified within Level 1 of the Fair Value Hierarchy.

*Collective Investment Trusts (CITs)* - Collective investment trusts are valued at the net asset value (NAV) of units held. The NAV, as provided by the trustee of the CITs, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the CIT less its liabilities. This practical expedient is not used when it is determined to be probable that the CITs will sell for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. The CITs provide for daily redemptions by the Plan at reported NAV, with no advance notice requirements. There are no unfunded commitments at year-end. These are direct filing entities.

The Plan's valuation methods may result in a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Although Plan management believes the valuation methods are appropriate and consistent with the market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 4. Information Certified by a Qualified Institution

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution, First Hill Trust Company.

### 5. Related Party and Party-in-Interest Transactions

Investments in the money market fund are managed by Charles Schwab, the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions. Additionally, certain investments are in funds and accounts that are managed by the Trustee of the Plan.

Administrative fees paid to the custodian, recordkeeper, and investment advisor by the Plan totaled \$141,971 and \$115,470 for the years ended December 31, 2024 and 2023, respectively.

### 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will remain 100% vested in their accounts.

### 7. Income Tax Status

The Plan has adopted the CCH Incorporated Non-Standardized Pre-Approved Profit-Sharing Plan. CCH Incorporated obtained an opinion letter, dated June 30, 2020, in which the Internal Revenue Service (IRS) stated that the Non-Standardized Pre-Approved Profit-Sharing Plan is qualified, and the trust established under the Plan is tax-exempt under the appropriate sections of the IRC. The Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there currently are no audits for any tax periods in progress.
