Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the AssetGenie, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the AssetGenie, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Transamerica Trust Company as of December 31, 2024 and for the period from October 2, 2024 to December 31, 2024, and Capital Bank and Trust Company as of December 31, 2023 and for the period from January 1, 2023 to October 1, 2024 stating that the certified investment information, as described in Note F to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the AssetGenie, Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Note A – Plan Description

The following description of the AssetGenie, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution 401(k) plan covering substantially all employees of AssetGenie, Inc., AGiRepair TX, LLC, AGiRepair, Inc., AGParts Worldwide, Inc., and Oasis Mental Health Applications Corp. (together the “Company”) who have completed sixty days of service and are age twenty-one or older, except for union, nonresident aliens, leased, part-time, temporary and seasonal employees as these are ineligible classes of employees according to the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan agreement utilized a nonstandardized prototype sponsored by Dunbar, Bender & Zapf, Inc. Capital Bank and Trust Company was the recordkeeper and custodian of the Plan until October 1, 2024. On October 2, 2024 all assets were transferred to Transamerica Trust Company, the current custodian of the Plan. The administrator of the Plan and Plan Sponsor is AssetGenie, Inc.

Contributions – Plan participants may contribute up to 100% of their annual eligible compensation on a pretax and/or after-tax basis, as defined in the Plan document, subject to certain limitations under the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan Year are eligible to make catch-up contributions, subject to certain limitations under the IRC. Participants may also contribute rollover distributions from other qualified defined benefit or contribution plans.

Participants are eligible to receive Company 401(k) ADP test safe harbor contributions (safe harbor contributions), Company matching contributions (matching contributions), and Company nonelective contributions (nonelective contributions). Safe harbor contributions are equal to 100% of the participant’s elective deferrals that do not exceed 4% of the participant’s compensation. Safe harbor contributions were \$570,206 for the year ended December 31, 2024. Matching contributions may be made at the sole discretion of the Company as a discretionary percentage of a participant’s compensation or a discretionary dollar amount. No matching contributions were made to the Plan for the year ended December 31, 2024. Nonelective contributions may be made at the sole discretion of the Company in the same ratio as each participant’s compensation bears to the total of such compensation of all participants. To be eligible for a nonelective contribution, participants must be employed on the last day of the Plan Year, unless due to death, disability, or terminated on or after normal retirement age, and completed one year of service. No nonelective contributions were made to the Plan for the year ended December 31, 2024.

Participants direct the investment of their contributions, including Company contributions into various investment options offered by the Plan. Participants may change their investment election for future contributions, or the percentage(s) invested in each of these options or transfer funds among these options on any business day. All investments are participant-directed.

Notes Receivable from Participants – Participant loans are not permitted per the Plan document.

Participant Accounts - Individual accounts are maintained for each Plan participant to reflect the participant’s contributions, the Company’s related contributions, and the net investment income (loss) attributable to the participant’s account. Participants are also charged with an allocation of administrative expenses. Allocations are based on specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

Note A – Plan Description (continued)

Payment of Benefits - Benefits may be distributed to participants, spouses or designated beneficiaries, as appropriate, upon normal retirement (age 65), death, disability or termination of employment. The Plan does not allow for early retirement. Prior to termination of service, participants who have attained the age of 59½ may make in-service withdrawals from all vested accounts. Benefit payments are made in a single lump sum. The Plan provides for certain required minimum distributions commencing at age 72 for certain participants. The Plan provides participants may make emergency withdrawals from the Plan to meet certain hardships. The permitted hardships are defined by the Internal Revenue Service (IRS) and the requirements are strict.

Vesting - Participants are vested immediately in their elective contributions, including rollovers, catch-up contributions and the Company safe harbor contributions and matching contributions, plus actual earnings thereon. Vesting in the Company’s nonelective contributions and prior discretionary profit-sharing contributions, as allowed prior to January 1, 2022, along with actual earnings is based on years of continuous service. The vesting schedule is as follows:

Forfeitures - Participant account balances which are not 100% vested upon termination of services are forfeited. Forfeitures can be used to pay for Plan administrative expenses or to reduce the Company’s contributions. As of December 31, 2024 and 2023 the forfeiture account balance was \$1,819 and \$342, respectively. For the year ended December 31, 2024, \$345 of forfeitures were used to reduce administrative expenses. No forfeitures were used for the year ended December 31, 2023.

Note B – Summary of Significant Accounting Policies

Basis of Accounting - The accompanying financial statements have been prepared using the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates - The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Contributions – Participant’s elective deferrals and Company contributions are recognized as additions to Plan assets in the year designated by the participant and Company, respectively.

Payment of Benefits - Benefits are recorded when paid by the Plan.

Investment Valuation and Income Recognition – Investments are reported at fair value except for the fully-benefit responsive investment contract, which is stated at contract value (Note H). Shares of mutual funds and collective trust funds are valued at the net asset value (NAV) of shares held by the Plan at year-end. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

GAAP establishes a framework for measuring fair value that requires or permits fair value measurements and enhances disclosures about fair value measurements. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value. The required disclosures concerning inputs used to measure fair value are included in Note G.

Plan Administrative Expenses - The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation (depreciation) in fair value of investments presented in the accompanying statements of changes in net assets available for benefits. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Subsequent Events – Management has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

Note C – Income Tax Status

The underlying nonstandardized prototype plan has received an opinion letter dated June 30, 2020, from the IRS that stated the Plan and related Trust are designed in accordance with applicable sections of the IRC. Subsequent to the receipt of the determination letter from the IRS, the Plan has been amended. The Plan is required to operate in conformity with the IRC to maintain its qualification. In the opinion of the Plan administrator, the Plan and the related Trust are currently operated in accordance with the Plan agreement and in conformity with applicable provisions of the IRC and are exempt from federal taxes.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax benefit if it is more likely than not the tax position would be sustained upon examination by the applicable authorities. The remainder of the tax position is required to be recorded as a tax liability. The Plan's tax returns for 2021, 2022, and 2023 are subject to examination by the taxing authorities, generally for three years after they were filed. The Plan currently has no uncertain tax positions and, therefore, no liabilities have been recorded.

Note D – Risks and Uncertainties

The Plan invests in various investment securities that are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note E – Party-in-Interest Transactions

Certain plain investments are managed by Transamerica Trust Company, current custodian of the Plan, or were managed by Capital Bank and Trust Company, the previous custodian of the Plan, and therefore, those transactions would qualify as party-in-interest transactions.

The Plan paid certain administrative fees for custodial and recordkeeping services. These transactions qualify as party-in-interest transactions. However, these transactions are not considered prohibited transactions under Section 408(b) of ERISA regulations.

Note F – Information Certified by the Plan’s Custodians

For the years ended December 31, 2024 and 2023, the plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information certified by Transamerica Trust Company, the custodian of the Plan as of December 31, 2024 and for the period October 2, 2024 through December 31, 2024, and Capital Bank and Trust Company, the custodian of the Plan as of December 31, 2023 and for the period January 1, 2023 through October 1, 2024, as complete and accurate, except for comparing such information certified by the custodians to information included in the Plan’s financial statements and supplemental schedule:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income as show in in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information included in the schedule of assets (held at end of year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

Note G – Fair Value Measurements

Financial Accounting Standards Board Statement ASC 820, *Fair Value Measurements* (FASB ASC 820), establishes a framework for measuring fair value and requires certain disclosures about the fair value measurement (see Note B). The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 inputs must be observable for substantially the full-term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for the Plan's investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds* - Valued at the NAV of shares held by the Plan at year-end. The NAV is based upon quoted market prices.
- *Collective Trust Funds* – Valued at the NAV of shares held by the Plan at year-end. The collective trust funds held by the Plan are not traded in an active market but have published fair values.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTES TO THE FINANCIAL STATEMENTS**

Note H – Fully Benefit-Responsive Investment Contract

As of December 31, 2024, the Plan held a stable value investment in a group annuity contract with the custodian. This investment met the fully benefit-responsive investment criteria and therefore was reported at contract value. Contract value is the relevant measure for the fully benefit-responsive investment contract because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions plus credited interest less participant withdrawals and fees. The account is credited with earnings based on the daily balance at a rate that is the daily equivalent of the effective annual rate of interest applicable for the six-month period. There is no stated minimum or maximum interest rate for the investment choice.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may limit the ability of the Plan to transact at contract value. Such events may include, but may not be limited to, the following: (1) the complete or partial termination of the Plan or contract; (2) changes to the Plan's investment options; (3) bankruptcy of the plan sponsor or other plan sponsor events such as divestitures or spinoffs of a subsidiary, that significantly affect the Plan's normal operations.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different than the contract value. Such events may include, but may not be limited to, the following: (1) significant changes to the Plan that affect the obligations under the contract; (2) the contract can no longer be treated as defined and it is not practical to continue the provision of benefits under the contract; (3) the plan is terminated; (4) requirements under the contract are not complied with; or (5) breaches of contract requirements as defined in the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with participants.

Note I – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their investments, including Company contributions.

Note J – Nonexempt Transactions

Employee contributions totaling \$11,799 during the year ending December 31, 2024 were transferred to the Plan later than required by Department of Labor Regulations.

Note K – Plan Amendments

During 2024, the Plan was amended adding Transamerica Trust Company as a corporate trustee. Additionally, the January 1, 2022 adoption agreement was retroactively revised in order to exclude certain fringe benefit compensation as Plan eligible compensation, in order to conform to the operation of the Plan prior to the adoption agreement, and since the adoption agreement became effective.

During 2023, the Plan was amended removing one of the two named individual trustees.
