## INDEPENDENT AUDITOR'S REPORT

To the Board of Directors of the  
Fair Isaac 401(k) Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Fair Isaac 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter—Supplemental Schedules Required by ERISA**

The supplemental schedule of assets (held at end of year) as of December 31, 2024 and schedule of delinquent participant contributions for the year ended December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

## NOTES TO FINANCIAL STATEMENTS

AS OF DECEMBER 31, 2024 AND 2023, AND FOR THE YEAR ENDED DECEMBER 31, 2024

---

### 1. DESCRIPTION OF THE PLAN

The following description of the Fair Isaac 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan’s information.

**General**—The Plan is a defined contribution plan established to provide voluntary retirement benefits and tax-deferred and Roth savings opportunities to eligible employees of Fair Isaac Corporation (the “Company”). The Plan was established in April 1988. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by the Company’s administrative committee (the “Administrative Committee”), consisting of five employee members appointed by the Company’s board of directors. Fidelity Management Trust Company serves as the trustee of the Plan.

**Contributions**—Participants may contribute, through tax-deferred and Roth salary reductions in an amount not less than 1% and not in excess of 25% of the participant’s compensation. Employer-matching contributions are made equal to 100% of each participant’s salary deferral contribution up to the first 3% of compensation, and 50% of the participant’s salary deferral contribution for the next 2% of compensation. The employer may decide to make a profit-sharing contribution during any Plan year; however, no such contribution was made in 2024. Participants who have attained age 50 are eligible to make catch up contributions. These additional contributions are ineligible for a Company matching contribution. Contributions are subject to certain Internal Revenue Code (IRC) limitations.

**Participant Accounts**—Individual accounts are maintained for each participant of the Plan. Each participant’s account is credited with the participant’s contribution and related employer match and Plan earnings. Participant accounts are also charged with withdrawals and an allocation of plan losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Investments**—Participants may direct the investment of their contributions and any employer contributions and/or account balances into various investment options offered by the Plan and may change investments and transfer amounts between funds daily. Participants may also direct their investments through a trustee sponsored self-directed brokerage account, which offers the option to invest in a variety of individual stocks and mutual funds.

**Vesting**—Participants are immediately vested in their pretax, Roth and employer-matching contributions; however, if the Plan sponsor makes an employer discretionary (profit-sharing) contribution, a five-year graded vesting schedule would apply to such contribution, plus actual earnings thereon. Participants are fully vested upon death, disability, or retirement.

**Notes Receivable from Participants**—Participants are allowed, after one year of service, to borrow a minimum of \$1,000 to a maximum of 50% of their vested account balance, up to \$50,000, as defined by the Plan. The term of the loan cannot exceed five years except when the loan proceeds are used to purchase the participant's principal residence, in which case the maximum term is 10 years. A participant may not have more than one loan outstanding at any time. Loans are secured by the vested balance in the participant's account and bear interest at rates determined by the Plan administrator based on the prevailing interest rates charged by persons in the business of lending money for loans, which would be made under similar circumstances. Principal and interest are paid ratably through payroll deductions. As of December 31, 2024, participant loans have maturities through 2034 at interest rates ranging from 4.25% to 9.5%.

**Payment of Benefits**—Benefits are payable upon termination, disability, death, age 59 1/2, or retirement as a lump-sum amount equal to the value of the participant's vested interest in his or her account. Terminated employees and non-employee participants may receive installment distributions in amounts greater than or equal to \$1,000. Additionally, participants may withdraw vested amounts from their account prior to termination of employment with the Company by demonstrating financial hardship, as defined in the Plan.

**Forfeited Accounts**—The Plan's Forfeiture Account is made up of return of excess orphan match, contribution corrections, and stale dated uncashed checks. As such, forfeitures in 2024 and 2023 represent the forfeitures associated with these types of transactions.

These amounts may be used to reduce future employer contributions or pay plan administrative expenses for the plan year. As of December 31, 2024 and 2023, \$3,794 and \$56,847, respectively were held in the Forfeiture Account. During 2024, approximately \$42,761 & \$18,647 of forfeitures were used to reduce employer matching contributions and administrative expenses respectively.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting**—The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates**—The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Risks and Uncertainties**—The Plan provides various investment instruments, including mutual funds, common collective trusts and a self-directed brokerage account. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the rates of investment securities will occur in the near term and that such changes could materially affect the value of the participants' account balances and the amounts reported in the financial statements.

**Investment Valuation and Income Recognition**—The Plan's investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion on fair value measurements. Purchases and sales of securities are recorded on a trade-date

basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**—Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the plan document.

**Contributions**—Employee contributions and employer matching contributions are recorded when employee contributions are withheld from employee's paychecks on the payroll date. Profit-sharing contributions are recorded when earned.

**Administrative Revenue (Expenses)**—Administrative expenses of the Plan are paid by the Plan or the Plan sponsor, as provided in the Plan document. Investment management fees for investments are included as a reduction of investment return and not reflected separately in the statement of changes in net assets available for benefits.

Administrative expenses of \$72 per participant are deducted from participant accounts each calendar year. Participants also pay administrative costs for loans, distributions and qualified domestic relation orders. The remaining expense is paid by the Company and through credits provided by the recordkeeper for Plan investments.

The Plan has a revenue-sharing agreement whereby certain investment managers return a portion of the investment fees to the recordkeeper to offset the Plan's administrative expenses. Future Plan expenses can be paid from any excess remaining revenue sharing amounts. For the year ended December 31, 2024, \$465,115 was used to offset Plan expenses. The Plan held undistributed administrative revenues of \$121,911 and \$56,995, at December 31, 2024 and 2023, respectively.

**Payment of Benefits**—Benefit payments to participants are recorded upon distribution. There were no amounts allocated to accounts of persons who have elected to withdraw from the Plan but have not yet been paid at December 31, 2024 and 2023.

**Non-interest bearing cash**—Cash held by the Plan does not earn interest and is included in the self-directed brokerage account.

### 3. CERTIFIED INVESTMENT INFORMATION

The following is a summary of the information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedules, that was prepared by or derived from information prepared by Fidelity

Management Trust Company, the trustee of the Plan, and furnished to the Plan administrator. The Plan administrator has obtained certifications from the trustee that such information is complete and accurate.

#### 4. FAIR VALUE MEASUREMENTS

ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

**Asset Valuation Techniques**—Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual Funds**—Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Collective Trust Funds**—Valued at the net asset value of units of a bank collective trust. The net asset value as provided by the trustee is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust,

the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to confirm that securities liquidations will be carried out in an orderly business manner.

**Self-Directed Brokerage Account**—A self-directed brokerage option that includes common and preferred stock, government and corporate bonds, cash and cash equivalents, options, and various other investment choices using Fidelity Brokerage Services, Inc:

## 5. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares in funds managed by Fidelity Investments, an affiliate of Fidelity Management Trust Company, the Plan's trustee, as defined by the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. The Plan issues loans to participants under the deferred arrangement portion of the Plan, which are secured by the vested

balances in the participants' accounts. Administrative revenues arise when investment managers return a portion of the investment fees to Fidelity Management Trust Company to offset the administrative expenses. Any excess resulting from this revenue sharing remains in an unallocated account from which future Plan expenses can be paid.

**6. NONEXEMPT PARTY-IN-INTEREST TRANSACTIONS**

The Company remitted participant contributions during 2024 and 2023 of \$1,615,512 and \$623,861, respectively to the trustee on various dates, which were later than required by Department of Labor (DOL) Regulation 2510.3 102. The Company intends to file Form 5330 with the IRS and intends to pay the required excise tax on the transactions. In addition, participant accounts will be credited with the amount of investment income that would have been earned had the participant contributions been remitted on a timely basis.

**7. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

**8. FEDERAL INCOME TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated January 9, 2014, that the Plan and related trust are designed in accordance with the applicable regulations of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. The Company and Plan management believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and the Plan and related trust continue to be tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

## 10. SUBSEQUENT EVENTS

Effective January 1, 2025, the Plan was restated to incorporate certain new and amended provisions of The Setting Every Community Up for Retirement Enhancement Act (the "SECURE Act"). These changes include the addition of qualified birth or adoption distributions, emergency personal expense distributions, qualified disaster recovery distributions, domestic abuse distributions, and provisions to allow the return of certain distributions as rollovers. The Plan also amended the definition of spouse and revised the minimum distribution rules in accordance with recent regulatory developments.

For the year ended December 31, 2024, subsequent events were evaluated through October 15, 2025, the date the financial statements were available to be issued. Except as noted above, there were no material subsequent events that occurred that would require disclosure or recognition in these financial statements.
