The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) (modified cash basis) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF PLAN

The following description of the Data Electronic Devices, Inc. ("Company") 401(k) Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

A. General

The Plan is a defined contribution plan covering all full-time employees of the Company, QCM, Inc. DBA Veris Manufacturing, Saline Lectronics, Inc., Bestronics, Inc., Ascentron, Inc., and Optimum Design Associates, Inc. ("Plan Sponsors") who have completed one month of eligible service, as defined by the Plan agreement, and are twenty-one years of age or older, or eighteen years of age or older for former participants of the Saline Lectronics, Inc. 401(K) Profit Sharing Plan and Trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended. Participation in the Plan is entirely voluntary.

In November of 2023, Data Electronic Devices, Inc.'s parent company, Emerald Electronic Manufacturing Services, acquired Ascentron, Inc. Ascentron, Inc. was the plan sponsor to the Ascentron Inc 401(k) Plan. In January of 2024, the plan administrator for this plan agreed to merge the Ascentron Inc 401(k) Plan with the Data Electronic Devices, Inc. 401(K) Plan. Per the transfer agreement, all contributions to the Ascentron Inc 401(k) Plan were ceased as of January 1, 2024, wherein each participant was enrolled and began contributing to the Data Electronic Devices, Inc. 401(K) Plan.

On January 10, 2024, the Ascentron Inc 401(k) Plan entered a blackout period, preventing participants from changing funds, obtaining loans, or obtaining distributions, during which all existing assets in the plan were transferred to the Data Electronic Devices, Inc. 401(K) Plan. This transfer occurred on January 18, 2024, wherein total assets of \$1,875,351 were transferred out of the Ascentron Inc 401(k) Plan, leaving no balance in the Plan as of January 31, 2024.

In May of 2024, Data Electronic Devices, Inc.'s parent company, Emerald Electronic Manufacturing Services, acquired Optimum Design Associates, Inc. Optimum Design Associates, Inc. was the plan sponsor to the Optimum Design Associates, 401(k) Profit Sharing Plan & Trust. In September of 2024, the plan administrator for this plan agreed to merge the Optimum Design Associates, 401(k) Profit Sharing Plan & Trust with the Data Electronic Devices, Inc. 401(K) Plan. Per the transfer agreement, all contributions to the Optimum Design Associates, 401(k) Profit Sharing Plan & Trust were ceased as of October 1, 2024, wherein each participant was enrolled and began contributing to the Data Electronic Devices, Inc. 401(K) Plan.

On November 22, 2024, the Optimum Design Associates, 401(k) Profit Sharing Plan & Trust entered a blackout period, preventing participants from changing funds, obtaining loans, or obtaining distributions, during which all existing assets in the plan were transferred to the the Data Electronic Devices, Inc. 401(K) Plan. This transfer occurred on December 3, 2024, wherein total assets of \$3,432,271 were transferred out of the Optimum Design Associates, 401(k) Profit Sharing Plan & Trust, leaving no balance in the Plan as of December 31, 2024.

B. Contributions

Each year, participants may contribute up to the maximum allowed by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment account options as offered by the Plan. The Plan includes an auto enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate at 4 percent of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant. Participants may change their investment percentage options weekly and reallocate their investment portfolio daily.

The Plan Sponsors elected to make safe harbor matching contributions in 2024 in accordance with statutory requirements. Participants are entitled to receive safe harbor contributions equal to 100% of the first 4% of each participants eligible compensation. All Plan Sponsor's contributions are directed by the participants. During the year ended December 31, 2024, the Plan Sponsors made safe harbor matching contributions of \$1,755,600.

The Plan Sponsor may also, at its discretion, make discretionary nonelective contributions, as defined in the Plan agreement. No discretionary contributions were made during the year ended December 31, 2024.

C. Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Plan Sponsor's contribution, (b) Plan earnings (losses), and (c) forfeitures of terminated participants' nonvested accounts and may be charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

D. Vesting

Participants are vested immediately in their employee contributions and the Plan Sponsor's safe harbor matching contributions plus actual earnings thereon. Vesting in the Plan Sponsors' discretionary contributions and actual earnings thereon is based on years of credited service. A participant is 100% vested after five years of credited service.

E. Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator at the time the loan application is submitted. At December 31, 2024 and 2023, the interest rates on outstanding notes receivable ranged from 4.25% to 10.5%. Principal and interest is paid ratably through weekly payroll deductions.

F. Terminated Accounts

At December 31, 2024 and 2023, terminated vested accounts amounted to \$6,133,741 and \$4,289,227, respectively. These accounts were not paid to the terminated participants as of December 31, 2024 and 2023, respectively.

G. Payment of Benefits

On termination of service due to death, disability or retirement, a participant will receive their vested interest by (i) transfer to another qualified plan, (ii) transfer to an individual retirement plan, or (iii) a lump-sum distribution subject to a 20-percent income tax withholding.

H. Hardship Withdrawals

Hardship withdrawals may be allowed in the case of heavy and immediate financial need that cannot be satisfied by other sources. Such withdrawals may be granted upon receipt of documented evidence. During the year ended December 31, 2024, hardship withdrawals amounted to \$105,659.

I. Forfeited Accounts

Forfeitures of employer contributions can be used to pay plan expenses or are applied to reduce subsequent employer discretionary contributions. In 2024, forfeited nonvested accounts totaled \$1,753. The balance in the forfeiture account as of December 31, 2024 and 2023 was \$1,932 and \$815, respectively.

J. Administration Expenses

The Sponsor provided certain administrative and accounting services to the Plan at no cost. Other administrative expenses incurred by the Plan during the year ended December 31, 2024 include loan and withdrawal fees of \$30,189, and investment management fees of \$51,950 charged directly to the participants' accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The accompanying financial statements have been prepared on a modified cash basis, which is a comprehensive basis of accounting other than generally accepted accounting principles. Consequently, investment income is recognized when received and disbursements are recognized when made. Accordingly, the financial statements are not intended to present the net assets available for benefits and changes in net assets available for benefits of the Plan in accordance with generally accepted accounting principles.

B. Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan administrator to make estimates and assumptions that affect the reported amounts of Plan assets and changes therein at the date of the financial statements. The most significant estimate affecting the financial statements is the fair value of investments. Actual results could differ from those estimates.

C. Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value.) Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income on investments is recorded when received by the Plan. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

D. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. Participants pay principal and interest through payroll deductions each pay period. Interest income is recognized by the Plan when it is received.

If a participant fails to make scheduled repayments and does not cure the delinquency within the required time period, the loan is treated as a deemed distribution in accordance with Internal Revenue Code requirements and is removed from the Plan's loan balance.

Loan origination and administrative fees related to participant loans are directly charged to the individual participant's account. While these fees are not paid by the Plan Sponsor, the related amounts are included as part of the administrative expenses reported in the Plan's financial statements. The Plan does not capitalize or defer any fees or costs associated with participant loans. Accordingly, there is no amortization of deferred loan fees or costs in the Plan's financial statements.

E. Payment of Benefits

Benefits are recorded when paid.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of fair value hierarchy under this framework are described as follows:

Level 1 Inputs to the valuation methodology are quoted prices (unadjusted) in active markets or identical assets or liabilities that the Plan can access at the measurement date.

Level 2 Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- a. Quoted prices for similar assets or liabilities in active markets
- b. Quoted prices for identical or similar assets or liabilities in inactive markets
- c. Inputs other than quoted prices that are observable for the asset or liability
- d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds – Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Values (NAV) and to transact at that price. The mutual funds in the Plan are determined to be actively traded.

4. COLLECTIVE INVESTMENT TRUST

In 2024 and 2023, Plan participants elected to allocate contributions to the Metlife Reliance Stable Value Fund (“Fund”), a common collective investment trust. The Fund’s investment objective is to seek preservations of principal while seeking a rate of return which, over time, is competitive with rates of return earned over an extended period of time by comparable fixed income investment products. The Fund provides its unitholders with a medium for collective investment and reinvestment in one or more bank, insurance company or synthetic investment contracts, and in short-term investments or other collective investment funds. The underlying collective investment funds may use various investment strategies in addition to holding long portfolio positions. Investments in this option are treated as an investment in a fully benefit-responsive guaranteed investment contract.

Because the Fund is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits. Contract value, as reported to the Plan by the custodian, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer.

Certain events limit the Plan’s ability to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (3) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974, or other events. The Plan administrator does not believe that any events that would limit the Plan’s ability to transact at contract value with Plan participants are probable of occurring.

5. RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

6. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were shares of mutual funds managed by Reliance Trust. Reliance Trust is the custodian of the Plan assets, and therefore, these are transactions that qualify as party-in-interest transactions.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsors have the right under the Plan to discontinue their contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

8. TAX STATUS

The Internal Revenue Service has determined and informed the custodian by a letter dated October 6, 2020 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

The provisions of Accounting for Uncertainty in Income Taxes require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
