### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Christ Community Health Services 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### 1. Description of Plan

The following description of Christ Community Health Services 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan sponsored by Christ Community Health Services (the Organization) for the benefit of its employees.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). John Hancock Life Insurance Company (John Hancock) served as the Plan's contract administrator from January 1, 2022 through March 20, 2023. Effective March 21, 2023, the Plan transferred all of the assets from John Hancock to Voya Retirement Insurance and Annuity Company (Voya or the trustee). Following the transfer, Voya also serves as the Plan's record-keeper. Plan assets transferred to the new insurance company group annuity contract were transferred into funds comparable to those offered by the previous insurance company group annuity contract. The conversion initiated a "Black Out" period beginning March 13, 2023, and continued through April 7, 2023. During this period, funds could not be diversified or withdrawn from the Plan until the recordkeeper had time to accurately complete the conversion. During this period, employee contributions continued to be made through payroll deductions and the contributions were held in the Voya Government Money Market Fund until the completion of the Black Out period. At the end of the Black Out period, these funds were invested in funds as requested by each participant and participants were able to access their accounts.

#### Contributions

The Plan permits eligible employees through a salary deferral election to have the Organization make annual contributions of up to the maximum allowed by the Internal Revenue Code (the Code). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Employee rollover contributions are also permitted.

The Organization makes safe harbor matching contributions of 100% of the first 3% and 50% of the next 2% of participants' compensation contributed to the Plan. The Organization may also make discretionary nonelective contributions to the Plan. No discretionary nonelective contributions were made in 2024. Contributions are subject to certain limitations.

#### Participant Investment Account Options

Each participant has the option of directing contributions into any of the investment account options selected by the Organization and may change the allocation daily.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions, the Organization's contributions, and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are immediately vested in their voluntary contributions and the Organization's safe harbor matching contributions plus earnings thereon. Vesting in the Organization's prior discretionary employer matching contribution portion of their accounts plus earnings thereon is based on years of service. Participants become vested as follows: 25% after two years of service, 50% after three years, 75% after four years, and 100% after five years. In the event of termination of service due to death, disability, or retirement, participants will be fully vested

### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may only have one loan outstanding at any time and the loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above the prime rate, as defined. Principal and interest is paid ratably through payroll deductions.

### **Payment of Benefits**

Upon termination of service, participants may elect to receive the value of the vested interest in their accounts as lump-sum distributions. Withdrawals other than for termination are permitted under circumstances provided by the Plan.

### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$13 and \$8,362, respectively. These accounts will be first used to reduce administrative expenses. Any remaining forfeitures will be used to reduce future employer contributions. During 2024, administrative expenses of \$21,542, respectively, were paid from forfeited nonvested accounts. No contributions were reduced from forfeited nonvested accounts during 2024.

### 2. Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements are prepared under the accrual basis of accounting.

#### Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Pooled separate accounts are valued at net asset value (NAV) based upon the quoted market value of the underlying investments as provided by Voya. The NAV is calculated daily and is the basis for current transactions.

Fully benefit-responsive investment contracts are valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administration expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

#### Payment of Benefits

Benefit payments to participants are recorded upon distribution.

#### Administrative Expenses

Administrative expenses may be paid by the Organization or the Plan, at the Organization's discretion.

### **Subsequent Events**

Management has considered transactions or events occurring through October 14, 2025, which is the date that the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

### **3. Information Prepared and Certified by the Trustee**

The investments, investment transactions, net appreciation in fair value of investments, notes receivable from participants and interest were obtained by management and agreed to or derived from the information certified by the trustee as complete and accurate. This information is included in the following:

- Statements of Net Assets Available for Benefits;
- Statement of Changes in Net Assets Available for Benefits; and
- Schedule H, line 4i - Schedule of Assets (Held at End of Year).

### **4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies and inputs used for assets measured at fair value. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023.

*Pooled separate accounts:* Valued at net asset value (NAV) of units based upon quoted market prices of the underlying investments. NAV is a readily determinable fair value and is the basis for current transactions which may occur daily. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

### 5. Investment Contract with Insurance Company

In 2023, the Plan entered into a fully benefit-responsive investment contract with Voya. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The guaranteed investment contract is fully benefit responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise. Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan Documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Organization or other Organization events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract permits Voya to terminate the agreement under certain circumstances after giving required advance written notification in which to cure any remediable defaults.

### 6. **Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan is invested in a group annuity contract with Voya starting. These investments and related transactions qualify as party-in-interest transactions.

Direct fees paid to Voya for record-keeping services were \$14,350 during 2024. Expenses paid directly to the Plan's third-party administrator, Burleigh Consulting Group, were \$23,492 during 2024.

Certain other fees incurred by the Plan for contract administration and investment management services are included in net appreciation in fair value of the investments, because they are paid indirectly. Certain administrative expenses related to the Plan are paid by the Organization and the Organization provides certain administrative services at no cost to the Plan.

### 7. **Plan Termination**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### 8. **Tax Status**

The Plan operates under a nonstandardized adoption agreement in connection with a pre-approved profit-sharing plan document sponsored by Burleigh Consulting Group, which received a favorable opinion letter, dated June 30, 2020, from the Internal Revenue Service stating the nonstandardized pre-approved plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and the Plan was qualified and the related trust was tax exempt as of the financial statement date.

### 9. **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.
