Accordingly, we do not express an opinion, a conclusion, nor provide any form of assurance on the 2023 financial statement.

The Plan was not subject to audit in the prior year. Accordingly, the Statement of Net Assets Available for Benefits as of December 31, 2023, is unaudited and was not compiled from information provided by management.

**NOTE A – DESCRIPTION OF PLAN**

The following description of the IFAS Smart Savings Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement and the amendments thereto for a more complete description of the Plan’s provisions.

General

Effective April 1, 2008, Integrated Finance and Accounting Solutions, LLC (the “Company”) established the IFAS Smart Savings Plan (the “Plan”) to provide deferred compensation benefits to its employees. The Plan is a defined contribution plan with 401(k) salary deferral provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and qualifies under the Internal Revenue Code (“IRC”) as a 401(k) Plan. The Plan was amended and restated effective January 1, 2023.

Eligibility

Employees are eligible to participate once they attain age 21. There is no service requirement for elective deferrals. For employer profit-sharing contributions, employees must complete one year of service. Entry into the Plan occurs on the first day of the month following satisfaction with eligibility requirements. See Summary Plan Description for definition of eligible compensation and automatic enrollment provisions.

Contributions

Participants may contribute between 0% and 100% of eligible compensation, up to the statutory maximum annual limit of \$23,000 for 2024, plus an additional \$7,500 catch-up contribution if age 50 or older. Contributions may be made on a pre-tax or Roth basis. Participants may also roll over amounts from other qualified plans. The Company makes safe harbor matching contributions equal to 100% of the first 3% of compensation deferred, plus 50% of the next 2% of compensation deferred. In addition, the Company may make discretionary profit-sharing contributions at its option. Safe Harbor matching contributions for the year ended December 31, 2024 were \$414,070. No discretionary contributions were made in 2024.

Participant Accounts

Plan assets are held by Ascensus Trust Company and administered by the Company. Each participant’s account is credited with their elective contributions, employer contributions, rollover contributions, and allocations of Plan earnings or losses, less any applicable charges. The benefit to which a participant is entitled is the vested balance of their account.

**NOTE A – DESCRIPTION OF PLAN (CONTINUED)**

Vesting

Participants are always fully vested in their elective deferrals, rollover contributions, safe harbor matching contributions, and any qualified nonelective contributions (QNECs). Profit-sharing contributions are subject to a six-year graded vesting schedule: 0% vested prior to two years of service; 20% vested after two years; 40% after three years; 60% after four years; 80% after five years; and 100% after six years. Participants become fully vested upon reaching Normal Retirement Age, death, disability, or Plan termination.

Notes Receivable from Participants

Participants may have up to two loans outstanding at a time. The maximum loan amount is the lesser of \$50,000 (reduced by the highest outstanding loan balance in the previous 12 months) or 50% of the participant's vested account balance. The minimum loan is \$1,000. Loans bear interest at the prime rate as published in the Wall Street Journal. Loans must generally be repaid within one to five years, except that loans used to purchase a principal residence may be extended beyond five years. Loans are secured by the participant's vested account balance and are repaid through payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or other separation, a participant or beneficiary may elect to receive a distribution equal to the vested balance. Mandatory distributions are required if a participant's vested balance is \$1,000 or less. Balances greater than \$5,000 may remain in the Plan until required minimum distribution rules apply. Distributions may be made in lump sum or other forms permitted by the Plan.

Forfeited Accounts

Forfeitures of non-vested profit-sharing contributions may be used to reduce future employer contributions or pay Plan administrative expenses. As of December 31, 2024, there were no forfeited accounts.

Investment Options

Contributions to the Plan are invested according to participant direction among the investment options provided by the Plan and held by Ascensus Trust Company, the trustee.

**NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (“GAAP”).

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investments and income recognition

Investments are reported at fair value. Quoted market prices are used to value investments in mutual funds. Units in common collective trusts are valued at the net asset value of units held by the plan at year-end, as reported by the trustee. Participant loans are valued at their unpaid principal balance plus accrued interest.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Party-in-interest transactions

Transactions with Ascensus Trust Company, the trustee and custodian of the Plan, qualify as party-in-interest transactions under ERISA. See Note I – Related Parties for further disclosure.

**NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

ERISA Section 103(a)(3)(C) Audit Election

As permitted by ERISA Section 103(a)(3)(C), the Plan’s financial statements are presented in conformity with an audit performed pursuant to this section. Accordingly, investments held and certified by Ascensus Trust Company, a qualified bank and custodian, have not been audited by the Plan’s independent auditor. The auditor’s procedures were limited to information that is not so certified. As further discussed in Note C, Ascensus Trust Company, a qualified institution, has certified all investment information as complete and accurate.

Risks and uncertainties

Investment securities are exposed to various risks, including market interest rate, and credit risk. Further information about investment risks and concentrations is presented in Note F – Risks and Uncertainties.

Cash and Cash Equivalents

Cash and cash equivalents represent monies deposited with the Plan Trustee which, at year end, were unallocated to investment accounts.

Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are charged directly to the borrowing participant's account. As of December 31, 2024, no allowance for credit losses has been recorded. If a participant does not make loan payments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan documents. As of December 31, 2024, notes receivable from participant loans totaled \$28,287. Management believes the notes receivable from participant loans to be fully collectible.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note H for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Investment Management Services

Investment management services, excluding transaction fees and loan fees, are paid for by the plan participants.

Certification dated January 2, 2025, from Ascensus Trust Company covers the period January 1 – December 31, 2024, and year-end balances in accordance with 29 CFR 2520.103-5.

**NOTE D – TAX STATUS**

The Plan, which is a prototype non-standardized profit-sharing plan with a Cash or Deferred Arrangement (CODA), has received a favorable determination letter from the Internal Revenue Service dated June 30, 2020. The Internal Revenue Service has determined and informed the Company that the Plan is designed in accordance with applicable regulations of the Internal Revenue Code (IRC) and is exempt from income taxes. Management believes the Plan remains qualified subsequent to the January 1, 2023 amendment.

The Plan's information return filings are subject to examination by the Internal Revenue Service and the Department of Labor for a period of three years after the date of filing. Returns filed for plan years prior to 2022 are no longer subject to examination.

**NOTE F – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term, and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

Because investments are participant-directed, participants bear the risk of investment losses and may be subject to concentration risk.

Although the Plan's investments are broadly diversified across multiple asset classes and fund managers, concentrations of market risk exist to the extent that participants allocate their account balances to specific funds or asset classes.

**NOTE G – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to reduce or discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their entire account.

**NOTE H – FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

*Level 1 Fair Value Measurements*

The fair value of mutual funds in registered investment accounts is based on quoted net asset values of the shares held by the Plan at year end.

*Level 2 Fair Value Measurements*

The fair value of common/collective trusts and pooled separate accounts consists of a wide variety of investments such as equities, preferred stock, bonds, real estate, and mutual funds.

The net asset value is based on the market value of its underlying investments, but the net asset value is not a publicly quoted price in an active market and can be obtained directly from the applicable asset manager or investment sponsor.

Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE I – RELATED PARTIES**

Ascensus Trust Company manages all funds of the Plan. As a result, Ascensus Trust Company qualifies as a party-in-interest to the Plan with respect to transactions related to these funds. The fair market value of the funds managed by Ascensus Trust Company totaled \$4,169,726 for the year ended December 31, 2024.

Transactions with the plan sponsor and participants qualify as party-in-interest transactions under ERISA §408(b)(2); management believes all such transactions are exempt and reasonable.

Management investment services paid by the Plan amounted to \$5,325 for the year ended December 31, 2024.
