***Scope and Nature of the ERISA Section 103(a)(3)(C) Audits***

We have performed audits of the financial statements of Performant 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

***Basis for Opinion***

### NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

#### NOTE 1: DESCRIPTION OF PLAN

The following description of the Performant 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

##### **General**

The Plan was established June 1, 1985 to provide benefits for the employees of Performant Financial Corporation (the "Plan Sponsor") and the employees' beneficiaries. The Plan is a defined contribution plan covering all employees of the Plan Sponsor who have attained the age of eighteen (18) years and have completed one month of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Fidelity Management Trust Company is the custodian of the Plan's assets and the Plan's trustee.

##### **Plan Year**

The Plan year begins January 1<sup>st</sup> and ends December 31<sup>st</sup>.

##### **Contributions**

The Plan allows the following types of contributions:

- *Employee Salary Deferral 401(k) and Roth Contributions*

The Plan includes an elective salary deferral arrangement pursuant to Section 401(k) of the Internal Revenue Code (the "Code"). Employees are automatically enrolled into the Plan upon eligibility. The automatic enrollment contribution percentage is 2%; however, employees may voluntarily contribute up to 60% of their wages subject to various nondiscrimination tests and limitations prescribed by the Code, and they may choose to opt out of the automatic enrollment. Effective May 1, 2023, the automatic enrollment percentage was increased to 3%. Participants may make after-tax Roth elective salary deferral contributions.

- *Nonelective Employer Contributions*

The Plan Sponsor may make a nonelective contribution on behalf of eligible participants who perform services covered by prevailing wage laws. The Plan Sponsor's contribution is equal to the amount determined to be required under prevailing wage laws to meet the required benefit levels for the Plan year. The Plan Sponsor contributed \$0 for the years ended December 31, 2024 and 2023.

The Plan Sponsor may make an additional nonelective contribution equal to a discretionary amount. Participants must earn at least 501 hours of service during the Plan year and be employed with the Plan Sponsor on the last day of the Plan year to be eligible to receive an allocation of the discretionary nonelective contribution. The Plan Sponsor elected not to make a discretionary nonelective contribution in 2024 and 2023.

- *Employer Matching Contributions*

The Plan Sponsor may make a discretionary matching contribution equal to a percentage of a participant's salary deferral contributions. Participants must earn 501 hours of service during the Plan year and be employed with the Plan Sponsor on the last day of the contribution period to be eligible to receive a matching contribution. Effective July 1, 2024, the Plan was amended to remove the 501 hours of service requirement and to add that participants must complete 12 months of service to be eligible to receive a matching contribution. The Plan Sponsor elected to make a matching contribution of \$257,900 and \$0 for the years ended December 31, 2024 and 2023, respectively.

NOTE 1: **DESCRIPTION OF PLAN (Continued)**

**Contributions (Continued)**

- **Employee Rollover Contributions**

Employees may make rollover contributions from another qualified plan, including Roth rollover contributions.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, employer contributions, rollover contributions, an allocation of plan earnings and losses, and an allocation of certain plan expenses, as defined by the plan document. The yield (interest, dividends, and net realized and unrealized gains and losses) on investments is allocated to each participant's account based on each participant's pro rata share of the total investments in the particular fund. The benefit to which a participant is entitled is limited to the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are 100% vested in all contributions upon entering the Plan.

**Forfeitures**

Forfeitures may be used to pay for Plan expenses or to reduce the amount of Plan Sponsor contributions. The forfeiture balance was \$32,374 and \$81,752 at December 31, 2024 and 2023, respectively, which is comprised of uncashed participant checks returned to the Plan. During the years ended December 31, 2024 and 2023, forfeitures of \$52,975 and \$0 were used to pay for Plan expenses. There were no forfeitures used to reduce the amount of Plan Sponsor contributions in 2024 or 2023.

**Retirement**

Normal retirement under the Plan is age sixty-five (65). Early retirement is permitted after a participant attains age 55 and completes 7 years of service.

**Notes Receivable from Participants**

The Plan allows participants to borrow from their accounts. Loans may not exceed 50% of the vested balance in a participant's account or \$50,000. The loans are secured by the balance in the participant's account and bear interest charged at a commercially reasonable rate as determined by the Plan's administrator. Principal and interest is paid ratably through monthly payroll deductions and loan periods range from one to five years, except for loans made for the purchase of a primary residence, which may permit a longer repayment term.

**Payment of Benefits**

Payment of benefits may be made at the following times under the Plan: 1) normal retirement or early retirement, 2) termination of employment of the participant, 3) financial hardship, 4) death of the participant, 5) in-service upon reaching age 59 ½ and 6) upon termination of the plan. The form of benefit payments may be in a single lump sum or in periodic installments over a period of time.

**Administrative Expenses**

Administrative expenses are paid by the Plan or Plan Sponsor. Administrative expenses paid by the Plan are offset by revenue sharing credits received. Expenses related to specific participant transactions are charged directly to the participant's account.

*NOTE 2:* **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are maintained on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Investment Valuation and Income Recognition**

Investments in securities are stated at fair market value using quoted market prices when available. Cash and cash equivalents are valued at stated carrying values which approximates market value. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded when earned. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Increases and decreases in the unit values of investments are reflected in each participant's self-directed account. Investments are valued daily.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan payments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Payment of Benefits**

Benefits are recorded when paid.

**Excess Contribution Refunds Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to employee contributions. Excess contributions amounting to \$0 and \$15,904 are included in the statements of net assets available for benefits and changes in net assets available for benefits for the years ended December 31, 2024, and 2023, respectively.

**Revenue Sharing**

The Plan participates in a revenue sharing arrangement with Fidelity Management Trust Company, the trustee of the Plan. Under this arrangement, the Plan receives revenue sharing credits that are allocated to participant accounts, based on a systematic allocation method, to offset plan administrative expenses. Accordingly, administrative expenses are reported in the statement of changes in net assets available for benefits net of revenue sharing credits received. Revenue sharing credits received by the Plan in excess of administrative expenses are recorded as other income in the statement of changes in net assets available for benefits. Revenue sharing credits are recognized when received.

**Estimates and Assumptions**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**Income Taxes**

The Plan adopted a non-standardized prototype plan which has obtained a favorable opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan is acceptable under Section 401 of the Code. The Plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Plan management has determined that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

**Reclassifications**

Certain reclassifications have been made to the 2023 financial statements to conform with the 2024 financial statement presentation. The reclassifications had no effect on previously reported net assets available for benefits.

**NOTE 3: INFORMATION CERTIFIED BY THE TRUSTEE**

**NOTE 4: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right to terminate the Plan at any time, subject to the provisions of ERISA. There are no considerations for vesting related to Plan termination as participants are fully vested in all contributions.

**NOTE 5: RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of changes in net assets available for benefits.

**NOTE 6: FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) ASC 820 provides a framework for measuring fair value. That framework provides a three-tier hierarchy that prioritizes the inputs to valuation techniques used for measuring fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are as follows:

Level 1 - Inputs are unadjusted quoted prices for identical assets or liabilities that the Plan has the ability to access.

Level 2 - Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, model-based valuation techniques for which all significant assumptions are observable in the market, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - Inputs that are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money Market Accounts:* Underlying short term investments with quoted prices in active markets to preserve the value of the investment at \$1.00 per share.

*Brokerage Accounts:* Valued at the daily closing price as reported by the underlying investments. Brokerage accounts consist primarily of mutual funds and common stocks.
