INDEPENDENT AUDITOR'S REPORT

To the Trustees of
OPCO CA 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of OPCO CA 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of OPCO CA 401(k) Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan and is open to substantially all employees of OPCO CA Skilled Mgmt, LLC and affiliated entities (the “employers” and collectively, the “Company”). Arrowhead Healthcare, LLC established the Plan effective January 1, 2018. Effective January 1, 2021, the Plan was renamed from Arrowhead Healthcare 401(k) Plan & Trust to OPCO CA 401(k) Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

During 2024, one participating employer ceased participation and twenty-nine new participating employers under common ownership began participating in the Plan, resulting in a total of eighty-two participating employers as of December 31, 2024.

The Plan offers investment options through a group annuity contract (the “Contract”) issued by John Hancock Life Insurance Company (U.S.A.) (“John Hancock”), custodian of the Plan’s assets. Through the Contract, contributions made into the Plan are invested in pooled separate accounts with sub-accounts which invest solely in underlying mutual funds. Amounts allocated to pooled separate accounts are credited to a participant’s account in the form of accumulation units.

Eligibility: To be eligible to participate in the Plan, an employee must be 21 years of age or older and have completed 30 days of service. Employees whose employment is covered by a collective bargaining agreement, certain nonresident aliens who have no earned income from sources within the United States, and highly compensated employees (generally more than 5% owners and certain family members or individuals receiving wages in excess of certain amounts established by law) are not eligible to participate in the Plan. Employees may enter the Plan the first day of the Plan year quarter coinciding with or following the date the eligibility requirements are satisfied.

Contributions: Participants may make voluntary pre-tax contributions or after-tax (Roth) contributions by means of a salary deferral agreement of up to 90% of their compensation, subject to the Internal Revenue Service (IRS) limitations for the Plan year. Plan participants over the age of 50 are also permitted to make additional pre-tax and Roth catch-up contributions (\$7,500 in 2024). The Plan also permits rollover contributions from other qualified pre-tax retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may contribute discretionary matching contributions to participant accounts, which are determined annually. Discretionary employer matching contributions are equal to 50% of the employee's deferral not to exceed 2% of compensation. Participants become eligible for discretionary matching contributions after 1,000 hours of service during the plan year and must be employed on the last day of the Plan year. For the purpose of employer matching contributions, employees begin receiving matching contributions on the day the eligibility requirements are satisfied. Management calculates and remits the discretionary employer matching contribution subsequent to year-end and, as such, these amounts are presented as employer contributions receivable at December 31, 2024 and 2023 in the accompanying statements of net assets available for benefits, if applicable. The Company elected not to make any discretionary matching contributions for 2024 or 2023.

In addition, the Company may contribute discretionary non-elective profit sharing contributions to the Plan. During 2024, no non-elective profit sharing contributions were contributed by the Company.

Investment options: Currently, participants are able to direct their contributions into pooled-separate accounts ("PSAs") maintained by John Hancock. Participants are able to transfer funds among all investment options, subject to certain limitations on the timing of such transfers imposed by the PSA.

Participant accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's discretionary matching and discretionary non-elective profit sharing contributions and (b) Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant's compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in both their voluntary contributions and any discretionary employer contributions plus any related earnings thereon.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms may not exceed five years unless the purpose of the loan is to purchase the participant's primary residence. The loans are secured by the vested balance in the participant's account and bear interest at a rate determined by the plan administrator, currently the prime interest rate at the time of the loan plus 2%. Interest rates range from 5.25% to 10.50%. Principal and interest is paid ratably through weekly payroll deductions.

Payment of benefits: Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account or partial payments. For termination of service due to other reasons, a participant will receive the value of the vested interest in his or her account as a lump-sum distribution. In case of hardship, a participant may apply for a distribution described in the Plan agreement. Lump sum distributions are required if the vested balance is \$7,000 or less. Additionally, in-service distributions are permitted for participants meeting certain age and length of service requirements.

Administrative expenses: Expenses for the Plan's investment managers, administrators, attorneys, and auditors are paid by the Plan or the Company at the Company's discretion.

Forfeited accounts: Forfeited nonvested accounts are to be used to reduce future employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$56,047 and \$250, respectively. No forfeited nonvested accounts were used during the year ended December 31, 2024.

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES

Basis of presentation: The financial statements are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain amounts reported in the financial statements and accompanying notes. Accordingly, actual results could differ from those estimates.

Notes receivable from participants: Participant loans are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. When a loan defaults, the deemed distribution is a distribution for tax reporting purposes only for the participant, however, the loan is still an asset of the plan and continues to accrue interest in accordance with the Department of Labor (DOL) and IRS regulations as the participant still has the option to pay off the loan at any time. Deemed distributions of participant notes receivable with no post-default payment activity are disregarded for Form 5500 reporting.

Investment valuation and income recognition: Investments are reported at fair value using methodologies described in Note 3. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments, including gains and losses, are recorded on a trade-date basis. Interest income is recorded when earned, dividends are recorded on the ex-dividend date and capital gain distributions are included in dividend income. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefit payments: Benefit payments to participants are recorded when paid.

Subsequent events: In preparing these financial statements, Plan management has evaluated events and transactions for potential recognition or disclosure through October 14, 2025, the date the financial statements were available to be issued. See Note 10 for a description of certain events occurring in 2025 that have a significant effect on the Plan.

NOTE 3 – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued at the net asset value (“NAV”) of the underlying investments held by each account, minus its liabilities, and then divided by the number of units outstanding. The NAV, as reported to the Plan, is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV. The pooled separate accounts offer a variety of different investment strategies, including asset preservation, income generation, growth, target date asset accumulation and sector specialization. Purchases and sales may occur daily within these accounts and the redemption period is immediate. As of December 31, 2024 and 2023, there were no unfunded commitments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 – INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN

John Hancock, the custodian, holds the Plan's investments and executes investment transactions.

NOTE 5 – RISKS AND UNCERTAINTIES

The participants direct the Plan to invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in all employer contributions.

NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS

Plan investments as of December 31, 2024 and 2023 were units of participation in pooled separate accounts that were managed by affiliates of John Hancock, the Plan’s custodian. Therefore, these transactions qualify as party-in-interest transactions.

Additionally, two officers of the Company are the trustees of the Plan, as defined in the plan agreement. Neither officer participates in the Plan.

The Plan issues notes receivable to participants, which are secured by the balances in participants’ accounts. When initiated, these transactions qualify as party-in-interest transactions.

NOTE 8 – INCOME TAX STATUS

The Plan adopted a non-standardized pre-approved plan document on which the IRS has issued an opinion letter dated June 30, 2020, that stated that the non-standardized pre-approved plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since issuance of the most recent opinion letter. Although the Plan has not requested an individual determination letter from the IRS, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date and no provision for income taxes has been included in the Plan’s financial statements.

NOTE 9 – PROHIBITED TRANSACTIONS

During 2022, the Company failed to remit certain participant contributions to the Plan on a timely basis, as defined by the Department of Labor’s Rules and Regulations under ERISA. Such contributions totaled \$34,582 for the year ended December 31, 2022, and are included in the Schedule of Delinquent Participant Contributions. The contributions were remitted to the Plan during 2022. Lost earnings related to the late remittances were calculated and credited to participant accounts in March 2024.

During 2024, the Company failed to remit certain participant contributions to the trustee on a timely basis, as defined by the Department of Labor’s Rules and Regulations under ERISA. Such contributions totaled \$93,041 for the year ended December 31, 2024 and are included in the Schedule of Delinquent Participant Contributions. Late remittances from 2024 were remitted to the Plan in July of 2024. Lost earnings related to the 2024 late remittance was calculated and remitted in September 2024.

NOTE 10 – SUBSEQUENT EVENTS

Effective May 1, 2025, two new participating employers under common ownership began participating in the Plan. Effective August 1, 2025, one new participating employer under common ownership began participating in the Plan. Effective September 1, 2025, three new participating employers under common ownership began participating in the Plan.
