Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

1. Description of the Plan

The following description of the Worldwide Restaurant Concepts 401(k) Savings Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan’s agreement for a more complete description of the Plan’s provisions.

General

During 2021, the Plan was amended to substitute Sizzler USA Restaurants, Inc. as the Plan Sponsor, as World Wide Restaurant Concepts was dissolved. There were no changes to the operations of the Plan or the participants of the Plan.

The Plan was established on January 1, 1992 as a defined contribution plan. The Plan covers all employees of Sizzler USA Restaurants, Inc. and its affiliates (the “Company”) who have completed at least three months of service and are eighteen years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Reliance Trust has been contracted to serve as record-keeper and Trustee of the Plan.

Participant Contributions

Participants may contribute up to fifty percent of their pre-tax annual compensation, as described in the Plan, subject to the annual federal tax limitation established by the Internal Revenue Service (IRS). In addition, employees who are age 50 or older may elect to defer additional amounts (called “catch-up contributions”) to the plan up to the maximum allowed by the IRS. Participants may also contribute amounts representing distributions from other qualified retirement plans. The Company may, at its discretion, make discretionary, non-elective contributions to the Plan. The Company made no discretionary contributions during the years ended December 31, 2024 and 2023.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Forfeited nonvested account balances may be used to reduce future employer contributions or pay any administrative Plan expenses. There were forfeited balances of \$230,106 and \$310,606 as of December 31, 2024 or 2023, respectively.

Vesting

Participants are immediately vested in their elective contributions (including Roth elective deferrals) and rollover contributions plus actual earnings thereon. Vesting in the employer non-elective contribution portion of their account plus actual earnings thereon is based on years of continuous service as follows: 100% vested after five years of service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum equal to the lower of 50% of their vested account balance, not to exceed or \$50,000. The notes are secured by the balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Interest rates ranged from 4.25% to 10.00% at December 31, 2024. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

Participants are eligible to receive the vested portion of benefits upon termination of employment, death, disability, retirement or Plan termination. If a participant's balance does not exceed \$5,000, the vested benefit will be distributed as a single lump-sum payment. If a participant's balance exceeds \$5,000, the vested benefit may be distributed as a single lump-sum payment, installments over a period of not more than the participant's assumed life expectancy, or as partial withdrawals. Distributions may also be made for hardship withdrawals, which are authorized by the Plan administrator and conform to the "deemed hardship" standards set forth in Treasury Regulation Section 1.401(k)(d)(2). Such hardship distributions are subject to certain limitations.

Investment Options

Reliance Trust Company as Trustee under a trust agreement held the assets of the Plan during the year, including all contributions and earnings thereon. Upon enrollment in the Plan, participants may direct contributions in any of the investment options made available by the Trustee.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The Plan sponsor uses estimates and assumptions in preparing the Plan's financial statements in accordance with accounting principles generally accepted in the United States of America. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and the reported changes in net assets. Actual results could vary from the estimates that were used.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document. Interest income on notes receivable is recorded when earned.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received when selling an asset or paid to transfer a liability in transaction between market participants at the measurement date. Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits if a defined-contribution plan attributable to fully benefit-responsive investment contracts because the contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan offers the Invesco Stable Asset Fund, a fully benefit responsive fund (see Note 5).

Valuation of Investments and Income Recognition

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis of accounting. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year net of investment expenses.

Risks and Uncertainties

Investments are exposed to various risks, such as interest rate, market fluctuation and credit. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term could materially affect participant account balances, the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Plan Expenses

The Company sponsors the Plan. Personnel within the Company perform various administrative services for the Plan. The payroll and related overhead costs associated with these services are not included as Plan expenses. Most administrative expenses of the Plan, including consulting, legal, and audit fees, are paid by the Company and not reflected in these financial statements. Other recordkeeping services are paid for by the Plan and totaled \$17,043 for the year ended December 31, 2024. Investment expenses are recorded net of appreciation/depreciation investments.

Payment of Benefits

Benefits payments are recorded when paid.

3. Income Tax Status

The IRS has determined and informed the Plan by letter dated October 6, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the Plan administrator believes that the Plan is still currently designed and being operated in compliance with the applicable requirements of the IRC. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its exempt status and had not taken uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. Information Certified by the Trustee

The Plan Sponsor elected the method of compliance presented by 29 CFR 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Under this provision of ERISA, certain information certified need not be subject to independent audit.

All investment information disclosed in the accompanying financial statements, including investments held at December 31, 2024 and 2023, as well as in the supplemental schedule as of December 31, 2024, and the net realized and unrealized appreciation in fair value of mutual funds and common/collective trust, and dividend income for the year ended December 31, 2024, was obtained or derived from information provided to the Plan administrator and certified as complete and accurate by the Plan's trustee.

5. Fair Value Measurements

Fair value is defined as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance.

The Plan maximizes the use of observable inputs and minimizes the use of unobservable inputs when measuring fair value. A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the following fair value measurement.

- Level 1: quoted prices in active markets for identical assets or liabilities;
- Level 2: inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or
- Level 3: observable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The assets or liabilities fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies (Mutual funds): Valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are deemed to be actively traded.

5. Fair Value Measurement (Continued)

The following is a description of the valuation methodologies used in 2024 and 2023 for assets measured at Net Asset Value as the practical expedient to estimate fair value:

Common/collective trusts (CCT): valued at NAV which is based on the fair value of the underlying investments of the CCT, less any liabilities. The CCT invests in guaranteed investment contracts and similar contracts issued by insurance companies, banks, and other financial institutions. Also, the CCT invests in security-backed investment contracts and short-term investments. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) and redemption notices may occur daily. The CCT has no unfunded commitments. Investments measured at fair value based on the NAV per share as a practical expedient were \$2,818,464 and \$3,147,855 as of December 31, 2024 and 2023, respectively.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in methodologies used at December 31, 2024 and 2023. There were no transfers between Levels 1, 2 and 3 for the year ended December 31, 2024.

6. Party-in-Interest Transactions

Certain Plan investments are mutual funds and common collective trusts managed by Reliance Trust. Reliance Trust is the trustee of the Plan and, therefore, these transactions qualify as party-in interest transactions as defined by ERISA. Any transactions involving these investments are on the open market at fair value or contract value, as outlined in Note 2. Consequently, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in interest transactions under ERISA.

7. Plan Termination

Although it has not expressed any intent to do so, the Plan sponsor has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their account balance.

8. Subsequent Events

The Plan has evaluated subsequent events from the date of the Statements of Net Assets Available for Benefits through October 13, 2025, the date the financial statements were available to be issued. During this period, no material recognizable subsequent events were identified.
