Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of the 403(b) Thrift Plan of Community Drug Board, Inc. (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements ("2024 financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the 2024 Financial Statement section:

- The amounts and disclosures in the accompanying 2024 financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Basis for Opinion on the 2024 Financial Statements

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

Note 1. Description of Plan

The following brief description of the 403(b) Thrift Plan of Community Drug Board, Inc. (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Community Drug Board, Community Drug Board Foundation, Community Health Center Foundation, and Ohio Multi-County Development Corporation (the "Sponsor"). Employees are eligible to participate in the Plan on their hire dates. In order to be eligible for employer contributions, participants must have reached the age of 18 and completed one year of service as defined by the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Contributions

Participants may make pre-tax contributions in any percentage of their compensation as defined by the Plan up to the maximum amount set by the law. Employees who become eligible to participate but do not enroll or opt out of the Plan are automatically enrolled to defer 3% of compensation as defined by the Plan on a pre-tax basis. The Plan allows for catch-up contributions for participants who attain the age of 50 before year end and for participants who have worked a minimum of 15 years for the Sponsor. The Sponsor may make discretionary matching and non-elective contributions. The Plan provides for the acceptance of rollover contributions from other plans qualified under the Internal Revenue Code (the "Code").

Participant Accounts

Each participant's account is credited with his or her elective deferrals, the Sponsor's discretionary matching contributions, and an allocation of the Sponsor's discretionary non-elective contributions, if any, and Plan earnings, and is charged with an allocation of administrative expenses. Upon enrollment in the Plan, participants may direct contributions among investment choices and may change their investment options on any normal business day. Allocations by the Plan are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Each participant has a 100% non-forfeitable vested interest in his or her elective deferral contributions. Vesting in the participants' shares of the Sponsor's matching and non-elective contributions is based upon years of continuous service according to a six-year graduated scale. Participants will be 20% vested after two years of service and will vest an additional 20% for each year thereafter. A participant is 100% vested after six years of credited service or in the event of death, disability, or retirement.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

Note 1. Description of Plan (Continued)

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. Notes receivable terms range from 1-5 years, or longer for the purchase of a primary residence. Notes receivable are secured by the balances in the participants' accounts. Principal and interest are paid ratably through bi-weekly payroll deductions. All expenses associated with the establishment and administration of the loan will be paid by or charged to the participants' accounts. Repayments of principal and interest are credited to the participants' separate accounts within the funds as elected by the participants. Until such repayments are received, the notes receivable are accounted for in the participant loan fund.

Payment of Benefits

Benefits will be paid from the Plan in a lump-sum or installments upon the occurrence of any of the following events:

Retirement – A participant, upon retirement from employment with the Sponsor at either normal retirement date (age 65) or at any time thereafter, shall be entitled to receive the entire balance in his or her account.

Disability – In the event a participant becomes totally disabled, the participant shall be entitled to receive the entire balance in his or her account.

Death – Upon death of a participant, the beneficiary of the participant shall be entitled to receive the entire balance in his or her account remaining at death.

In-Service Withdrawals – Upon attaining the age of 59½, a participant may take in-service withdrawals.

Termination of Employment – Upon termination of employment with the Sponsor for any reason other than death, retirement, or total disability, a participant shall be entitled to the vested balance in his or her account. If the value of vested benefits credited to a participant's account is \$5,000 or less at the time of termination, the entire amount will automatically be distributed to the participant without the participant's consent in the form of a direct rollover to an individual retirement account as designated by the plan administrator.

Hardship – A participant shall be entitled to a hardship withdrawal of the participant's share of salary deferrals and rollover contributions after maximum participant loans have been withdrawn.

Forfeitures

The Sponsor has the option to use forfeited employer contributions to reduce future employer contributions, pay Plan expenses, or allocate to participants in the same manner as employer non-elective contributions. During 2024, \$52,138 of forfeitures was used to reduce employer contributions to the Plan. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$-0-.

Note 1. Description of Plan (Continued)

Termination Provisions

The Sponsor anticipates and believes that the Plan will continue indefinitely; however, the Sponsor reserves the right to terminate the Plan at any time by an action of its Board of Directors. In the event of termination of the Plan, all amounts credited to the participant accounts will become 100% vested in their non-elective contributions and the assets then remaining in the fund will be allocated and distributed to participants in accordance with the terms of the Plan.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts, which are valued at contract value) (see Note 4). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodians. The change in the difference between fair value and the cost of investments and gain or loss on the sale of investments is reflected in the statements of changes in net assets available for benefits as net appreciation in fair value of investments. The cost of investments sold is based on the average cost of the investments. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded at December 31, 2024 or 2023. If a participant ceases to make repayments and the plan administrator deems the note receivable to be in default, the balance on the note receivable is reclassified to benefits paid to participants in accordance with Plan provisions.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

Note 2. Summary of Significant Accounting Policies (Continued)

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Evaluation of Subsequent Events

The Plan has evaluated subsequent events through October 15, 2025, the date on which the financial statements were available to be issued.

Note 3. Unaudited Information

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, management received a certification from Principal Trust Company ("Principal"), the Trustee of the Plan, acknowledging the completeness and accuracy of all investments and notes receivable reflected in the accompanying statement of net assets available for benefits from June 1, 2024 through December 31, 2024, the related investment and loan interest activity reflected in the statement of changes in net assets available for benefits for the year then ended, the supplemental schedule as of December 31, 2024, and investment related information in the accompanying notes to the financial statements. Mutual of America Life Insurance Company and Lincoln National Life Insurance Company have certified to the completeness and accuracy of all investments reflected in the statements of net assets available for benefits at December 31, 2024 and 2023, the related investment activity reflected in the statements of changes in net assets available for benefits for the years then ended, and the investment related information in the accompanying notes to the financial statements. This information is unaudited by independent accountants.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;

- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

From June 1, 2024 through December 31, 2024, registered investment companies are Principal funds (Mutual of America funds from January 1, 2024 through May 31, 2024) which are based on market quotations or prices from independent pricing services and are classified as Level 1.

The methods above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. There have been no changes in the methodologies used from 2023 to 2024. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Guaranteed Investment Contract With Insurance Company

The Plan holds an investment contract which meets the fully benefit-responsive criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

Note 5. Guaranteed Investment Contract With Insurance Company (Continued)

The investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed by the Plan. The crediting interest rate, which may not be less than 0%, is based on a formula agreed upon with the issuer. Such interest rates are reviewed at least annually for resetting. The contract cannot be terminated before the scheduled maturity date. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events may limit the Plan's ability to transact at contract value with Principal at December 31, 2024 and 2023. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with Plan participants, is probable.

Note 6. Income Tax Status

The Internal Revenue Service ("IRS") has determined and informed the Sponsor by a letter dated March 31, 2017, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for Plan participants under Section 403(b). GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has determined that the Plan does not have any uncertain tax positions and the associated unrecognized benefits that materially impact the financial statements or related disclosures. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8. Party-in-Interest Transactions

Certain Plan investments are managed by Principal, the Custodian, or its affiliates. Principal and Mutual of America also receive administrative expenses from the Plan. Therefore, these transactions qualify as party-in-interest transactions.
