### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of the Anchorage Capital Advisors, L.P. 401(k) Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **Note 1. Plan Description**

The following description of Anchorage Capital Advisors, L.P. 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan, established on January 1, 2003, restated on January 1, 2024, is a defined contribution plan covering eligible employees of Anchorage Capital Advisors, L.P. (Company). Full-time, non-excluded employees, who have attained the age of 18 with one day of service, are eligible to participate in the Plan. Effective with the Plan restatement, union employees, and interns are excluded from participating in the Plan. An employee's entry date into the Plan is the first day the employee satisfies the eligibility requirements coinciding with or following the date of eligibility. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended.

**Contributions**

**Participant Salary Deferral**

Participants in the Plan may contribute a discretionary amount up to 90% of their annual compensation and bonus provided that the participant's contribution does not exceed the maximum dollar amount determined by the Internal Revenue Service (IRS) each calendar year, which is \$23,000 for the calendar year ended December 31, 2024. Employees over the age of 50 can elect to contribute an additional \$7,500 for the calendar year ended December 31, 2024. Effective January 1, 2021, the Company has amended the Plan to allow Roth elective deferrals.

**Employer Discretionary Matching Contributions**

Participants may be eligible to receive a discretionary matching contribution based on a discretionary percentage of a participant's elective deferrals. The matching contribution is made on an annual basis for all participants regardless of service completed during the Plan year or employment status at the end of the Plan year. During the year ended December 31, 2024, the Company did not make a matching contribution.

**Employer Discretionary Profit Sharing Contributions**

The Company may make discretionary profit-sharing contributions to participants. The discretionary profit-sharing contribution is made on an annual basis (as of the last day of the Plan year) for all participants who are employed at the end of the Plan year or who have completed more than 500 hours of service. There were no discretionary profit-sharing contributions for the year ended December 31, 2024.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Participants vest in the Company's discretionary matching and profit-sharing contributions plus actual earnings thereon based on the following schedule:

***Participant Accounts***

Individual participant accounts are credited with applicable participant contributions, an allocation of the Company's contributions, and investment earnings or losses, and are charged with an allocation of administrative expenses. Allocations are based upon participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled to is equal to the vested portion of the participant's account.

***Forfeitures***

A participant who terminates employment and is less than 100% vested, forfeits the non-vested portion of their account. Forfeitures attributable to employer matching and profit-sharing contributions are first used to pay any administrative expenses and then may be used to offset any discretionary employer contributions. There were no forfeitures for the year ended December 31, 2024. The unallocated forfeiture balance amounted to zero at both the years ended December 31, 2024 and 2023.

***Investment Options***

Participants may make direct contributions to any of the investment options offered by the Plan. Participants may change their investment options on a daily basis.

***Distributions***

Distributions from the Plan are permitted under the following circumstances: (i) attainment of age 59½, (ii) termination of employment, (iii) death or permanent disability, and (iv) a proven hardship. Distributions from a participant's account are made in the form of a lump-sum payment or installments over a period of not more than the participant's assumed life expectancy (or the assumed life expectancy of a beneficiary).

***Notes Receivable from Participants***

In general, the Plan administrator may permit participants to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. A participant may have only one loan outstanding at any time.

Loans are secured by the balance in the participant's account and bear interest at an interest rate determined by the Plan administrator based on the prime rate plus 1% (rates were 9.5% in 2024). Loans shall be repaid over a period of up to five years unless the loan is for the purchase of a primary residence, which then the Plan administrator will offer extended repayment options. Principal and interest are repaid through payroll deductions. At December 31, 2024 and 2023, participant loans were \$24,366 and \$19,869, respectively.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements have been prepared using the accrual basis of accounting.

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Dividends are recorded on the ex-dividend date. Interest is included in income when earned, based on the terms of the investments and the periods during which the investments are owned. Purchases and sales of securities are recorded on a trade-date basis.

The Plan presents, in the statement of changes in net assets available for benefits, the net change in the fair value of its investments which consists of realized gains or losses, and unrealized appreciation or depreciation on investments.

Net appreciation includes the plan's gains and losses on investments brought and sold as well as held during the year. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred.

***Notes Receivable From Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

***Benefit Payments***

Benefits are recorded when paid.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Administrative Expenses***

All transaction fees are paid from participants' accounts. If forfeitures are available to use, administrative expenses are paid by the Plan through the forfeiture funds, otherwise they are paid by the Plan or the Company. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments in the statement of changes in net assets available for benefits.

**Note 3. Information Certified by the Plan's Custodian**

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, the custodian of the Plan, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

#### **Note 4. Fair Value Measurements**

Financial Accounting Standards Board Accounting Standards Codification (ASC) No. 820, *Fair Value Measurements and Disclosures* (ASC 820), provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access
  
- Level 2** Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability
  
- Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

- Mutual funds: Mutual funds are stated at fair value based on unadjusted prices in an active market for each share held by the Plan.
- Common collective trust funds: Common collective trust funds are stated at fair value which is determined by the trustee of the common collective trust based on the underlying assets, which represent net asset value (NAV) of units held by the trust. The common collective trust invests primarily in mutual funds. The common collective trusts do not have any unfunded commitments relating to its investments, or any significant restrictions or redemptions. Participant-directed redemptions can be made on any business day and do not have a redemption period notice.
- Stable value collective trust fund: Composed primarily of fully-benefit responsive investment contracts and is valued at the NAV units of the bank collective trust. The net asset value is used as a practical expedient to estimate the fair value.
- The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. There are no participant redemption restrictions for these investments and the redemption notice period of 12 months is applicable only at the Plan level.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5. Parties-in-Interest**

The Company administers the Plan from its office. Plan investments are managed by Reliance Trust Company. Reliance Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. ADP is the administrative service provider of the Plan. Fees paid by the Plan for the administration of participant notes amounted to \$4,261 for the year ended December 31, 2024, and are included in administrative expenses on the statement of changes in net assets available for benefits.

**Note 6. Tax Status**

The Plan is a Non-Standardized Pre-Approved profit-sharing plan sponsored by Automatic Data Processing, Inc. (ADP). ADP has obtained an opinion letter on the Plan dated October 6, 2020, stating that the form of the Plan is acceptable under Section 401 of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by taxing authorities.

The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes that it is no longer subject to income tax examinations for years prior to 2021.

**Note 7. Risk and Uncertainties**

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities may occur in the near term and those changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 8. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue and to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, participants will become fully vested in their accounts.
