### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Mercury Technologies, Inc 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. ### Notes to Financial Statements

#### 1. Description of Plan:

The following description of Mercury Technologies, Inc 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering all eligible employees of Mercury Technologies, Inc. (the "Company"). Employees become eligible to participate after attaining the age of 18. Employees are eligible for entry to the Plan on the first day of the pay period after or coinciding with the date the employee satisfies the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Contributions:** The Plan provides for participants to contribute a portion of their compensation on a pre-tax basis, through Roth contributions, or as after-tax contributions, in accordance with the terms defined in the Plan. Participants of qualifying age may make additional "catch-up" contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company makes safe harbor matching contributions equal to 100% of the participant's elective contribution up to 4% of the participant's eligible compensation. The Plan also allows for discretionary contributions as elected by the Company. There were no discretionary contributions for 2024 and 2023. Contributions are subject to certain limitations.

**Participant Accounts:** Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment Options:** Participants may direct the custodian as to the investment of their account balances in accordance with guidelines established by the Plan. Participants may change their investment elections at any time.

**Vesting:** Participants are immediately vested in their contributions, the Company's safe harbor contributions, and any discretionary contributions plus actual earnings thereon.

**Notes Receivable from Participants:** Participants may borrow from their Plan accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms cannot exceed five years, unless the proceeds are used to acquire a principal residence. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by the plan administrator.

### Notes to Financial Statements, Continued

#### 1. Description of Plan, Continued:

**Notes Receivable from Participants, Continued:** Principal and interest are paid ratably through payroll deductions. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants, deemed to be in default by the plan administrator, are reclassified as distributions based upon the terms of the plan document.

**Plan Administration:** Overall responsibility for administering the Plan rests with the Company. Through September 26, 2023, Benefit Trust Company, the former custodian, held all assets of the Plan and Guideline, Inc. ("Guideline"), the former recordkeeper and third-party administrator of the Plan, administered participant accounts. Effective September 27, 2023, all assets of the Plan are held by, Fidelity Management Trust Company, LLC, the custodian, and participant accounts are administered by its affiliate, Fidelity Workplace Services, LLC, the recordkeeper and third-party administrator (collectively, "Fidelity").

**Payment of Benefits:** Distribution of the vested portion of a participant's account will occur upon the participant's termination of service, retirement, death, or disability, as defined in the Plan. In-service withdrawals of a participant's vested balance are permitted at age 59 ½ or upon hardship. A participant is entitled to receive a lump-sum payment in an amount equal to the value of their account.

#### 2. Summary of Significant Accounting Policies:

**Basis of Accounting:** The financial statements of the Plan are prepared on the accrual method of accounting.

**Investment Valuation and Income Recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits:** Benefits are recorded when paid.

### Notes to Financial Statements, Continued

#### 2. Summary of Significant Accounting Policies, Continued:

**Use of Estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

**Subsequent Events:** Management has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued and has determined that there are no subsequent events, other than the matter described in Note 12, to be reported in the accompanying financial statements.

#### 3. Fair Value Measurements:

The Financial Accounting Standards Board (“FASB”) has issued guidance for measurement and disclosure of fair value and established a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology are quoted prices for similar instruments in active and inactive markets; and model driven valuations with significant inputs and drivers derived from observable active markets. There were no Level 2 assets in the Plan at December 31, 2024 and 2023.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement. There were no Level 3 assets in the Plan at December 31, 2024 and 2023.

Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for investments carried or disclosed at fair value:

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Money market fund:** Valued at the cash balance which approximates fair value.

#### 3. Fair Value Measurements, Continued:

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 4. Administrative Expenses:

Although not required by the Plan, a portion of the costs of the Plan administration was absorbed by the Company. The Plan paid administration fees in the amount of \$24,690 during 2024 and \$10,121 during 2023.

#### 5. Related Party Transactions:

Certain Plan investments consist of shares of mutual funds managed by Fidelity, the custodian of the Plan. These are related party transactions and are identified as parties-in-interest in the accompanying schedule of assets (held at end of year). Administration fees disclosed in Note 4 were paid to parties-in-interest.

#### 6. **Plan Termination:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

#### 7. **Tax Status:**

The Internal Revenue Service has determined and informed the prototype plan sponsor by letter dated June 30, 2020 that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter; however, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Management has evaluated the effects of accounting guidance related to uncertain income tax positions and concluded that the Plan had no significant financial statement exposure to uncertain income tax positions at December 31, 2024 and 2023. The Plan is not currently under audit by any tax jurisdiction.

#### 8. **Risks and Uncertainties:**

The Plan provides for investments in various securities. Investments are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the financial statements.

#### 9. **Financial Information Certified by the Qualified Institutions:**

Benefit Trust Company, the custodian of the Plan from January 1, 2023 through September 26, 2023, has certified that the following information is complete and accurate:

- Investment income, including net appreciation in value of investments January 1, 2023 to September 26, 2023.
- Interest income on notes receivable from participants January 1, 2023 to September 26, 2023.

#### 11. Prohibited Transactions:

During the plan year ended December 31, 2024, the Company failed to remit an aggregate of \$460 of participant contributions timely. Principal portion of these late contributions have been remitted to the plan, however, all late contributions remain uncorrected with respect to lost earnings as of December 31, 2024, as reflected in the schedule of delinquent participant contributions. The Company is assessing the appropriate payments of any lost earnings related to these events.

#### 12. Corrective Contributions:

In 2025, the Company identified that certain employee deferral elections were not implemented as intended during the 2024 Plan year and that certain wage payments were improperly excluded from eligible compensation used to calculate contributions for 2024 and certain prior Plan years. The Company is determining corrective contributions and related lost earnings to be remitted to the Plan during the 2025 Plan year. Management has evaluated the estimated amounts and determined they are not material to the financial statements as of December 31, 2024; therefore, no receivable has been recorded in the accompanying statements of net assets available for benefits.
